## SECTION ONE. AUTHORITY

The Naabik'íyáti' Committee of the Navajo Nation Council is a standing committee of the Navajo Nation Council empowered to coordinate all state programs with other standing committees and branches of the Navajo Nation government. 2 N.N.C. § 700 (A) and 701 (A)(4).

## SECTION TWO. FINDINGS

A. The Naabik'íyáti' Committee of the Navajo Nation Council established the State Task Force as a sub-committee through the approval of Resolution NABIMY-32-15. See Exhibit A.
B. The Naabik'íyáti' Committee subsequently approved Resolution NABIMY-42-17 amending Resolution NABIMY-32-15 to provide for six members; two from each state
(Arizona, New Mexico and Utah) and establish regular quarterly meetings. See Exhibit B.
C. The Naabik'íyáti' Committee State Task Force Sub-committee is charged with conducting regular interaction with Navajo Nation lobbyists, state legislatures, officials, employees and agencies to enhance the understanding between the Navajo Nation Council and the respective states of Arizona, New Mexico and Utah. See Exhibit B. D. The Speaker of the Navajo Nation Council appoints the delegates to serve on the State Task Force. See Exhibit A.

## SECTION THREE. APPOINTMENT

The Speaker of the $24^{\text {th }}$ Navajo Nation Council hereby appoints the following Delegates to the Naabik'íyáti' Committee State Task Force Sub-committee:

## BE IT ENACTED:

## Section One. Findings

A. The Navajo Nation Council established the Naabik'iyáti' as a Navajo Nation standing committee and empowered the committee to "[t]o coordinate all...state programs with other standing committees and branches of the Navajo Nation government to provide the most effective delivery of services to the Navajo Nation. 2 N.N.C. §§ $700(A)$ and $701(\mathrm{~A})(4)$ (2012) see also CJA-03-13.
B. Naabik'iyáti' Committee may establish the State Task Force sub-committee. 2 N.N.C. § 186 (2012) see also CO-45-12.
C. The Navajo Nation Council gave Naabik'1yati' Committee the authority to delegate its authority as appropriate for efficiency and streamlining of government process to appropriate entities. 2 N.N.C. § $701(B)$ (2012) see also CJA-03-13.

Section Two. Naabik'íyáti' State Task Force Sub-committee Establishment
A. The Navajo Nation establishes the Naabik'iyati' State Task Force sub-committee to advance the position and priorities of the Navajo Nation within the States of Arizona, New Mexico and Utah. The Naabik'iyati' State Task Force Subcommittee shall:

1. Conduct regular interaction with the Navajo Nation lobbyist(s), state legislatures, officials, employees, and agents, to enhance the understanding between the Navajo Nation Council and the respective states; and
2. Report monthly to the Navajo Nation Council Speaker the Task Force's activities; and
3. Transfer information and recommendations to the Navajo Nation Council Speaker, the Naabik'íyáti' Committee, appropriate Navajo Nation Council standing committees, and appropriate Legislative Branch boards, commissions, agencies, offices and programs.
B. The Naabik'íyáti' State Task Force Sub-committee shall consist of nine members; three from each state (Arizona, New Mexico and Utah). The Navajo Nation Council Speaker shall appoint the delegates to serve on the sub-committee. The Navajo Nation Council Speaker appoints the following to the sub-committee, EXHIBIT A:

5. Jonathan Hale, Arizona
6. Walter Phelps, Arizona
7. Mel R. Begay, New Mexico
8. Seth Damon, New Mexico
9. Tom Chee, New Mexico

12. Tsah bii Kin, Navajo Mountain, Shonto, Oljato Delegate, Utah
C. The Naabik'iyáti' State Task Force Sub-committee by majority vote shall select a chairperson and vicechairperson at their first meeting. The chairperson and vice-chairperson shall serve at the Sub-committee's pleasure; replacement shall be by majority vote.
D. The Naabik'iyati' State Task Force Sub-committee shall establish a regular meeting day(s) of the month and shall meet more frequently during a state legislative session.
E. The Naabik'iyáti' State Task Force Sub-committee shall present a written report to the Naabik'iyáti' Committee after each state's legislative session.

## Section Three. Sub-committee Term

The Naabik'íyáti' State Task Force Sub-committee shall exist until their assigned tasks are completed and shall report on the recommendations to the Naabik'iyáti' Committee. 2 N.N.C. § 186 (2012) see also CJA-03-13.

## Section Four. Directives

A. The Speaker's Chief of Staff shall assign one policy analyst to assist the Naabik'Iyati' State Task Force Subcommittee.
B. The Legislative Services' Executive Director shall assign two office of Legislative Services staffers to assist the Naabik' Iyati' State Task Force Sub-committee.
C. The Speaker shall determine a Sub-committee budget and identify the funds.

## SECTION ONE. AUTHORITY

A. The Navajo Nation Council established the Naabik'Iyáti' Committee as a Navajo Nation standing committee and empowered the committee to "[t]o coordinate all . . state programs with other standing committees and branches of the Navajo Nation government to provide the most effective delivery of services to the Navajo Nation. 2 N.N.C. §§ 700 (A) and 701 (A) (4) (2012).
B. Naabik'iyati' Committee may establish the state Task Force SubCommittee. 2 N.N.C. § 186 (2012).
C. The Navajo Nation Council gave Naabik'iyáti' Committee the authority to delegate its authority as appropriate for efficiency and streamlining of government process to appropriate entities. 2 N.N.C. § 701 (B) (2012).

SECTION TWO. FINDINGS
A. Resolution NABIMY-32-15, established the state Task Force as a Naabik'Iyáti' Sub-Committee, pursuant to 2 N.N.C. § 701 (B) (2012). Resolution NABIMY-32-15 is attached as Exhibit A.
B. The Navajo Nation established the Naabik'iyáti' State Task Force Sub-Committee to advance the position and priorities of the Navajo Nation within the States of Arizona, New Mexico and Utah.
C. The State Task Force is delegated the authority to:

1. Conduct regular interaction with the Navajo Nation lobbyist(s), state legislatures, officials, employees, and agencies, to enhance the understanding between the Navajo Nation Council and the respective states; and
2. Report monthly to the Navajo Nation Council Speaker the Task Force's activities; and
3. Transfer information and recommendations to the Navajo Nation Council Speaker, the Naabik'iyati' Committee, appropriate Navajo Nation standing committees, and appropriate Legislative Branch boards, commissions, agencies, offices and programs.
D. Currently, the State Task Force consists of nine members, three from each state (Arizona, New Mexico and Utah) and regularly meets each month.
E. The amendment to Resolution NABIMY-32-15 changes the membership of the State Task Force from nine members to six members, resulting in two members from each state (Arizona, New Mexico and Utah); and amending the meetings of the state Task force from monthly to quarterly to coincide with the Navajo Nation Council Session.

SECTION THREE. AMENDMENT TO NABIMY-32-15
The Navajo Nation hereby amends NABIMY-32-15 as follows:

Section Two. Naabik'iyáti' State Task Force Sub-Committee Establishment
B. The Naabik'Iyati' State Task Force Sub-Committee shall consist of nine six members; thzee two from each state (Arizona, New Mexico and Utah). The Navajo Nation Council Speaker shall appoint the delegates to serve on the sub-committee. The Navajo Nation Council Speaker appoints the following to the sub-committee, EXHIBIT A:

1. Kee-Allen Begay, Jx., Axizona
2. Jonathan Hale, Axizena-Dwight Witherspoon, Arizona
3. Walter Phelps, Arizona
4. Mel R. Begay Petexgon Yazzie, Steven Begay, New Mexico

7. Davis Filfred, Utah
8. Nathaniel Brown, Utah
9. Toah bii-Kin, Navajo Mountain, Shonto, Oljato, Delegate Hexman Daniela, Utah

D. The Naabik' iyati' State Task Force Sub-Committee shall establish a regular quarterly meeting day(s) of the month shall meet more frequently during a state legislative session. A quorum shall eonsigt of one (I) repregentative from each of the three regpeetive gtates (Axisona, New Mexieo and Utah), in confozmance with 2 N.N.C. f 183 (E).

## SECTION FOUR. APPROVING THE AMENDMENT TO NABIMY-32-15

The Navajo Nation hereby approves the amendment to NABIMY-32-15, Establishing the Naabik'iyáti' State Task Force as a Naabik'iyáti' Sub-Committee, attached hereto as Exhibit A.

SECTION FIVE. EFFECTIVE DATE
The provisions of this Act shall become effective in accord with 2 N.N.C. § 221 (C).
