BE IT ENACTED:

Section 1. Findings and Purposes

A. The Navajo Nation Board of Education consists of eleven (11) members. 10 N.N.C. §106(B). Five (5) members are elected at-large, one from each of the five (5) agencies. Six (6) members are appointed positions. *Id.*

B. Regarding appointments to the Navajo Nation Board of Education, the law provides:
"Six Board members shall be appointed to six year terms by the President of the Navajo Nation and confirmed by the [Health, Education and Human Services] Committee of the Navajo Nation Council. These members will be appointed in order to ensure that a variety of experience and knowledge is present on the Board." 10 N.N.C. §106(B)(3).

C. Qualifications for the six appointed positions to the Navajo Nation Board of Education are stated as follows - two appointed Board members will be individuals who are recognized for their knowledge of traditional Navajo culture; 10 N.N.C. §106(C)(1)(a); one appointed Board member will be a school administrator working on the Navajo Nation; 10

1 N.N.C. §106(C)(1)(b); two appointed Board member will be parents of at least one child
2 enrolled in a Kindergarten, elementary, or secondary program on the Navajo Nation; 10
3 N.N.C. §106(C)(1)(c); and, one appointed Board member will be a teacher employed in a
4 Bureau of Indian Affairs funded or state public school operating on the Navajo Nation; 10
5 N.N.C. §106(C)(1)(d) .

6 D. Pursuant to appointment provisions applicable to the Navajo Nation Board of
7 Education, President Ben Shelly has appointed Ms. Candace J. Keams-Benally, to the
8 teacher position on the Board. See Exhibit A, letter of appointment. Ms. King-Benally's
9 qualifications and interests are stated in Exhibit B.

10 E. The Health, Education and Human Services Committee serves as oversight for the
11 Navajo Nation Board of Education. 2 N.N.C. § 401(C)(3). The committee has authority to
12 confirm appointments to the Board. 10 N.N.C. §106(B)(3).

14 **Section 2. Confirmation of Appointment**

15 The Health, Education and Human Services Committee of the Navajo Nation Council
16 hereby confirms the appointment of Ms. Candace J. Keams-Benally, to the Navajo Nation
17 Board of Education. Ms. Keams-Benally shall serve in the teacher representative position
18 on the Board, as provided in 10 N.N.C. §106(C)(1)(d). She shall serve a term consistent
19 with 10 N.N.C. § 106(B).

Candace J. Keams-Benally: Autobiography

My name is Candace J. Keams-Benally. I am Kinłichii'nii born for the Tódích'íi'nii. My maternal grandfather is Bit'ahnii and my paternal grandfather is Tótsohníí. I was raised north of Aneth, Utah by my parents and my maternal grandparents. At an early age my family instilled perseverance to be successful in earning a degree in higher education; everyday my grandmother's values and principles she implanted in me are echoed.

Upon graduating from high school I began my college career. I earned my AS in Liberal Arts from the College of Eastern Utah, Blanding. Then I enrolled in the Distant Teacher Education Program offered by Fort Lewis College and received my BA in Bi-Cultural Studies. During this endeavor I also attended Dine College in Shiprock, NM and enrolled in a number of Navajo Language and Culture courses. At this point I was qualified to take a series of tests to become a certified teacher. I passed all the required tests and became a certified teacher and was hired as a FACE Early Childhood Teacher.

During my tenure as the teacher for Beclabito Day school I taught young children. There was one student with special needs that impacted my professional life so profoundly that I resigned in 2007 upon acceptance to the University of Oregon Graduate school to pursue my Master degree in Special Education. I had applied to the University of Oregon's Sapsikwala Project and was selected as a recipient of the grant. I was one of a cohort of six recipients. The Sapsik'wala (Teacher) Education Project was created by the University of Oregon College of Education in partnership with the nine federally recognized tribes of the State of Oregon. The goal of the project is to prepare American Indians and Alaska Natives (AI/AN) as teachers whose knowledge, skills, and cultural sensitivity will bring about long-term, much needed improvements in the elementary, middle and high school educational experiences of AI/AN youth. I was accepted to the University of Oregon Graduate school and graduated in 2008.

My philosophy of education has evolved over the years. I believe that all children have the innate ability to learn if given the right support and opportunity to receive a quality education. It is my desire to ensure that all students are given that opportunity. Children need to feel safe and supported in a positive learning environment. It is also important to me that parents are supported along with their students. Parents should also be empowered so they feel they have the tools to help support their child learning.

This opportunity to serve as a member of the committee will allow for me to share my vision, alongside fellow colleagues within the field of education.

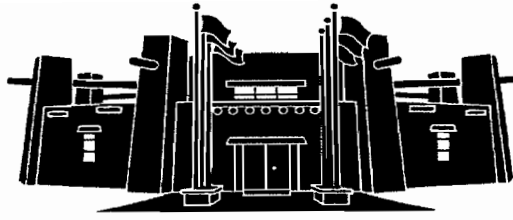


