PURPOSE: Resolution CJN-29-22, Section Ten, Subsection D states: "The eligibility criteria for receiving services under the Housing Projects assigned to CHID shall be approved by the Resources and Development Committee by resolution and shall include equal distribution by Delegate Region." The purpose of this legislation is to approve the Division of Community Development, Community Housing and Infrastructure, "DCD/CHID ARPA Housing Application and Eligibility Criteria," at pages one and two, Sections I through VI, of EXHIBIT A.

20	A. Pursuant to 2 N.N.C. § 500 (A), the Resources and Development Committee is hereby

E. In accordance with CJN-29-22, Section Ten, Subsection D, at page 16 of 28, "The eligibility criteria for receiving services under the Housing Projects assigned to CHID shall be approved by the Resources and Development Committee by resolution and shall include equal distribution by Delegate Region."

- A. In accordance with CJN-29-22, Section Ten, Subsection B (1), at page 15 of 28, "\$50,000,000 [is allocated] to the Community Housing and Infrastructure Department (CHID) for New Housing Projects, as Long-Term Housing Security: Services for Unhoused Persons (Expenditure Category 2.15) ..., with administrative oversight by the Division of Community Development and legislative oversight by the Resources and Development Committee."
- B. In accordance with CJN-29-22, Section Ten, Subsection C, at page 16 of 28, "The Housing Projects assigned to CHID ... are need-based."
- C. The CJN-29-22, Section Ten (D) Housing Projects "shall include equal distribution by Delegate Region."
- D. The Community Housing and Infrastructure Department developed the "DCD/CHID ARPA Housing Application and Eligibility Criteria," at Sections I through VI, of EXHIBIT A.

- E. The "DCD/CHID ARPA Housing Application and Eligibility Criteria" was developed to provide guidance to the Nation for determining the most qualified, eligible applicants to receive new housing under CJN-29-22 Section 10 (B) (1).
- F. The "DCD/CHID ARPA Housing Application and Eligibility Criteria" will ensure all applicants are qualified tribal members that have provided the required documentation and will consider site specific homesite conditions and costs associated with the required removal/demolition of existing structures, site preparation, available utilities, and accessibility to the homesite with the objective of maximizing the funding and serving as many tribal members with new housing as possible in each Delegate Region.

SECTION THREE. APPROVAL

A. The Resources and Development Committee of the Navajo Nation Council hereby approves the "DCD/CHID ARPA Housing Application and Eligibility Criteria," at Sections I through VI, of **EXHIBIT A.**



NAVAJO NATION FISCAL RECOVERY FUNDS DCD-CHID ARPA New Housing Application and Eligibility Criteria

I. Funding Source and Distribution

- A. Navajo Nation Fiscal Recovery Funds (2.16 New Housing): \$50 million
 - \$50 million to DCD/CHID new housing (CJN-29-22)
- B. \$50 million equal distribution to the 24 Council Delegate Regions
- C. \$2,083,333 to each Delegate Region

II. Application Solicitation

- A. Application Dates
 - 1. Issue notice to Chapters of the online New Housing Application
- B. Application Type and Submittal Process
 - 1. Online New housing application
 - 2. A link will be emailed to Chapters to access the online ARPA Housing Application
 - 3. Chapter staff must utilize Chapter email account to access application portal and to upload required supporting documents
 - 4. Chapter staff to assist community members with completing the online application for the neediest of the needy and submission
 - 5. One new housing application per applicant
- C. Application Requirements
 - Please make sure all information on the application is accurate and filled out entirely. If any information is not provided, your application will be considered incomplete and placed in "pending status".
 - 2. Head of Household is the only applicant to apply and submit housing application along with other necessary documents for homeownership completion through the application portal.
 - 3. All information entered on the application will be true and complete, any misrepresentation or false information will be justification for refusal of housing assistance.

III. Eligibility Criteria

- A. CHID office will screen the new housing applications once submitted by the Chapter
- B. CHID to ensure all applications have the Applicant's required supporting documents attached (copies):
 - Approved Homesite/Residential Lease (with Navajo Nation Arch & Biological Compliance Form)
 - Photo Identification Card (Government Issued)
 - Certificate of Indian Blood (CIB)
 - Proof of Chapter Voter Registration
 - Within Navajo Nation Service Area (utility connection)

- Doctor's Statement
- C. Applications will be separated based on number of bedrooms according to number persons in the household
- D. Applicants will be notified by CHID office if application is incomplete or any supporting documents not attached.

IV. Eligibility/Selection Criteria

- A. CHID office to carefully review each complete application and home site assessment to determine selection (serve the neediest of the needy):
 - Carefully review applicants' names on the home/residential lease, will not assist applicant if Applicant is not on the lease
 - Applicant is disabled/severe health concerns
 - Applicant has a burnout home
 - Applicant is homeless (no structure on home site)
 - Applicant's existing home is dilapidated (unrepairable)
 - Overcrowded or multi-generational home
 - Applicant utility service ready for connection

V. Application Homesite Assessments

- A. CHID office will conduct applicant homesite assessment to verify all information on the application is accurate, if any information on application is determined false, applicant will be ineligible for housing assistance.
- B. CHID office to request the attendance of a Chapter representative during meetings and assessments
- C. Visual assessment of the access road, existing home will determine if a new home is to be constructed or a possible renovation to a livable standard
- D. Existing homes will also be considered for demolition and removal if a new home is considered.

VI. Home Size Determination

- A. The size of the new home will be determined based on the number of eligible household members. This information will be shared with the applicant.
- B. The health condition of the applicant, if a care provider is needed, an additional bedroom will be added. A letter or statement from the health care provider will be required if home care services are needed
- C. All applicant's receiving new homes will also receive the required infrastructure to facilitate the home to include electric, solar, natural gas/propane, water/wastewater and cistern/septic system.
- D. There will be three types of floor plans: (ADA requirements will be applied)
 - 1. 1 bedroom; 1 bathroom (+/-700 sq. ft.)
 - 2. 2 bedroom; 1 bathroom (+/-1,000 sq. ft.)
 - 3. 3 bedroom; 2 bathroom (+/-1,200 sq. ft.)

VII. General Contractor Selection - Design Build (Stick Build, Modular, Manufactured)

- A. Compliance with the Navajo Business Opportunity Act (NBOA) and the Navajo Nation Procurement Policy to bid out services.
- B. Priority 1 and 2 qualified licensed General Contractor(s) and subcontractor's will be selected to perform the new housing construction for all selected eligible applicants.
- C. CHID office will develop the request for proposals (RFP/RFQ), including scope of work, budget and schedule for each new home construction activity
- D. The Contractor will update or redesign the existing floor plans, if needed.
- E. Additional design to improve the energy or cost efficiency of each new home
- F. The Contractor will comply with the current International Residential Codes, Plumbing and Electrical Codes.
- G. CHID office will coordinate with Contractor and Utility company to connect all utility services (waterline, wastewater system, powerline)
- H. CHID office & the Contractor will comply with all funding requirements and other laws and regulations.

VIII. New Housing Construction Phases

- A. The new home construction will identify the necessary work to be performed at each phase of the new home construction:
 - 1. Foundation/Site Prep;
 - 2. Subfloor;
 - 3. Exterior and interior walls;
 - 4. Rough-in electrical and plumbing
 - 5. Roof System;
 - 6. Exterior and interior finish walls
 - 7. Trim-out electrical and plumbing
 - 8. Accessible ramp at main entrance, if needed
 - 9. Existing home demolition and debris removal

X. Construction Begin

- A. Construction for new housing will be coordinated between the CHID office and the Contractor
- B. All preliminary activities have been cleared for construction
- C. Take into consideration weather conditions
- D. Chapters to communicate with homeowners to stay clear of the construction site and its contents, before, during and after construction, for their safety and the safety of the construction crew.

XI. Monitoring

A. CHID office will coordinate with the Contractor on scheduled monitoring visits to the construction site for reporting purposes.

- B. The Contractor will be required to provide bi-weekly written reports to include updated pictures, any project challenges, and/or changes to the project schedule
- C. office will meet and discuss any issues/concerns with the Contractor and to provide recommendations for solutions
- D. CHID will conduct continuous monitoring visits to the construction site until construction is complete

IX. Construction Completion and Final Inspection

- A. The Contractor must have completed all phases of the construction described in section VIII. and IV.
- B. All utility services are connected and operating
- A. The Contractor will inform the CHID office of the completion of the construction and schedule a Pre-Final Inspection to note any punch list
- B. All corrections to the punch list to be complete by the scheduled deadline and pre- established contract terms
- C. General Contractor will notify CHID office and CHID office will notify necessary parties of a final Inspection date and time
- D. The Contractor will be required to provide Operation and Maintenance (O&M) Manuals and training to Homeowner prior to occupancy.
- E. CHID office to hand over the Homeowner Certificate and house keys to the new homeowner

X. Close-out

- A. The Contractor to submit all pertinent construction documents to the CHID office for their records
- B. CHID office will pay out remaining invoices to the Contractor
- C. CHID office to maintain construction files at a central location for audit purposes

XIII. INVOICES & PAYMENTS

- A. All invoices and payments will be handled by the CHID office in coordination with the Contractor according to the master contract.
- B. Invoices to be paid according to Navajo Nation policies
