

BE IT ENACTED:

**SECTION ONE. AUTHORITIES**

- A. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council.  
2 N.N.C. §700(A).
- B. Pursuant to Navajo Nation Council CO-45-12, section 5(A), "references in the Navajo Nation Code and other official documents to the Government Services and Intergovernmental Relations Committees shall mean the Naabik'iyáti' Committee, unless the amendments enacted herein or the context of previous law indicates otherwise."
- C. The Naabik'iyáti' Committee is authorized to amend the Plan of Operation for the Office of Miss Navajo Nation.

**SECTION TWO. FINDINGS**

- A. The Office of Miss Navajo Nation is seeking amendments to its Plan of Operation. See attached Exhibit A.
- B. The Plan of Operation for Office of Miss Navajo Nation was last amended January 11, 2000. See Exhibit C, resolution GSCJA-03-00.

1 C. The Navajo Nation Department of Justice has determined the proposed amendments  
2 provided by Office of Miss Navajo Nation as "sufficient." See attached Exhibit B.

## PLAN OF OPERATION

## I. ESTABLISHMENT

The Office of Miss Navajo Nation is hereby established within the Office of President and Vice President, within the Executive Branch of the Navajo Nation.

~~II. MISSION STATEMENT~~

~~In keeping with the Navajo culture and tradition, the role of Miss Navajo Nation is to exemplify the essence and characters of First Woman, White Shell Woman, and Changing Woman, and to display leadership as the Goodwill Ambassador. Miss Navajo represents womanhood and fulfills the role of "grandmother, mother, aunt, and sister" to the Navajo people, and therefore she can speak as a leader, teacher, counselor, advisor, and friend. In March 1999, the Branch Chiefs of the Navajo Government agreed that one of the fundamental principles of the Navajo Government should be the preservation of Navajo Culture. It shall be the mission of the Office of Miss Navajo Nation to encourage every Navajo to assist in the preservation of Navajo Culture and Miss Navajo Nation will represent the importance of Navajo Women with respect and honor.~~

~~II.III. PURPOSE:~~

The purpose of the Office of Miss Navajo Nation is to assist Miss Navajo Nation with the scheduling of her itinerary, providing support services, ~~C~~chaperoning Miss Navajo Nation during travel, managing the administrative matters of the office, and coordinating educational activities that include the history, tradition, and culture of the Navajo people.

~~III.IV. STAFFING: AND ORGANIZATION~~~~A.I. STAFFING~~

- ~~1. The Office of Miss Navajo Nation shall be administered by a Program Director Supervisor; and,~~

1       2. The Program Supervisor of the Office of the Miss Navajo Nation shall be under  
2       the general direction, and guidance of the Chief of Staff with the Office of the  
3       President and Vice President.

4       3. The Program Supervisor shall be authorized to recommend additional  
5       professional and technical, and administrative support staff as needed to carry  
6       out the organizational purpose(s) as stated herein. Additional positions shall be  
7       acquired in accordance with the Executive Personnel Policies and Procedures  
8       and applicable budget rules established for conducting the annual Navajo  
9       Nation budget process.

10      4. The Office of Miss Navajo Nation department employees shall be hired,  
11      employed, and compensated pursuant to the Executive Personnel Policies and  
12      Procedures of the Navajo Nation.

13      5.2. The winner of the annual Miss Navajo Nation pageant shall occupy the title of  
14      Miss Navajo Nation for one year. Miss Navajo Nation will be directly  
15      supervised by the Program Director Supervisor, and be governed by the  
16      applicable Navajo Nation Executive Personnel Policies and Procedures, and  
17      other applicable laws of the Navajo Nation; and,

18      a. The one (1) year term may be extended for one (1) additional year in the  
19      event of exigent circumstances, including, but not limited to natural  
20      disasters, approved public emergency by the Emergency Management  
21      Commissions. The one (1) year extension must be approved by the Navajo  
22      Nation President.

23      3. ~~All staff members including the Program Director shall be hired and employed~~  
24      ~~in accordance with the applicable Personnel Policies and Procedures and other~~  
25      ~~applicable laws of the Navajo Nation; and~~

26      4. ~~All staff members shall be under the immediate supervision of the Program~~  
27      ~~Director. The designated employee in the Office of the President and Vice~~  
28      ~~President shall supervise the Program Director.~~

29      B. ORGANIZATION

30      The Organizational Chart is exhibit "B".

2 IV.V. RESPONSIBILITY AND AUTHORITY DUTIES AND RESPONSIBILITIES:

3 A.1. The Program Director Supervisor shall:

4 1.a. Prepare and Ssubmit quarterly reports to the Office of President and Vice  
5 President. ~~and,~~

6 2.b. Develop ~~prepare~~ an annual operating program budget, monitor expenditures,  
7 and provide quarterly expenditure reports to the Office of the President and  
8 Vice President. ~~and,~~

9 3.e. Manage and administer the daily activities of the Office of Miss Navajo Nation  
10 in consultation with Miss Navajo Nation including, but not limited to,  
11 developing, implementing, and amending standard procedures manuals,  
12 handbooks, memorandum of understanding and/or agreement, and developing,  
13 and maintaining performances-based measures for the Office of Miss Navajo  
14 Nation, consistent with applicable Navajo Nation laws; and,

15 4.d. Supervise, and evaluate all staff within the Office of Miss Navajo Nation. ~~and,~~

16 5.e. Assist Miss Navajo Nation with the scheduling of activities and functions,  
17 which she will promote and participate; Ensure that proper travel authorizations  
18 and chaperone staff are in place prior to commencing travel. All travel and  
19 related expenses are subject to availability of funds. ~~and,~~

20 6.f. Plan, coordinate, supervise, and monitor the annual Miss Navajo Nation  
21 Pageant in conjunction with the Navajo Nation Fair Office, and Committee. ~~and,~~  
22

23 7.g. Initiate, conduct, and participate in fund-raising campaigns on behalf of the  
24 Office of Miss Navajo Nation. The ~~primary~~ purpose of the fund-raising  
25 activities is to subsidize the Office of Miss Navajo Nation appropriated general  
26 funds. ~~and to establish a stable funding stream.~~ Ensure that the fund-raising  
27 activities comply with Navajo Nation laws, policies, and regulations.

28 B.2. Miss Navajo Nation shall:

29 1.a. ~~To the best of her abilities, r~~Represent the Navajo Nation as a Goodwill  
30 Ambassador by educating the general public on the history, tradition, and



1 culture of the Navajo people. The purpose and intent of the Goodwill  
2 Ambassadorship is to enhance the reputation of the Navajo Nation and increase  
3 the number of patronages on the Navajo Nation; and,

4 2.b. Participate in all fund-raising activities for the Office of Miss Navajo Nation  
5 and other charitable organizations at the choosing of Miss Navajo Nation to  
6 enhance the reputation of and increase the number of patronage on the Navajo  
7 Nation; and,

8 3.e. Participate in other activities as authorized by the Office of President and Vice  
9 President in accordance with the applicable Navajo Nation policies and ethic  
10 applicable laws; and,

11 4. Relinquish the Title, and Crown, including all benefits, gifts, royalties, and  
12 honors derived from the position for any of the following reasons:

13 a. If voluntarily submits a written notification to the Office of Miss Navajo  
14 Nation's Program Supervisor to end the title reign as Miss Navajo Nation  
15 prior to the end of reign year; and,

16 b. If Miss Navajo Nation seeks another royalty title during her reign as Miss  
17 Navajo Nation; and,

18 c. If Miss Navajo Nation is in violation of the Navajo Executive Personnel  
19 Policies and Procedures, and/or any applicable laws of the Navajo Nation.

20  
21 V.VI. ELIGIBILITY CRITERIA FOR MISS NAVAJO NATION PAGEANT CANDIDATES ARE  
22 AS FOLLOWS:

23 A.4. The Candidate(s) must be:

24 1.a. An enrolled member of the Navajo Nation. who speaks fluent Navajo and English;  
25 and knowledgeable in Navajo history, culture, and values and tradition.

26 2. A female, have always been a female, and biological born a female;

27 3. Able to demonstrate who fluency in speaking Navajo and English languages; and  
28 knowledgeable in Navajo history, culture, values, and tradition.

29 4. Knowledgeable in Navajo history, culture, values, and tradition;

30 5.b. 18-25 years of age, single, never married, and never had children;

1  
2 ~~6.e.~~ A high school graduate or hold a GED certificate ~~with a valid driver's license;~~

3 7. Have a valid State driver's license;

4 8. Of good moral character, and have not been involved at any time in any act of moral  
5 turpitude.

6 B.2. The Candidates must submit:

7 1.a. A 300-word essay on the topic of her choice; and,

8 2.b Three (3) letters of recommendation with one recommendation from any of the  
9 following: Chapter Official, Clergy, Academic Counselor, Community Leader, or from  
10 a professional.

11 C.3. The Candidate will be disqualified if:

12 1.a. She is registered for or on active duty in the National Guard or other military  
13 services; and,

14 2.b. She is enrolled in a post-secondary educational or trade institution; and,

15 3.e. She previously served as Miss Navajo Nation ~~for a full one-year term;~~ and,

16 4. She has falsified any information on contestant application for the Miss Navajo Nation  
17 title; and,

18 5. She does not comply with Miss Navajo Nation Pageant Code of Conduct, General  
19 Guidelines Agreement, Pageant Requirements, Rules, and Regulations.

20  
21 ~~VII.~~ VI. MISS NAVAJO NATION WILL RECEIVE THE FOLLOWING BENEFITS:

22 A.4 Miss Navajo Nation shall be paid an annual salary in accordance with the Office of  
23 Miss Navajo Nation fiscal year budget and applicable Executive Personnel Policies  
24 and Procedures of the Navajo Nation; and,

25 B.2 Upon successful completion of her reign, Miss Navajo Nation will receive an educational  
26 scholarship of \$7,500.00 if an undergraduate, or \$15,000.00 if a Graduate. The benefit  
27 shall be administered accordingly:

28 1. This educational scholarship shall be paid directly to the educational institution;  
29 and,

2. The former Miss Navajo Nation must submit proof of registration to the selected educational institution; or submit a written notice four (4) months in advance to Program Supervisor to reserve the educational scholarship for a period of one year, if she elects to enroll until the following fall academic semester; and,
3. The scholarship fund shall remain available within the Office of Miss Navajo Nation's program budget, and reserve for a period of one year after the conclusion the former Miss Navajo Nation's reign; and,
4. If there is no proof of registration, or written notice submitted to Program Supervisor the benefit will be deemed relinquished. This benefit is contingent upon the individual who was Miss Navajo continuing her education at the beginning of the next academic semester or the quarter following the conclusion of her reign; and,

C.3. Subject to the availability of funds, the Office of Miss Navajo Nation will be provided a Tribal Vehicle for Miss Navajo Nation. The assigned government tribal vehicle shall be used to carry-out Miss Navajo Nation's itinerary, and shall abide by the Navajo Nation Motor Vehicle Use Handbook.

D.4. Miss Navajo Nation shall be furnished a Tribal Apartment at Window Rock, Navajo Nation, (Arizona). The Office of Miss Navajo Nation shall budget for the pre-assigned Tribal Apartment including together with the cost of water, sewer, refuse disposal, electricity, and natural gas unless such costs and expenses are otherwise provided for in the Navajo Nation budget. without charge to Miss Navajo Nation for the duration of her reign. Miss Navajo Nation shall be responsible for the housing security deposit. Miss Navajo Nation shall adhere to the Navajo Nation Employee Housing Rules and Regulations. If Miss Navajo Nation declines to reside in pre-assigned tribal apartment ~~such residence~~, the Navajo Nation shall not be responsible or liable for costs, and expenses incurred by of her residing living elsewhere.

#### ~~VIII~~ VII. LEGISLATIVE OVERSIGHT:

The ~~Government Services~~ Naabik'iyati' Committee of the Navajo Nation Council shall be the oversight Committee for the Office of Miss Navajo Nation.

PLAN OF OPERATION**

**I. ESTABLISHMENT**

The Office of Miss Navajo Nation is hereby established within the Office of the Speaker within the Legislative Branch of the Navajo Nation.

**II. PURPOSE**

The purpose of the Office of Miss Navajo Nation is assist Miss Navajo Nation in scheduling her itinerary, provide support services, chaperone, manage the administrative matters of the office and to coordinate with Miss Navajo Nation to educate the general public on the history, tradition, and culture of the Navajo people.

**III. STAFFING**

1. The Office of Miss Navajo Nation shall be administered by a Program Director.
2. The position of Miss Navajo Nation shall be occupied by the winner of the annual Miss Navajo Nation pageant. Miss Navajo Nation will be supervised by the Program Director and governed by the Navajo Nation Personnel Policies and Procedures.
3. All staff members including the Program Director will be hired and employed according to the Navajo Nation Personnel Policies and Procedures and other applicable laws of the Navajo Nation.
4. All staff members shall be under the general supervision of the Speaker of the Navajo Nation Council.

**IV. DUTIES AND RESPONSIBILITIES**

1. The General duties and responsibilities of the Program Director shall include:
  - a. Make quarterly reports to the Speaker of the Navajo Nation Council;
  - b. Prepare an annual operating budget, monitor expenditure and provide a quarterly expenditure report to the Speaker of the Navajo Nation Council;
  - c. Manage the daily activities of the Office of Miss Navajo Nation;
  - d. Perform all administrative functions and matters of the Office;
  - e. Schedule all itineraries for Miss Navajo Nation's itinerary to make sure she is comfortable, lodging is arranged for, travel authorization is in place and provide chaperone. The itinerary will be based upon a written invitation and subject to availability of funds;

- f. Responsible for planning and supervising the annual Miss Navajo Nation pageant in conjunction with the Navajo Nation Fair Office and Committee;
  - g. Participate in fund-raising campaigns on behalf of the Office of Miss Navajo Nation.
2. Miss Navajo Nation shall:
- a. Represent the Navajo Nation as a Goodwill Ambassador by educating the general public on the history, tradition, and culture of the Navajo people;
  - b. Participate in fund-raising activities for the Office of Miss Navajo Nation and participate in other activities as authorized by the office.

V. THE ELIGIBILITY CRITERIA FOR MISS NAVAJO NATION PAGEANT ARE AS FOLLOWS:

- 1. The Candidate must be:
  - a. An enrolled member of the Navajo Nation who speaks fluently in Navajo and English, and who is knowledgeable in Navajo History, culture, values, and tradition;
  - b. 18-25 years of age, single, never married, and never had children;
  - c. A high school or GED graduate with a valid driver's license.
- 2. The Candidates must submit:
  - a. An essay composing of 300 words on a topic of her choice;
  - b. Three letters of recommendation with one recommendation from any of the following: Chapter Official, clergy, academic counselor, community leader, or from a professional.
- 3. The Candidate will be disqualified if:
  - a. She is actively in a military services, enrolled part or full time in a college or technical institution or had & previously been Miss Navajo Nation.

VI. MISS NAVAJO NATION WILL RECEIVE THE FOLLOWING BENEFITS:

- 1. Miss Navajo Nation shall earn a salary in accordance with applicable Tribal Personnel Policies and Procedures of the Navajo Nation;
- 2. Upon a successful completion of her reign, Miss Navajo Nation will receive a scholarship of \$7,500.00 if an Undergraduate or \$15,000.00 for a Graduate;
- 3. The Navajo Nation will provide a Tribal Vehicle for Miss Navajo Nation to use as it relates to her itinerary and shall abide by the Navajo Nation Motor Vehicle Review Board Handbook;

4. The Navajo Nation will furnish a Tribal Apartment at Window Rock, (Navajo Nation) Arizona, together with the cost of water, sewer, refuse disposal, electricity and natural gas without charge to Miss Navajo Nation the duration of her reign. If Miss Navajo Nation declines to reside in such a residence, the Navajo Nation shall not be responsible or liable for costs and expenses of living elsewhere.

**VII. MISS NAVAJO NATION WILL RELINQUISH HER TITLE/CROWN, ALL BENEFITS, GIFTS, ROYALTIES AND HONORS DERIVED FROM THE POSITION FOR THE FOLLOWING REASONS:**

1. Observed in bars, clubs, etc.
2. Intoxicated
3. Found in use or possession of alcohol or controlled drugs or substances.
4. If she marries or co-habitates during her year of reign.
5. Becomes pregnant during her reign.
6. Conducts herself in a manner contrary to applicable laws of the Navajo Nation.
7. If she is in violation of any parts of the Navajo Nation Personnel Policies and Procedures and the Navajo Nation Ethics in Government Act which constitutes removal.

**VIII. LEGISLATIVE OVERSIGHT**

The Intergovernmental Relations Committee of the Navajo Nation Council shall be the oversight Committee for the Office of Miss Navajo Nation.

**IX. AMENDMENT**

The Plan of Operation for the Office of Miss Navajo Nation may be amended from time to time by the Intergovernmental Relations Committee of the Navajo Nation Council when deemed appropriate.

In keeping with Navajo culture and tradition, the role of Miss Navajo Nation is to exemplify the essence and characters of First Woman, White Shell Woman, and Changing Woman and to display leadership as the Goodwill Ambassador. - a. To the best of her ability, Represent the Navajo Nation as a Goodwill Ambassador by educating the general public on the history, tradition, and culture of the Navajo people. The purpose and intent of the Goodwill Ambassadorship is to enhance the reputation of the Navajo Nation and increase the number of patronage on the Navajo Nation; and
- b. Participate in fund-raising activities for the Office of Miss Navajo Nation and other charitable organizations at the choosing of Miss Navajo Nation to enhance the reputation of and increase the number of patronage on the Navajo Nation; and participate in other activities as authorized by the office.



- c. Participate in other activities as authorized by the Office of the President and Vice President in accordance with Navajo Nation policies and ethics laws.

**VI THE ELIGIBILITY CRITERIA FOR MISS NAVAJO NATION PAGEANT CANDIDATES ARE AS FOLLOWS:**

- a. An enrolled member of the Navajo Nation who speaks fluently in Navajo and English, and who is knowledgeable in Navajo History, culture, values, and tradition; and
- b. 18-25 years of age; single; never married; and never had children; and
- c. A high school or GED graduate or hold a GED certificate with a valid driver's license.

**2. The Candidates must submit:**

- a. An 300 word essay composing of 300 words on a topic of her choice; and
- b. Three letters of recommendation with one recommendation from any of the following: Chapter Official, eClergy, aAcademic eCounselor, eCommunity lLeader, or from a professional.

**3. The Candidate will be disqualified if:**

- a. She is on active duty in the National Guard or other military services; and actively in a military services, enrolled part or full time in a college or technical institution or had previously been Miss Navajo Nation.

- c. She previously served as Miss Navajo Nation for a full one-year term.


I have attached my comments to the Office of Miss Navajo Nation's Plan of Operation and hope my recommendations will be considered.

Here are my comments to the Plan of Operation. I did my comments and explanations in blue where I thought changes or updates need to be. I left it blank where I thought it was ok and no need to make any updates or changes.

## PLAN OF OPERATION

### I. ESTABLISHMENT

Since the Office of Miss Navajo Nation is established within the Executive Branch of the Office of President & Vice President, Miss Navajo Nation represents the Navajo Nation, as an ambassador. Miss Navajo Nation should not limit her abilities to solely working with one Navajo Nation Branch, however, work with the Legislative and Judicial Branches, as well as other Navajo entities and enterprises.

### II. MISSION STATEMENT

The Mission Statement is important to reinstate because it is a concise explanation of the organization's reason for existence. It describes the organization's purpose and its overall intention. The statement supports the overall vision and serves to communicate purposes and directions for Miss Navajo Nation, Office of Miss Navajo staff members, and other stakeholders to follow. Former Miss Navajo Nation titleholders, including myself, believed in the Mission Statement. It helps clarify the overall duties and responsibilities within the Office of Miss Navajo Nation. Also, it is important to re-emphasize the importance of the Dine language. The Dine language is a cultural identity, as well as, the vital cultural representation Miss Navajo Nation is recognized as, needs to be preserved and reiterated.

In keeping with the Navajo Language, Culture and Traditions, the role of Miss Navajo Nation is to exemplify the essence and qualities of First Woman, Changing Woman, and White Shell woman, and to display leadership as the Goodwill Ambassador. Miss Navajo Nation represents womanhood and fulfills the role of "grandmother, mother, aunt and sister" to the Navajo People, and therefore she can speak as a leader, teacher, counselor, advisor, and friend. (I took this part out In March 1999) The Branch Chiefs of the Navajo government agreed, one of the fundamental principles of the Navajo government should be the preservation of Navajo Culture. It shall be the mission of the Office of Miss Navajo Nation to encourage every Navajo to assist in the preservation of the Navajo Language and Navajo Culture. Miss Navajo Nation will represent the importance of Navajo women with respect and honor.

One recommendation is to reference Mrs. Angela Barney Nez's comment. Her comments are to reference the Navajo Nation Code and the Din4 Fundamental Law, which provides an explanation to reciting the need for preservation of the Din4 language and culture, as a law and codified in the Navajo Nation Code. This reference would provide clarification and understanding for the Office of Miss Navajo Nation.

### III. PURPOSE

The purpose of the Office of Miss Navajo Nation is to assist Miss Navajo Nation with the scheduling of her itinerary, providing support services, chaperoning Miss Navajo Nation during travel, managing the administrative matters of the office, and coordinating educational activities that include the [language](#), history, tradition, and culture of the Navajo People. Furthermore, establish a recruitment process for interested qualified candidates by helping with screening application, which leads to hosting the annual Miss Navajo Nation pageant.

The purpose of the Office of Miss Navajo Nation is to offer help and assist if a Miss Navajo Nation cannot speak the Dine language by registering her for a Dine Language course or request a fluent Dine speaker to work with Miss Navajo Nation. The preservation of the Dine language is important for Miss Navajo Nation to understand the vital communication from the public, as well as, overcoming the language barriers. Two Miss Navajo Nation pageants have been held, where none of the contestants spoke Dine fluently or immediately. Therefore, the Office of Miss Navajo Nation should be held responsible in teaching the Dine language and cultural aspects to provide knowledge and understanding of Miss Navajo Nation. Another recommendation to add to the purpose of the office is to oversee and manage the annual Miss Navajo Nation Pageant.

The purpose needs to state how assistance is offered in coordinating educational activities, which include the Navajo language, history, tradition, and culture. In my experience being a former Miss Navajo Nation, assistance with educational cultural outreach was never explained or the process in conducting projects were clearly emphasized. It was until new management within the Office of Miss Navajo Nation, did I learn the process of projects with the help of newly hired Program Director. The assistance from the Office of Miss Navajo Nation Secretary did not provide any clarification on this purpose, as well. This information is to provide an understanding that the Office of Miss Navajo Nation was not always supported by representative from the office on offering assistance. Therefore, addressing the clear understanding of the role and responsibilities from each member of the Office of Miss Navajo Nation will benefit the outcome of working together and providing as much service to the public.

### IV. STAFFING AND ORGANIZATION

#### A. Staffing

3. This state "Executive Personnel Policies and Procedures". I have never heard of an "Executive", which should state The Navajo Nation Personnel Policies and Procedures, provided by the Department of Personnel Management. The term "Executive" is



mentioned several times, however, the Legislative and Judicial Branches refer to the Navajo Nation Personnel Policies and Procedures, instead.

4. All staff members including the Program Supervisor within the Office of Miss Navajo Nation shall be hired, employed, and compensated, in accordance with the applicable Navajo Nation Personnel Policies and Procedures and other applicable laws of the Navajo Nation.

For the best interest of the Office of Miss Navajo Nation, the current Program Supervisor position was never announced or advertised. This would have given other individuals on and off the Navajo Nation an opportunity to be considered based on their qualification, which benefits the Office of Miss Navajo Nation.

5. The wording is fine, however, other alternatives should be offered or suggested before immediately re-instating Miss Navajo Nation to continue her reign for another year. The well-being of the Miss Navajo Nation title can at times be exhausting and stressful to be maintain, especially during a pandemic. Other suggested alternatives would be maybe hosting a virtual pageant, or at least continue with the screening of contestants' applications. This would allow any contestants a fair advantage in possibly being Miss Navajo Nation if they are 25 years of age since the age is limited. The contestant would be given an opportunity to resubmit an application due to the pandemic.

#### B. ORGANIZATION

An Organizational Chart needs to be attached. This provides clarification and understanding of the Office of Miss Navajo Nation.

### V. RESPONSIBILITY AND AUTHORITY

#### A. The Program Supervisor shall:

- 1.

3. Manage and administer the daily activities of the Office of Miss Navajo Nation in consultation with Miss Navajo Nation including, but not limited to, developing, implementing and amending standard procedures manuals, handbooks, memorandums of understanding and/or agreement, and developing, and maintaining performance-based measures for the Office of Miss Navajo Nation, consistent with the Navajo Nation laws. Miss Navajo Nation needs to be able to understand the administrative functions of the Office of Miss Navajo Nation. This includes able to manage, learn the overall administrative functions of the office. Former Miss Navajo Nation at most were not encouraged to be a part of important administrative process or decision making. However, the improvements of the office need to be heard and address from Miss Navajo Nation, based on her current reign experience. Miss Navajo Nation may provide vital information by offering recommendations and suggestions on all administrative functions.
4. Supervise and evaluate all staff within the Office of Miss Navajo Nation.

I am not sure how you evaluate Miss Navajo Nation. Regular Navajo Nation employees usually get evaluated annually, however, as a suggestion; Miss Navajo Nation could be assessed based on a 90-day evaluation process, instead. The assessment process could provide more an understanding on the Navajo Nation Personnel Policy & Procedure manual, daily work-related objectives, promptness to meeting or events, conducting Miss Navajo Nation business in a professional manner, etc. Also, Miss Navajo Nation would be given an opportunity, as well, to provide any clarification or needed understanding to fulfill the role as best.

5. The safety of Miss Navajo Nation is especially important. Security options needs to be offered for events or fairs, where large crowds are expected. Also, upholding the integrity and responsibilities the role Miss Navajo Nation values, there is no engagement of alcohol or substance abuse while on travel, as a chaperone for Miss Navajo Nation. Former Miss Navajo have experience issues relating to this, where chaperones have justified by stating consumption are on their own time. Any travels with the company of Miss Navajo Nation there is NO type of alcohol or substance consumption of any sort to be conducted. Suggestion may need to have chaperones signed a wavier if they are not a Navajo Nation employee. Navajo Nation employees are to not have any consumption, while on any Navajo Nation related businesses.
6. Plan, coordinate, supervise and monitor the annual Miss Navajo Nation Pageant in conjunction with the Navajo Nation Fair Office, committee, and sponsors. Sponsors are added to this section, because the Miss Navajo Nation Pageant has been sponsored by major sponsorship or corporations' contributions, which helped make the Miss Navajo Nation pageant a reality. Also, the Miss Navajo Nation Council needs to be added, since the organization has been requested to help in coordinating the Miss Navajo Nation Pageant.
7. Initiate, conduct, and participate in fund-raising campaigns on behalf of the Office of Miss Navajo Nation. The purpose of the fund-raising activities is to subsidize the Office of Miss Navajo Nation appropriated general funds. Ensure that the fund-raising activities comply with Navajo Nation laws, polices, and regulations. I do not know of any other office within the Navajo Nation government that has to fundraise to elevate costs, more funds should be requested by the Office of the President and Vice-President and the Navajo Nation Council. Fundraising or solicitation of sponsors should be for the Miss Navajo Pageant.

B. Miss Navajo Nation shall:

1. Represent the Navajo Nation as a Goodwill Ambassador by educating the general public on the Navajo/Din4 Language, history, tradition and culture of the Navajo people. The purpose and intent of the Goodwill Ambassadorship is to enhance and help preserve the Din4 language and culture identity of the Navajo People.



2. Participate in all fund-raising activities for the Office of Miss Navajo Nation, the Miss Navajo Nation Pageant, and other charitable organizations at the choosing of the Miss Navajo Nation.  
Take out to enhance the reputation of the Navajo Nation.
3. Participate in other activities as authorized by the Office of President and Vice President in accordance with the applicable Navajo Nation polices and laws.  
Since the Office is established under OPVP, Miss Navajo Nation represents the Navajo Nation so being under the Executive Branch should not limit her ability to work with the Legislative and Judicial Branches or other Navajo entities/enterprises.
4. Relinquish the title, and crown, including all benefits, gifts, royalties, and honors derived from the position for any of the following reasons:
  - a.

  - c.
  - d. Observed in bars, clubs, etc.
  - e. If she becomes pregnant.
  - f. If she marries or cohabitates during her year of reign

In a previous Plan of Operation, it listed d, e, and f. I recommend it be re-inserted and not removed from the Plan of Operations. It is not against Navajo Nation Personnel Policies and Procedures or Navajo Nation Laws, if Miss Navajo Nation becomes pregnant, marry, or cohabitate. However, these are vital criteria to relinquish the title. Miss Navajo Nation should not be involved or witnessed to be located, where the Office of Miss Navajo Nation integrity is questioned or perceived in a negative manner.

#### VI. ELIGIBILITY CRITERIA FOR MISS NAVAJO NATION PAGEANT CANDIDATES ARE AS FOLLOWS

##### A. The Candidates(s) must be:

3. Able to demonstrate fluency in speaking Navajo and English languages. Is a test needed when contestants submit their pageant application to demonstrate fluency? The past two pageants contestants did not speak fluently.

5. 18 to 25 years of age, single, never married, no common law spouse and never had children. In the case that a pageant was not conducted due to the event of exigent circumstances, including but not limited to natural disasters and approved public emergency by the Emergency Management Commissions, the following year pageant age criteria should be extended to 26 years of age. Therefore, the contestant should be allowed to apply the following year, due to submitting application at the age of 25 years old.

2. Should be removed, the candidates should be allowed to participate in the pageant while in school, undergraduate, post-secondary, or trade school. However, the contestants should look into their educational institutions policies, if they are crowned Miss Navajo Nation, which they are required to leave school. Contestants need to understand after you start a school semester or plan to leave the school, it may lead to non-refundable school expense.

5. We were not given copies of the Pageant Code of Conduct, etc.

VII. Miss Navajo Nation will receive the following benefits.

B. Upon successful completion of her reign, Miss Navajo Nation will receive an educational scholarship of \$7,500.00 if an undergraduate, or \$15,000 if a graduate. I recommend the educational scholarship if possible, to be increased, because the amount has not changed, which most college and universities cost of tuition has increased annually. Clarification if needed for this section. Since the educational scholarship does not state if this is a one-time scholarship or offered a semester or for the entire school year. Most scholarships awarded are usually continuously awarded over time. The educational scholarship does not state if it is only for full-time students. I recommend the scholarship be offered to part-time student for both undergraduate and graduate school, as well for trade school. Another recommendation to consider is when a Miss Navajo Nation completed her reign, the scholarship should be reserved and not taken away if it has not been disbursed. No time limit or an extended timeline on the scholarship disbursement should be implemented. The educational scholarship awarded after Miss Navajo Nation completing her reign needs to be awarded and consideration to when she decides to return to school. The transition period from ending her reign and starting a new school year can be challenging and overwhelming. Much needed rest for the well-being from fulfilling the Miss Navajo Nation

role maybe needed. Therefore, the educational scholarship needs to be available when Miss Navajo Nation is ready to return to her educational or trade endeavors.

The benefit shall be administered accordingly:

1.

2. The former Miss Navajo Nation must submit proof of registration to the selected educational institution; or submit a written notice four months in advance to the Program Supervisor to reserve the educational scholarship for a period of one year, if she elects to enroll until the following fall academic semester; and

The scholarship should be reserved because the outgoing Miss Navajo completed her reign. There should be no timeframe. However, I recommend changing the "reserve the educational scholarship for a period of one year" to at most a period of four to five years to use the scholarship awarded.

3. The scholarship should be reserved for the former Miss Navajo Nation until it is used. There should be no timeframe or a longer timeframe of 4 to 5 years.

4. This should be removed, because if outgoing Miss Navajo completed her year and is awarded the scholarship. She has fulfilled her duties and responsibilities in completing her reign, therefore, relinquishing or not awarding the educational scholarship for any reason should not be considered or taken away.







Re : **Report of the Health, Education and Human Services Committee on Amendments proposed to Plan of Operation for Office of Miss Navajo Nation (0221-20)**

The Health, Education and Human Services Committee (HEHSC) of the Navajo Nation Council provides its report on the above proposed resolution originally presented to Naabik'íyáti' Committee. Recommendations of HEHSC are based on presentations of former Miss Navajo Nation title holders, as well as those provided by the Office of Miss Navajo Nation. The report of HEHSC is provided as amendments to proposed legislation 0221-21. The amendments proposed by HEHSC are as follows:

1. On page 3, at section II, *Purpose*, lines 21 through 24 should be amended as follows:

~~The purpose of the Office of Miss Navajo Nation is to assist Miss Navajo Nation with the scheduling of her itinerary, providing support services, Chaperoning Miss Navajo Nation during travel, managing the administrative matters of the office, and coordinating educational activities that include the history, tradition, and culture of the Navajo people. The purpose of the Office of the Miss Navajo Nation is to plan and coordinate the annual Miss Navajo Nation Pageant.~~

2. On page 4, delete proposed new language on lines 18 - 22 as follows:

~~a. The one (1) year term may be extended for one (1) additional year in the event of exigent circumstances, including, but not limited to natural disasters, approved public emergency by the Emergency Management Commissions. The one (1) year extension must be approved by the Navajo Nation President.~~

3. On page 5, under section IV(A), *Responsibility and Authority* of the Program Supervisor, beginning at line 28, add by inserting new language as follows-

8. Be knowledgeable in the Diné language and culture.

9. Work with, or seek the assistance of, the Legislative and Judicial branches, Navajo organizations, entities and tribal enterprises in executing the intent, purposes and responsibilities of the Office.

4. On page 5, under section IV(B), *Responsibility and Authority* of Miss Navajo Nation, starting at line 29, add by inserting new language as follows -

1. Teach and exemplify the essence and characteristics of First Woman, White Shell Woman and Changing Woman, and to display leadership as the Nation's Goodwill Ambassador.

2. Represent Diné womanhood, fulfill the role of "grandmother, mother, aunt, and sister" to the Navajo people, and speak as a leader, teacher, counselor, advisor, and friend. Miss Navajo Nation shall represent the importance of Navajo women with respect and honor.

3. Consistent with the requirements of Dine Fundamental Law in the preservation of language and culture, encourage every Navajo to assist in the preservation of Diné language and culture.

Other provisions under section IV(B) shall be redesignated.

5. On page 6, delete and remove the entire proposed new language on lines 11 - 19 as follows:

~~4. Relinquish the Title, and Crown, including all benefits, gifts, royalties, and honors derived from the position for any of the following reasons:~~

~~a. If voluntarily submits a written notification to the Office of Miss Navajo Nation's Program Supervisor to end the title reign as Miss Navajo Nation prior to the end of reign year; and,~~

- ~~b. If Miss Navajo Nation seeks another royalty title during her reign as Miss Navajo Nation; and;~~
- ~~e. If Miss Navajo Nation is in violation of the Navajo Executive Personnel Policies and Procedures, and/or any applicable laws of the Navajo Nation.~~

6. On pages 6 and 7, replace proposed amendments at new section V(A) as follows:

### V VI. ELIGIBILITY CRITERIA FOR MISS NAVAJO NATION CANDIDATES ARE AS FOLLOWS:

A 1. The Candidate must be: A candidate shall submit an application and must be:

- 1 a. An enrolled member of the Navajo Nation, as shown by a Certificate of Indian Blood or Navajo Nation voter registration document(s); who speaks fluent Navajo and English, and knowledgeable in Navajo history, culture, and values and tradition; and;
- 2. Female at birth, as indicated in birth certificate;
- 3. Able to demonstrate fluency in speaking Navajo and English;
- 4. Knowledgeable in Navajo history, culture, values, and tradition;
- 5 b. 18-25 years of age, single, never married, and never had children;
- 6 e. A high school graduate or hold a GED certificate with a valid driver's license;
- 7. Licensed to operate a motor vehicle;
- 8. Of good moral character, and have not been involved at any time in any act of moral turpitude.

7. Delete the entirety of proposed VI-B, on pages 7 and 8, and insert new language as follows:

B.2 Upon successful completion of her reign, Miss Navajo Nation will receive an educational scholarship of \$7,500.00 if an undergraduate, or \$15,000.00 if a Graduate. The benefit shall be administered accordingly:

- 1. This educational scholarship shall be paid directly to the educational institution; and;
- 2. The former Miss Navajo Nation must submit proof of registration to the selected educational institution; or submit a written notice four (4) months in advance to Program Supervisor to reserve the educational scholarship for a period of one year, if she elects to enroll until the following fall academic semester; and;
- 3. The scholarship fund shall remain available within the Office of Miss Navajo Nation's program budget, and reserve for a period of one year after the conclusion the former Miss Navajo Nation's reign; and;
- 4. If there is no proof of registration, or written notice submitted to Program Supervisor the benefit will be deemed relinquished. This benefit is contingent upon the individual

~~who was Miss Navajo continuing her education at the beginning of the next academic semester or the quarter following the conclusion of her reign; and,~~

B. Miss Navajo Nation, upon successful completion of her reign, shall receive \$7,500 which may be used for post high school education expenses.

8. On page 8, insert at line 27 the following new section:

### VII. RELINQUISHMENT OF TITLE AND CROWN

A. Miss Navajo Nation shall relinquish her title and crown, including all benefits, gifts, royalties, and honors derived from the position, for any of the following reasons:

1. If voluntarily submits a written notification to the Office of Miss Navajo Nation's Program Supervisor to end the title reign as Miss Navajo Nation prior to the end of reign year;
2. If Miss Navajo Nation seeks another royalty title during her reign as Miss Navajo Nation;
3. If Miss Navajo Nation is in violation of the Navajo Executive Personnel Policies and Procedures, and/or any applicable laws of the Navajo Nation; or,
4. Any occurrence for which a candidate for Miss Navajo Nation can be disqualified under this Plan of Operation.

B. In the event that Miss Navajo Nation relinquishes her title, or is unable to complete her term, the first runner-up to Miss Navajo Nation, if she is qualified, shall assume the role and responsibility as Miss Navajo Nation for the remaining term.

Redesignate the remaining section(s).
