**PURPOSE:** This resolution, if approved, will adopt the Navajo Nation CARES Fund Act that authorizes the President to develop expenditure plans for the Nation's share of the federal CARES Act, Title V, funds.

**This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each committee member to review the proposed resolution in detail.**

BE IT ENACTED:

Section One. Authority

- A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102(A).
- B. The Naabik'iyati' Committee is a standing committee of the Navajo Nation Council with the responsibility to hear proposed resolution(s) that require final action by the Navajo Nation Council. 2 N.N.C. § 164 (A)(9).
- C. The Budget and Finance Committee is a standing committee of the Navajo Nation Council with the enumerated powers to review and recommend to the Navajo Nation

1 Council the budgeting, appropriation, investment and management of all funds and to  
2 promulgate rules and regulations relative to contracting and financial matters. 2 N.N.C.  
3 §§ 300 (B)(1) and (2).  
4

5 **Section Two. Findings**

- 6 A. The World Health Organization (WHO) declared a Public Health Emergency of  
7 International Concern related to the outbreak of coronavirus (COVID-19), a highly  
8 contagious and, at times, fatal respiratory virus, on January 30, 2020; the U.S.  
9 Department of Health and Human Services declared a Public Health Emergency  
10 related to the COVID-19 outbreak on January 31, 2020; and the WHO declared a  
11 global pandemic due to COVID-19 on March 11, 2020. The pandemic has reached  
12 the Navajo Nation.
- 13 B. On March 11, 2020, the Navajo Nation Commission on Emergency Management,  
14 with the concurrence of the Navajo Nation President and Vice President, declared a  
15 Public Health State of Emergency on the Navajo Nation due to the presence of  
16 COVID-19 in areas surrounding the Navajo Nation. Resolution No. CEM 20-03-11.  
17 The President and Commission have issued other Public Health Emergency Orders:  
18 including: Order No. 2020-001 dated March 18, 2020 (declaring the outbreak of  
19 COVID-19 and limiting mass gatherings); Order No. 2020-002 dated March 19, 2020  
20 (quarantining the Chilchinbeto Community); Order No. 2020-003 dated March 20,  
21 2020 (ordering individuals living on the Navajo Nation to stay home and shelter in  
22 place except for essential activities, prohibiting visitors to the Navajo Nation, and  
23 closing all businesses on the Navajo Nation except essential businesses); Order No.  
24 2020-004 dated March 29, 2020 (implementing a daily curfew from 8:00 p.m. to 5:00  
25 a.m. for all Navajo Nation residents, extending the shelter in place order, and further  
26 limiting public gatherings); Order No. 2020-005 dated April 5, 2020 (implementing a  
27 57-hour weekend curfew on April 10-13); Order No. 2020-006 dated April 16, 2020  
28 (extending the weekend curfew for April 17-20 and April 24-27, and closing Navajo  
29 Nation essential businesses during curfew hours); Order No. 2020-007 (requiring face  
30 masks in public); and Order No. 2020-008 dated April 29, 2020 (extending the

1 weekend curfew to May 11 ). The Navajo Nation Office of the President and Vice  
2 President issued Executive Order 002-20 on March 31, 2020 (closing all Navajo  
3 Nation offices except essential personnel through April 21); and Executive Order  
4 003-20 on April 21, 2020 (extending the closure order to May 17, 2020).

5 C. As of May 13, 2020, the Navajo Nation Health Command Operations Center  
6 confirmed a total of 3,392 COVID-19 cases on the Navajo Nation and 119 related  
7 deaths, these numbers continue to increase.

8 D. The U.S. Congress on March 27, 2020, enacted the Coronavirus Aid, Relief, and  
9 Economic Security Act ("CARES Act"), Pub. L. No. 116-136, 134 Stat. 281 (2020).  
10 The federal CARES Act, at Title V, § 5001, entitled "Coronavirus Relief Funds," set  
11 aside \$8 billion in emergency aid for Tribal governments to address the COVID-19  
12 pandemic. The federal CARES Act is attached as **Exhibit A**.

13 E. On April 22, 2020, the U.S. Treasury issued "Coronavirus Relief Fund Guidance for  
14 State, Territorial, Local, and Tribal Governments" (hereinafter "Treasury's  
15 Guidance") related to the permissible uses of the Coronavirus Relief Fund. See,  
16 **Exhibit B**. Examples of eligible expenditures and ineligible expenditures are included  
17 in Treasury's Guidance. After litigation in *Confederated Tribes of the Chehalis*  
18 *Reservation v. Mnuchin*, Case No. 1:20-cv-01002-APM, in which the Navajo Nation  
19 participated as a party, on May 5, 2020, the U.S. Departments of Treasury and  
20 Interior issued a joint press release announcing that the U.S. Treasury would  
21 distribute 60% of the \$8 billion, or \$4.8 billion, to Tribal governments. Of this, the  
22 Navajo Nation's share from the federal Coronavirus Relief Fund initially distributed  
23 from the U.S. Treasury on or about May 5, 2020 is \$600,559,530.10. The funds have  
24 been deposited into Navajo Nation accounts.

25 F. The federal CARES Act expressly provides that Coronavirus Relief Fund shall be  
26 used to cover costs that are necessary expenditures incurred due to the public health  
27 emergency with respect to COVID-19 and related purposes. The Navajo Nation may  
28 need to expand the scope of the relief fund in providing services to residents of the  
29 Navajo Nation. For example, water and telecommunication developments are not  
30 specifically mentioned in the federal CARES Act or Treasury's Guidance, but it is

1 needed to provide Navajo families with water and communication as part of the effort  
2 to combat the COVID-19 pandemic. Further, Navajo Nation needs to prepare for a  
3 possible second wave of COVID-19. Navajo families are running into lockdowns of  
4 towns bordering the Navajo Nation and cannot shop as they wish. The Navajo Nation  
5 may need to use federal CARES Act fund to provide relief to Navajo families to shop  
6 for necessary commodities when border towns are locked down; Navajo Nation may  
7 have to provide needed relief to Navajo families to obtain fuel, food, sanitizing  
8 products, personal protective equipment, and other necessary supplies. The President  
9 should be allowed to negotiate with the federal government to provide for needed  
10 relief to Navajo families.

11 G. Like the States, the pandemic was not expected by the Navajo Nation and no funds  
12 were appropriated in anticipation of the pandemic response. Thus, federal CARES  
13 Act funds are not general fund revenues. They are limited emergency federal funds  
14 provided by the federal government to the Navajo Nation. Existing laws of the  
15 Navajo Nation cannot accommodate the rapid expenditure of the federal CARES Act  
16 funds and special expending and auditing procedures need to be devised.

17 H. Because the funds are not projected revenue, they should not be subject to any  
18 provisions of the Navajo Nation Code which requires a portion of funds to be set-  
19 aside and deposited into any other fund of the Navajo Nation.

20 I. The Navajo Nation Council further finds that because the Coronavirus Relief Fund  
21 can only be used for expenditures through December 30, 2020, procurements  
22 expending these funds must be expedited. The President should provide proposed  
23 regulations within ten days to the Budget and Finance Committee for approval. The  
24 proposed regulations shall provide for expedited expenditure of the CARES Act  
25 funds and accounting of the funds.

26 J. Since the restructuring of Navajo Nation government in 1989, the Navajo Nation is  
27 facing a pandemic for the first time requiring social distancing, hygiene practices,  
28 healthcare treatment at a distance, distant educational learning, provision of food,  
29 water, fuel, and other supplies to quarantined or curfewed Navajo families and other  
30 issues of first impression. Navajo Nation has to decrease the number of infectious

1 cases, take measures for the safeguarding of Navajo population, construct  
2 infrastructure to treat patients, provide for water to homes, institute telemedicine and  
3 telehealth, establish distance learning, development of businesses on Navajoland,  
4 reconfigure work stations and offices for employees, and to supplement governmental  
5 efforts like providing or selling food, water, personal protective equipment, and other  
6 necessary supplies.

7 K. The Navajo Nation Council finds it in the best interests of the Navajo Nation to enact  
8 the "Navajo Nation CARES Fund Act".  
9

### 10 **Section Three. Establishment and Expenditure of the Navajo Nation CARES Fund**

- 11 A. There is established the "Navajo Nation CARES Fund" (hereinafter "Fund").
- 12 B. The Navajo Nation hereby designates that the monies that the Navajo Nation has  
13 received, and will later receive, from the United States pursuant to the federal  
14 CARES Act, shall be deposited into the Navajo Nation CARES Fund.
- 15 C. Any monies deposited into the Fund shall be used in accordance with Title V of the  
16 CARES Act, Treasury's Guidance and any further guidance, rulemaking and  
17 regulations, whether federal or Navajo Nation, and agreements between the Navajo  
18 Nation and the federal government on the use of the Fund.
- 19 D. The Fund shall be a continuing account and shall not lapse on an annual basis  
20 pursuant to 12 N.N.C. § 820(N).
- 21 E. Purpose. The purpose of the Fund is to serve as a depository into which the  
22 Coronavirus Relief Funds appropriated by the United States for the benefit of the  
23 Navajo Nation under Title V of the CARES Act are deposited, and from which the  
24 Navajo Nation shall expend funds as stated herein.
- 25 F. Expenditures of the Fund. Pursuant to Section Five (A) and (C) below, the President  
26 shall develop and prepare all expenditure plans. The President shall incorporate the  
27 needs of the Executive Branch in an expenditure plan for the Executive Branch. The  
28 President shall incorporate the needs of the Legislative Branch, after consulting with  
29 the Speaker of the Navajo Nation Council, in an expenditure plan for the Legislative  
30 Branch. The President shall incorporate the needs of the Judicial Branch, after

1 consulting with the Chief Justice, in an expenditure plan for the Judicial Branch.  
2 Such expenditure plans shall be in accordance with Title V of the federal CARES  
3 Act, U.S. Treasury guidance and any other guidelines or regulations as stated herein  
4 in paragraph C above.

5 G. Expenditure plans shall not be considered as appropriations and shall not be subject to  
6 the Navajo Nation Appropriations Act, 12 N.N.C. §§ 800 *et seq.* or its underlying  
7 policies and regulations, including the Budget Instructions Manual.

8 H. Audit. The Controller shall keep records sufficient to demonstrate that the  
9 Coronavirus Relief Funds appropriated by the U.S. Congress to the Navajo Nation  
10 have been used in accordance with the federal CARES Act and § 601(d) of the Social  
11 Security Act. The Fund shall be subject to annual audit by the Navajo Nation's  
12 independent auditor. The Navajo Nation Council and/or the Navajo Nation President  
13 may require an interim audit at any time. The Controller is responsible for providing  
14 any and all records required by the U.S. Department of Treasury.

15  
16 **Section Four. Authorizing Immediate Expenditures**

17 A. The Navajo Nation Council hereby authorizes the immediate expenditure of  
18 \$50,559,530.10 from the Fund by the Health Incident Command Center, within the  
19 Department of Health, for the following purposes:

- 20 1. Personal Protective Equipment (PPE) and related items in the amount of  
21 \$8,000,000 for Navajo Nation government employees, volunteers, enterprises;
- 22 2. Food, Water and Basic Necessities care packages and related items in the  
23 amount of \$10,000,000;
- 24 3. Payroll expenses in the amount of \$5,000,000;
- 25 4. Disinfection of public areas, Government Buildings, and other Navajo Nation  
26 facilities in the amount of \$10,000,000;
- 27 5. Reconfiguring Navajo Nation offices for the safe return of Government  
28 Employees in the amount of \$10,000,000;

1           6. Computer hardware and software for Navajo Nation government offices to  
2           improve telework capabilities for Government Employees in the amount of  
3           \$2,000,000

4           7. Assistance to P.L. 93-638 healthcare facilities on the Navajo Nation in the  
5           amount of \$3,000,000, provided that if this amount is not expended or  
6           necessary then it shall be incorporated into the other categories in this section  
7           at the option of the President; and

8           8. Expenses to facilitate the procurement and/or improvement of the Navajo  
9           Nation's Financial System to process Navajo Nation CARES Fund  
10          expenditures in the amount of \$2,559,530.10.

11         B. The Office of the Controller shall assist in the budgeting and expenditure of these  
12         funds and shall be responsible for ensuring that any expenditures meet the  
13         requirements of the Coronavirus Relief Fund, Treasury Guidance and the Navajo  
14         Nation CARES Fund Act.

15         C. These immediate expenditures shall not be part of an initial expenditure plan and may  
16         be supplemented in future expenditure plans at the recommendation of the Work  
17         Group.

18         D. Failure to expend these funds by August 31, 2020, shall result in such funds being  
19         redeposited into the Navajo Nation CARES Fund.

20  
21         **Section Five. Authorizing the President to Introduce Legislation into the Legislative**  
22         **Process**

23         For the purposes set forth in this legislation, the President is authorized under 2 N.N.C. §  
24         164 (A)(1) to introduce a proposed legislation, specifically including expenditure plan  
25         legislation(s), to the Standing Committees and the Navajo Nation Council.

26  
27         **Section Six. Authorizing the Navajo Nation President to Form the Dikos Ntsaaígíí-19**  
28         **Relief Fund Work Group to Assist in Creating Expenditure Plan(s)**

29         A. The President is hereby authorized to form the Dikos Ntsaaígíí-19 Relief Fund Work  
30         Group (Work Group) and shall be comprised of four members from the Executive

1 Branch, four members from the Legislative Branch, and four members from the  
2 Judicial Branch; and may include representatives from Navajo chapters and persons  
3 who have certain expertise. The Work Group shall be tasked with creating an  
4 expenditure plan(s).

5 B. The President may appoint Federal Advisory Representatives as consulting members  
6 to the Work Group including, but not limited to, representatives from the following  
7 Federal Agencies: Bureau of Indian Affairs – Navajo Region, Indian Health Service,  
8 Bureau of Indian Education, Army Corps of Engineers, Homeland Security,  
9 Department of Energy, Federal Communications Commission, Environmental  
10 Protection Agency, and the Federal Emergency Management Agency.

11 C. The Work Group is to present an expenditure plan(s) for expending the Fund to the  
12 President within 15 days after the enactment of this legislation.

13 D. The President shall then present a final expenditure plan(s) to expend \$550,000,000,  
14 as well as future deposits in the Fund, to the Budget and Finance Committee,  
15 Naabiki'yati' Committee, and the Navajo Nation Council for approval.

16 E. The President may also submit other proposed legislation to the respective Standing  
17 Committees and Navajo Nation Council necessary to expedite the implementation of  
18 the expenditure plan.

19 F. The Office of the Controller shall produce a report within 30 days from the enactment  
20 of this legislation of total COVID-19 expenditures the Navajo Nation has spent from  
21 March 1, 2020 to date. This amount will be deducted from the remaining balance the  
22 Work Group must produce an expenditure plan for. The amount presented must  
23 qualify as an expenditure under Coronavirus Relief Fund and the U.S. Treasury  
24 Guidelines.

25 G. The Work Group term shall expire six (6) months after the enactment of the last  
26 public health emergency order and the Work Group shall prepare and present a final  
27 report to the Navajo Nation Council and the Navajo Nation President and Vice  
28 President.

1 **Section Seven. Authorizing Expenditures for Waterline, Electricity, Telecommunication**  
2 **and Other Projects to Combat Covid-19.**

3 As allowed by the Coronavirus Relief Fund and the U.S. Treasury Guidelines and/or  
4 Navajo Nation agreements with the federal government, the President may incorporate  
5 waterline, electricity, telecommunication projects and other infrastructure projects into  
6 the expenditure plan(s) using the \$550,000,000 and implement and construct such  
7 eligible projects under the authority of the Navajo Nation CARES Fund Act.  
8

9 **Section Eight. Prevailing Law; Allowing for Expedited Procurement Rules and Procedures.**

10 A. To ensure that Navajo Nation expenditures using Coronavirus Relief Funds are  
11 expended by December 31, 2020 as required by the U.S. Treasury and  
12 notwithstanding any provision of Navajo Nation law to the contrary, the provisions of  
13 this legislation shall take priority and govern the expenditure of funding from the  
14 Coronavirus Relief Fund. As determined by the Attorney General of the Navajo  
15 Nation, any contradicting financial, procurement, preference, construction, or other  
16 general laws of the Navajo Nation, as well as any attendant regulations, shall yield to  
17 the Navajo Nation CARES Fund Act so that the funds may be expended in a timely  
18 manner and purchases and construction occur in an expeditious manner.

19 B. The President may introduce legislation regarding any laws that need to be waived to  
20 accomplish the purposes of the Navajo Nation Cares Fund Act and notify the Navajo  
21 Nation Council of the measures that have been taken to mitigate the law being  
22 waived.  
23

24 **Section Nine. Effective Date**

25 This Act is effective upon its approval pursuant to 2 N.N.C. § 221(B).  
26

27 **Section Ten. Savings Clause**

28 Should any provision of the Navajo Nation CARES Fund Act ("Act") or the expenditure  
29 plan(s) thereunder be determined invalid by the Navajo Nation Supreme Court, or a  
30 District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court,

1 those portions of the Act or expenditure plan which are not determined invalid shall  
2 remain the law of the Navajo Nation.

3  
4 **Section Eleven. Directives**

5 A. The Controller, with the support of the Attorney General, is directed to enter into a  
6 contract with a firm to provide consulting services in a capacity similar to an  
7 independent inspector general or auditor general to determine whether expenditures  
8 of the CARES Act funding are in compliance with the permissible uses of the  
9 appropriated funding as set forth in the federal CARES Act, Treasury's Guidance, the  
10 Navajo Nation CARES Fund Act and the applicable Expenditure Plan; to notify the  
11 Navajo Nation division, department, program, chapter, or entity to which the  
12 appropriations are allocated if any expenditures are ineligible under the CARES Act  
13 and to provide written reports to the Naabik'iyáti' Committee and the President of the  
14 Navajo Nation of all ineligible expenditures.

15 B. Upon submission of an expenditure plan by the Office of the President and Vice  
16 President and approval by the Budget and Finance Committee, the Office of  
17 Management and Budget is directed to develop expedited budget procedures,  
18 including forms, if necessary, for the expeditious expenditure of Navajo Nation  
19 CARES Fund Act funding. Thereafter, the Office of the Controller, Department of  
20 Justice, Office of Management and Budget and Office of Legislative Counsel are  
21 directed to develop an expenditure plan template within ten (10) days of the  
22 enactment of this legislation.

maximum total compensation received by the officer or employee from the air carrier or contractor in calendar year 2019; and

(3) no officer or employee of the eligible business whose total compensation exceeded \$3,000,000 in calendar year 2019 may receive during any 12 consecutive months of such period total compensation in excess of the sum of—

(A) \$3,000,000; and

(B) 50 percent of the excess over \$3,000,000 of the total compensation received by the officer or employee from the eligible business in calendar year 2019.

(b) **TOTAL COMPENSATION DEFINED.**—In this section, the term “total compensation” includes salary, bonuses, awards of stock, and other financial benefits provided by an air carrier or contractor to an officer or employee of the air carrier or contractor.

**SEC. 4117. TAX PAYER PROTECTION.**

The Secretary may receive warrants, options, preferred stock, debt securities, notes, or other financial instruments issued by recipients of financial assistance under this subtitle which, in the sole determination of the Secretary, provide appropriate compensation to the Federal Government for the provision of the financial assistance.

**SEC. 4118. REPORTS.**

(a) **REPORT.**—Not later than November 1, 2020, the Secretary shall submit to the Committee on Transportation and Infrastructure and the Committee on Financial Services of the House of Representatives and the Committee on Commerce, Science, and Transportation and the Committee on Banking, Housing, and Urban Affairs of the Senate a report on the financial assistance provided to air carriers and contractors under this subtitle, including a description of any financial assistance provided.

(b) **UPDATE.**—Not later than the last day of the 1-year period following the date of enactment of this Act, the Secretary shall update and submit to the Committee on Transportation and Infrastructure of the House of Representatives and the Committee on Commerce, Science, and Transportation and the Committee on Banking, Housing, and Urban Affairs of the Senate the report described in subsection (a).

**SEC. 4119. COORDINATION.**

In implementing this subtitle the Secretary shall coordinate with the Secretary of Transportation.

**SEC. 4120. DIRECT APPROPRIATION.**

Notwithstanding any other provision of law, there is appropriated, out of amounts in the Treasury not otherwise appropriated, \$32,000,000,000 to carry out this subtitle.

**TITLE V—CORONAVIRUS RELIEF FUNDS**

**SEC. 5001. CORONAVIRUS RELIEF FUND.**

(a) **IN GENERAL.**—The Social Security Act (42 U.S.C. 301 et seq.) is amended by inserting after title V the following:

**“TITLE VI—CORONAVIRUS RELIEF FUND**

**“SEC. 601. CORONAVIRUS RELIEF FUND.**

“(a) **APPROPRIATION.**—

“(1) **IN GENERAL.**—Out of any money in the Treasury of the United States not otherwise appropriated, there are appropriated for making payments to States, Tribal governments, and units of local government under this section, \$150,000,000,000 for fiscal year 2020.

“(2) **RESERVATION OF FUNDS.**—Of the amount appropriated under paragraph (1), the Secretary shall reserve—

“(A) \$3,000,000,000 of such amount for making payments to the District of Columbia, the Commonwealth of Puerto Rico, the United States Virgin Islands, Guam, the Commonwealth of the Northern Mariana Islands, and American Samoa; and

“(B) \$8,000,000,000 of such amount for making payments to Tribal governments.

“(b) **AUTHORITY TO MAKE PAYMENTS.**—

“(1) **IN GENERAL.**—Subject to paragraph (2), not later than 30 days after the date of enactment of this section, the Secretary shall pay each State and Tribal government, and each unit of local government that meets the condition described in paragraph (2), the amount determined for the State, Tribal government, or unit of local government, for fiscal year 2020 under subsection (c).

“(2) **DIRECT PAYMENTS TO UNITS OF LOCAL GOVERNMENT.**—If a unit of local government of a State submits the certification required by subsection (e) for purposes of receiving a direct payment from the Secretary under the authority of this paragraph, the Secretary shall reduce the amount determined for that State by the relative unit of local government population proportion amount described in subsection (c)(5) and pay such amount directly to such unit of local government.

“(c) **PAYMENT AMOUNTS.**—

“(1) **IN GENERAL.**—Subject to paragraph (2), the amount paid under this section for fiscal year 2020 to a State that is 1 of the 50 States shall be the amount equal to the relative population proportion amount determined for the State under paragraph (3) for such fiscal year.

“(2) **MINIMUM PAYMENT.**—

“(A) **IN GENERAL.**—No State that is 1 of the 50 States shall receive a payment under this section for fiscal year 2020 that is less than \$1,250,000,000.

“(B) **PRO RATA ADJUSTMENTS.**—The Secretary shall adjust on a pro rata basis the amount of the payments for each of the 50 States determined under this subsection without regard to this subparagraph to the extent necessary to comply with the requirements of subparagraph (A).

“(3) **RELATIVE POPULATION PROPORTION AMOUNT.**—For purposes of paragraph (1), the relative population proportion amount determined under this paragraph for a State for fiscal year 2020 is the product of—

“(A) the amount appropriated under paragraph (1) of subsection (a) for fiscal year 2020 that remains after the application of paragraph (2) of that subsection; and

“(B) the relative State population proportion (as defined in paragraph (4)).

“(4) **RELATIVE STATE POPULATION PROPORTION DEFINED.**—For purposes of paragraph (3)(B), the term “relative State population proportion” means, with respect to a State, the quotient of—

“(A) the population of the State; and

“(B) the total population of all States (excluding the District of Columbia and territories specified in subsection (a)(2)(A)).

“(5) **RELATIVE UNIT OF LOCAL GOVERNMENT POPULATION PROPORTION AMOUNT.**—For purposes of subsection (b)(2), the term “relative unit of local government population proportion amount” means, with respect to a unit of local government and a State, the amount equal to the product of—

“(A) 45 percent of the amount of the payment determined for the State under this subsection (without regard to this paragraph); and

“(B) the amount equal to the quotient of—

“(i) the population of the unit of local government; and

“(ii) the total population of the State in which the unit of local government is located.

“(6) **DISTRICT OF COLUMBIA AND TERRITORIES.**—The amount paid under this section for fiscal year 2020 to a State that is the District of Columbia or a territory specified in subsection (a)(2)(A) shall be the amount equal to the product of—

“(A) the amount set aside under subsection (a)(2)(A) for such fiscal year; and

“(B) each such District’s and territory’s share of the combined total population of the District of Columbia and all such territories, as determined by the Secretary.

“(7) **TRIBAL GOVERNMENTS.**—From the amount set aside under subsection (a)(2)(B) for fiscal year 2020, the amount paid under this section for fiscal year 2020 to a Tribal government shall be the amount the Secretary shall determine, in consultation with the Secretary of the Interior and Indian Tribes, that is based on increased expenditures of each such Tribal government (or a tribally-owned entity of such Tribal government) relative to aggregate expenditures in fiscal year 2019 by the Tribal government (or tribally-owned entity) and determined in such manner as the Secretary determines appropriate to ensure that all amounts available under subsection (a)(2)(B) for fiscal year 2020 are distributed to Tribal governments.

“(8) **DATA.**—For purposes of this subsection, the population of States and units of local governments shall be determined based on the most recent year for which data are available from the Bureau of the Census.

“(d) **USE OF FUNDS.**—A State, Tribal government, and unit of local government shall use the funds provided under a payment made under this section to cover only those costs of the State, Tribal government, or unit of local government that—

“(1) are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19);

“(2) were not accounted for in the budget most recently approved as of the date of enactment of this section for the State or government; and

“(3) were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.

“(e) **CERTIFICATION.**—In order to receive a payment under this section, a unit of local government shall provide the Secretary with a certification signed by the Chief Executive for the unit of local government that the local government’s proposed uses of the funds are consistent with subsection (d).

“(f) **INSPECTOR GENERAL OVERSIGHT; RECOUPMENT.**—

“(1) **OVERSIGHT AUTHORITY.**—The Inspector General of the Department of the Treasury shall conduct monitoring and oversight of the receipt, disbursement, and use of funds made available under this section.

“(2) **RECOUPMENT.**—If the Inspector General of the Department of the Treasury determines that a State, Tribal government, or unit of local government has failed to comply with subsection (d), the amount equal to the amount of funds used in violation of such subsection shall be booked as a debt of such entity owed to the Federal Government. Amounts recovered under this subsection shall be deposited into the general fund of the Treasury.

“(3) **APPROPRIATION.**—Out of any money in the Treasury of the United States not otherwise appropriated, there are appropriated to the Office of the Inspector General of the Department of the Treasury, \$35,000,000 to carry out oversight and recoupment activities under this subsection. Amounts appropriated under the preceding sentence shall remain available until expended.

“(4) **AUTHORITY OF INSPECTOR GENERAL.**—Nothing in this subsection shall be construed to diminish the authority of any Inspector General, including such authority as provided in the Inspector General Act of 1978 (5 U.S.C. App.).

“(g) **DEFINITIONS.**—In this section:

“(1) **INDIAN TRIBE.**—The term “Indian Tribe” has the meaning given that term in section

4(e) of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 5304(e)).

“(2) LOCAL GOVERNMENT.—The term ‘unit of local government’ means a county, municipality, town, township, village, parish, borough, or other unit of general government below the State level with a population that exceeds 500,000.

“(3) SECRETARY.—The term ‘Secretary’ means the Secretary of the Treasury.

“(4) STATE.—The term ‘State’ means the 50 States, the District of Columbia, the Commonwealth of Puerto Rico, the United States Virgin Islands, Guam, the Commonwealth of the Northern Mariana Islands, and American Samoa.

“(5) TRIBAL GOVERNMENT.—The term ‘Tribal government’ means the recognized governing body of an Indian Tribe.”.

(b) APPLICATION OF PROVISIONS.—Amounts appropriated for fiscal year 2020 under section 601(a)(1) of the Social Security Act (as added by subsection (a)) shall be subject to the requirements contained in Public Law 116-94 for funds for programs authorized under sections 330 through 340 of the Public Health Service Act (42 U.S.C. 254 through 256).

**TITLE VI—MISCELLANEOUS PROVISIONS**

**SEC. 6001. COVID-19 BORROWING AUTHORITY FOR THE UNITED STATES POSTAL SERVICE.**

(a) DEFINITIONS.—In this section—

(1) the term “COVID-19 emergency” means the emergency involving Federal primary responsibility determined to exist by the President under section 501(b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5191(b)) with respect to the Coronavirus Disease 2019 (COVID-19); and

(2) the term “Postal Service” means the United States Postal Service.

(b) ADDITIONAL BORROWING AUTHORITY.—Notwithstanding section 2005 of title 39, United States Code, or any other provision of law, if the Postal Service determines that, due to the COVID-19 emergency, the Postal Service will not be able to fund operating expenses without borrowing money—

(1) the Postal Service may borrow money from the Treasury in an amount not to exceed \$10,000,000,000—

(A) to be used for such operating expenses; and

(B) which may not be used to pay any outstanding debt of the Postal Service; and

(2) the Secretary of the Treasury may lend up to the amount described in paragraph (1) at the request of the Postal Service, upon terms and conditions mutually agreed upon by the Secretary and the Postal Service.

(c) PRIORITIZATION OF DELIVERY FOR MEDICAL PURPOSES DURING COVID-19 EMERGENCY.—Notwithstanding any other provision of law, during the COVID-19 emergency, the Postal Service—

(1) shall prioritize delivery of postal products for medical purposes; and

(2) may establish temporary delivery points, in such form and manner as the Postal Service determines necessary, to protect employees of the Postal Service and individuals receiving deliveries from the Postal Service.

**SEC. 6002. EMERGENCY DESIGNATION.**

(a) IN GENERAL.—The amounts provided under this division are designated as an emergency requirement pursuant to section 4(g) of the Statutory Pay-As-You-Go Act of 2010 (2 U.S.C. 933(g)).

(b) DESIGNATION IN SENATE.—In the Senate, this division is designated as an emergency requirement pursuant to section 4112(a) of H. Con. Res. 71 (115th Congress), the concurrent resolution on the budget for fiscal year 2018.

**DIVISION B—EMERGENCY APPROPRIATIONS FOR CORONAVIRUS HEALTH RESPONSE AND AGENCY OPERATIONS**

The following sums are hereby are appropriated, out of any money in the Treasury not otherwise appropriated, for the fiscal year ending September 30, 2020, and for other purposes, namely:

**TITLE I  
AGRICULTURAL PROGRAMS  
OFFICE OF THE SECRETARY**

For an additional amount for the “Office of the Secretary”, \$9,500,000,000, to remain available until expended, to prevent, prepare for, and respond to coronavirus by providing support for agricultural producers impacted by coronavirus, including producers of specialty crops, producers that supply local food systems, including farmers markets, restaurants, and schools, and livestock producers, including dairy producers: *Provided*, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 251(b)(2)(A)(i) of the Balanced Budget and Emergency Deficit Control Act of 1985.

**OFFICE OF INSPECTOR GENERAL**

For an additional amount for “Office of Inspector General”, \$750,000, to remain available until September 30, 2021, to prevent, prepare for, and respond to coronavirus, domestically or internationally: *Provided*, That the funding made available under this heading in this Act shall be used for conducting audits and investigations of projects and activities carried out with funds made available in this Act to the Department of Agriculture to prevent, prepare for, and respond to coronavirus, domestically or internationally: *Provided further*, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 251(b)(2)(A)(i) of the Balanced Budget and Emergency Deficit Control Act of 1985.

**ANIMAL AND PLANT HEALTH INSPECTION SERVICE**

**SALARIES AND EXPENSES**

For an additional amount for “Salaries and Expenses”, \$55,000,000, to remain available until September 30, 2021, to prevent, prepare for, and respond to coronavirus, domestically or internationally, including for necessary expenses for salary costs associated with the Agriculture Quarantine and Inspection Program: *Provided*, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 251(b)(2)(A)(i) of the Balanced Budget and Emergency Deficit Control Act of 1985.

**AGRICULTURAL MARKETING SERVICE  
MARKETING SERVICES**

For an additional amount for “Marketing Services”, \$45,000,000, to remain available until September 30, 2021, to prevent, prepare for, and respond to coronavirus, domestically or internationally, including necessary expenses for salary costs associated with commodity grading, inspection, and audit activities: *Provided*, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 251(b)(2)(A)(i) of the Balanced Budget and Emergency Deficit Control Act of 1985.

**FOOD SAFETY AND INSPECTION SERVICE**

For an additional amount for “Food Safety and Inspection Service”, \$33,000,000, to remain available until September 30, 2021, to prevent, prepare for, and respond to coronavirus, domestically or internationally, including for support of temporary and intermittent workers, relocation of inspectors, and, notwithstanding 21 U.S.C. 468, 695 and 1053 and 7 U.S.C. 2219a, costs of overtime inspectors under the Federal Meat Inspec-

tion Act, the Poultry Products Inspection Act, and the Egg Products Inspection Act: *Provided*, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 251(b)(2)(A)(i) of the Balanced Budget and Emergency Deficit Control Act of 1985.

**FARM PRODUCTION AND CONSERVATION PROGRAMS**

**FARM SERVICE AGENCY**

For an additional amount for “Salaries and Expenses”, \$3,000,000, to remain available until September 30, 2021, to prevent, prepare for, and respond to coronavirus, domestically or internationally, including necessary expenses to hire temporary staff and overtime expenses: *Provided*, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 251(b)(2)(A)(i) of the Balanced Budget and Emergency Deficit Control Act of 1985.

**RURAL DEVELOPMENT PROGRAMS**

**RURAL BUSINESS—COOPERATIVE SERVICE**

**RURAL BUSINESS PROGRAM ACCOUNT**

For an additional amount for “Rural Business Program Account”, \$20,500,000, to remain available until September 30, 2021, to prevent, prepare for, and respond to coronavirus, for the cost of loans for rural business development programs authorized by section 310B and described in subsection (g) of section 310B of the Consolidated Farm and Rural Development Act: *Provided*, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 251(b)(2)(A)(i) of the Balanced Budget and Emergency Deficit Control Act of 1985.

**RURAL UTILITIES SERVICE**

**DISTANCE LEARNING, TELEMEDICINE, AND BROADBAND PROGRAM**

For an additional amount for “Distance Learning, Telemedicine, and Broadband Program”, \$25,000,000, to remain available until expended, to prevent, prepare for, and respond to coronavirus, domestically or internationally, for telemedicine and distance learning services in rural areas, as authorized by 7 U.S.C. 950aaa et seq.: *Provided*, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 251(b)(2)(A)(i) of the Balanced Budget and Emergency Deficit Control Act of 1985.

**DOMESTIC FOOD PROGRAMS**

**FOOD AND NUTRITION SERVICE**

**CHILD NUTRITION PROGRAMS**

For an additional amount for “Child Nutrition Programs”, \$8,800,000,000 to remain available until September 30, 2021, to prevent, prepare for, and respond to coronavirus, domestically or internationally: *Provided*, That such amount is designated by the Congress as being for an emergency requirement pursuant to section 251(b)(2)(A)(i) of the Balanced Budget and Emergency Deficit Control Act of 1985.

**SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM**

For an additional amount for “Supplemental Nutrition Assistance Program”, \$15,810,000,000, to remain available until September 30, 2021, to prevent, prepare for, and respond to coronavirus, domestically or internationally: *Provided*, That of the amount provided under this heading in this Act, \$15,510,000,000 shall be placed in a contingency reserve to be allocated as the Secretary deems necessary to support participation should cost or participation exceed budget estimates to prevent, prepare for, and respond to coronavirus: *Provided further*, That of the amount provided under this

**Coronavirus Relief Fund  
Guidance for State, Territorial, Local, and Tribal Governments  
April 22, 2020**

The purpose of this document is to provide guidance to recipients of the funding available under section 601(a) of the Social Security Act, as added by section 5001 of the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”). The CARES Act established the Coronavirus Relief Fund (the “Fund”) and appropriated \$150 billion to the Fund. Under the CARES Act, the Fund is to be used to make payments for specified uses to States and certain local governments; the District of Columbia and U.S. Territories (consisting of the Commonwealth of Puerto Rico, the United States Virgin Islands, Guam, American Samoa, and the Commonwealth of the Northern Mariana Islands); and Tribal governments.

The CARES Act provides that payments from the Fund may only be used to cover costs that—

1. are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19);
2. were not accounted for in the budget most recently approved as of March 27, 2020 (the date of enactment of the CARES Act) for the State or government; and
3. were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.<sup>1</sup>

The guidance that follows sets forth the Department of the Treasury’s interpretation of these limitations on the permissible use of Fund payments.

***Necessary expenditures incurred due to the public health emergency***

The requirement that expenditures be incurred “due to” the public health emergency means that expenditures must be used for actions taken to respond to the public health emergency. These may include expenditures incurred to allow the State, territorial, local, or Tribal government to respond directly to the emergency, such as by addressing medical or public health needs, as well as expenditures incurred to respond to second-order effects of the emergency, such as by providing economic support to those suffering from employment or business interruptions due to COVID-19-related business closures.

Funds may not be used to fill shortfalls in government revenue to cover expenditures that would not otherwise qualify under the statute. Although a broad range of uses is allowed, revenue replacement is not a permissible use of Fund payments.

The statute also specifies that expenditures using Fund payments must be “necessary.” The Department of the Treasury understands this term broadly to mean that the expenditure is reasonably necessary for its intended use in the reasonable judgment of the government officials responsible for spending Fund payments.

***Costs not accounted for in the budget most recently approved as of March 27, 2020***

The CARES Act also requires that payments be used only to cover costs that were not accounted for in the budget most recently approved as of March 27, 2020. A cost meets this requirement if either (a) the cost cannot lawfully be funded using a line item, allotment, or allocation within that budget *or* (b) the cost

is for a substantially different use from any expected use of funds in such a line item, allotment, or allocation.

The “most recently approved” budget refers to the enacted budget for the relevant fiscal period for the particular government, without taking into account subsequent supplemental appropriations enacted or other budgetary adjustments made by that government in response to the COVID-19 public health emergency. A cost is not considered to have been accounted for in a budget merely because it could be met using a budgetary stabilization fund, rainy day fund, or similar reserve account.

***Costs incurred during the period that begins on March 1, 2020, and ends on December 30, 2020***

A cost is “incurred” when the responsible unit of government has expended funds to cover the cost.

***Nonexclusive examples of eligible expenditures***

Eligible expenditures include, but are not limited to, payment for:

1. Medical expenses such as:
  - COVID-19-related expenses of public hospitals, clinics, and similar facilities.
  - Expenses of establishing temporary public medical facilities and other measures to increase COVID-19 treatment capacity, including related construction costs.
  - Costs of providing COVID-19 testing, including serological testing.
  - Emergency medical response expenses, including emergency medical transportation, related to COVID-19.
  - Expenses for establishing and operating public telemedicine capabilities for COVID-19-related treatment.
2. Public health expenses such as:
  - Expenses for communication and enforcement by State, territorial, local, and Tribal governments of public health orders related to COVID-19.
  - Expenses for acquisition and distribution of medical and protective supplies, including sanitizing products and personal protective equipment, for medical personnel, police officers, social workers, child protection services, and child welfare officers, direct service providers for older adults and individuals with disabilities in community settings, and other public health or safety workers in connection with the COVID-19 public health emergency.
  - Expenses for disinfection of public areas and other facilities, *e.g.*, nursing homes, in response to the COVID-19 public health emergency.
  - Expenses for technical assistance to local authorities or other entities on mitigation of COVID-19-related threats to public health and safety.
  - Expenses for public safety measures undertaken in response to COVID-19.
  - Expenses for quarantining individuals.
3. Payroll expenses for public safety, public health, health care, human services, and similar employees whose services are substantially dedicated to mitigating or responding to the COVID-19 public health emergency.

4. Expenses of actions to facilitate compliance with COVID-19-related public health measures, such as:
  - Expenses for food delivery to residents, including, for example, senior citizens and other vulnerable populations, to enable compliance with COVID-19 public health precautions.
  - Expenses to facilitate distance learning, including technological improvements, in connection with school closings to enable compliance with COVID-19 precautions.
  - Expenses to improve telework capabilities for public employees to enable compliance with COVID-19 public health precautions.
  - Expenses of providing paid sick and paid family and medical leave to public employees to enable compliance with COVID-19 public health precautions.
  - COVID-19-related expenses of maintaining state prisons and county jails, including as relates to sanitation and improvement of social distancing measures, to enable compliance with COVID-19 public health precautions.
  - Expenses for care for homeless populations provided to mitigate COVID-19 effects and enable compliance with COVID-19 public health precautions.
5. Expenses associated with the provision of economic support in connection with the COVID-19 public health emergency, such as:
  - Expenditures related to the provision of grants to small businesses to reimburse the costs of business interruption caused by required closures.
  - Expenditures related to a State, territorial, local, or Tribal government payroll support program.
  - Unemployment insurance costs related to the COVID-19 public health emergency if such costs will not be reimbursed by the federal government pursuant to the CARES Act or otherwise.
6. Any other COVID-19-related expenses reasonably necessary to the function of government that satisfy the Fund's eligibility criteria.

*Nonexclusive examples of ineligible expenditures<sup>2</sup>*

The following is a list of examples of costs that would *not* be eligible expenditures of payments from the Fund.


1. Expenses for the State share of Medicaid.<sup>3</sup>
2. Damages covered by insurance.
3. Payroll or benefits expenses for employees whose work duties are not substantially dedicated to mitigating or responding to the COVID-19 public health emergency.

The prohibition on payment for abortions does not apply to an abortion if the pregnancy is the result of an act of rape or incest; or in the case where a woman suffers from a physical disorder, physical injury, or physical illness, including a life-endangering physical condition caused by or arising from the pregnancy itself, that would, as certified by a physician, place the woman in danger of death unless an abortion is performed. Furthermore, no government which receives payments from the Fund may discriminate against a health care entity on the basis that the entity does not provide, pay for, provide coverage of, or refer for abortions.



4. Expenses that have been or will be reimbursed under any federal program, such as the reimbursement by the federal government pursuant to the CARES Act of contributions by States to State unemployment funds.
5. Reimbursement to donors for donated items or services.
6. Workforce bonuses other than hazard pay or overtime.
7. Severance pay.
8. Legal settlements.

I have prepared the above-referenced proposed resolution and associated legislative summary sheet pursuant to your request for legislative drafting. As with any action of government however, it can be subject to review by the courts in the event of proper challenge.

The Office of Legislative Counsel confirms the appropriate standing committee(s) based on the standing committees powers outlined in 2 N.N.C. §§301, 401, 501, 601 and 701. Nevertheless, "the Speaker of the Navajo Nation Council shall introduce [the proposed resolution] into the legislative process by assigning it to the respective oversight committee(s) of the Navajo Nation Council having authority over the matters for proper consideration." 2 N.N.C. §164(A)(5).

Please ensure that his particular resolution request is precisely what you want. You are encouraged to review the proposed resolution to ensure that it is drafted to your satisfaction.



**Goal:** Reduce new COVID-19 infections rate to no new positive cases per day for at least 30 consecutive days (and no more than 10 per month there after); and to address recurrence of illness during seasonal changes. Plan for immediate and long term essential needs and infrastructure for NN families, and to address child education and social welfare needs of all families, and to address the mental health needs around the anxiety, stress, fear, trauma and grief of this challenging time in our shared history. Encourage the Navajo Way of Life to be reinstated in this process to address and heal from this pandemic.

**Objectives**

Through legislation, designate funds for infrastructure development and remediation for the following actions:

- 1) Through drones and helicopters, NN will continue immediate delivery of essential items to families of Navajo Nation (food, water, propane, firewood, livestock feed/care supplies, cleaning supplies, propane/solar powered refrigeration and washing machines (U.S. Census to be done concurrently); and
- 2) Infrastructure development, water wells, water line installation, home site lease approvals w/financial support for arch. site clearance and land plat surveys for families living in multi-family homes, families with ADA needs, veterans, young children, etc.; and
- 3) Infrastructure and Long term health planning to build permanent clinics/hospitals on Navajo Nation for COVID-19 quarantine, treatment and recovery. Long term health planning to address food desert designation by requesting local families/farmers to start/restart farming and to support and request for NAPI in using/planting additional field plots for predicted world-wide food shortages which may adversely affect the Navajo Nation population; and
- 4) Support and/or planning of commercial food stores to build retail stores on Navajo Nation. Begin plans to create solar/wind power equipment/manufacturing and begin plans to develop/reinstitute barter system in case of world economic collapse.
- 5) Revisit and assess existing services to children and families, enhance or remediate services to support ‘mental health’ healing from pandemic. Ensure existing supervisors are not endangering staff and clients (Division of Social Services, Division of Health, Dept. of Dine Education, school systems, health care systems, etc.) Ensure each child is receiving an education remotely with access to internet/computer. Develop plan based on assessment to improve services with a mental health framework to support staff/programs to improve their services through a best practice called Infant and Early Childhood Mental Health Consultation (IECMHC). Current DoDE, NNOSERS program has a grant to support the build out of this type of mental health framework to support programs/staff on the Navajo Nation to better support families.

The outbreak of coronavirus COVID-19, a fatal respiratory virus has effected all walks of life among the Navajo people from young to old on the Navajo reservation. Our people have suffered tremendously socially and economically thus far with limited resources to care for their loved one, especially the education of our children. It has been reported by health experts that this contagious virus will continue to effect people into the winter season and beyond.

A public health state of emergency has been declared by the Navajo Nation President and Vice President in March 2020, with written resolutions and declarations for the Navajo people to "Shelter in Place", stay at home order went into effect right away. Our children have been behind closed door thus far, some with telecommunications network are able to telework with their teachers to continue with their education. Many are left in the dark those without internet, telework equipment and telework capabilities.

As a teacher for more than 30 years, I strongly request for part of the Navajo Nation Cares Fund Act to incorporate into your plan towards telecommunications projects to purchase computer hardware and software to improve telework capabilities for all schools on the Navajo reservation. Improving telecommunications capabilities will also help save lives of our people to acquire a speedy contact resource to get help for those that are ill from this contagious disease.

I write in support of Legislation NO. 0116-20 sponsored by Council Delegate Edmund Yazzie to put forth a comprehensive plan to use the \$600 million in CARES Act funding that addresses the needs of the Navajo People, but more importantly to plan for future pandemics.

As an enrolled member of the Navajo Nation tribe I have a number of recommendations. First and foremost, I appreciate the efforts that appointed leaders have taken to address the current pandemic that has stricken our great Navajo Nation. Immediate and reactive action has resulted in the purchase and delivery of bottled water, canned goods, sanitary-cleaning products, and personal protective equipment. These items have been beneficial in providing Navajo Nation tribal members with basic necessities, but only momentarily. Bottled water, canned goods, and sanitary-cleaning products cannot be purchased and delivered for every future pandemic that occurs within the Navajo Nation. Consequently, the \$600 million that Navajo Nation has been allocated needs to be utilized to create sustainable infrastructure. The Center for Disease Control emphasizes the importance of practicing personal hygiene in all aspects; however a lack of indoor-plumbing within most Navajo Nation families makes this recommendation near impossible. For instance, I live approximately 9 miles from the Navajo Nation capital in Window Rock, AZ but myself and many other residents within the Summit-Defiance Plateau area do not have indoor-plumbing and have not had indoor-plumbing for well over 20+ years. Unfortunately, this is a common circumstance for a number of families that reside within the Navajo Nation.

The Navajo Nation greatly lacks access to grocery stores and convenient stores to fulfill the needs of its current population of 200,000 tribal members during this pandemic. The establishment of more grocery stores and convenient stores within Navajo Nation communities will eliminate the need for tribal members to utilize services outside of the reservation, consequently reducing the exposure risk-level to illnesses off-the-reservation. In addition, investments in the establishment of retail and grocery stores will allow the Navajo Nation to be "self-sustaining" by generating internal revenue.

To conclude, above are two prime examples in which the Navajo Nation can utilize the \$600 million CARES Act allocated funds to ensure that the Nation is prepared in addressing the current and future pandemics so that no more lives are lost due to limited access to basic necessities we each need as Diné people.

The proposed funding for cleaning tribal administrative buildings, paying staff, and laptops should be eliminated and paid from other tribal monies.

The Cares Act is for the people.

Of all the news I've seen very little is reported of the Nation helping their own. We are too dependent on outside sources and our government should serve their people.

The Navajo people are in need of food and the government should distribute food twice a week until stores have adequate inventory. This will also help keep people at home since many are driving around searching for food and buying fast food to survive. The people need disinfecting materials and cleaning products immediately. The people need masks, gloves and face shields.

The schools are closed and it is uncertain when they will reopen. The Nation needs to purchase chrome books, educational material and WiFi (hotspots) for virtual learning to take place.

Direct payments of \$1200 should be distributed to registered voters to help with necessities and bills. Many of our people are entrepreneurs and they can't sell jewelry or food. Many people don't have jobs to pay their bills.

Business licensing procedures should be streamlined to develop additional grocery stores and franchises. The Navajo people need to be self-sufficient. We can't depend on the government which only enables us further.

The Navajo Nation should provide improved health care by hiring additional professional and caring personnel to assist those that are isolated or home bound due to covid.

The high risk individuals should also be provided additional care so there is no need for them to travel; including food, water, masks, face shields, medicine and home health care by CHR's.

The Tribe has to look at the short term for now and have a vision for the future. We have to have a vision for ourselves and the future generation, or our Nation will perish not only through lives but our children leaving this depressed area with very little hope of ever returning.

**Requesting The Navajo Nation Council to designate \$45 Million for the Manymules Waterline Project from the \$600 Million Navajo COVID CARE Direct Appropriation Fund**

**WHEREAS:**

1. Pursuant to the provisions of the Navajo Nation Corporation Code, Black Mesa United-Dzilíjiin Bee Ahóta' (BMU-DzBA) Incorporated is granted authority to transact business on the Navajo Nation (NN); and,
2. Pursuant to the Arizona Corporation Commission, BMU-DzBA Incorporated is approved as a tax-exempt Arizona Non-Profit Corporation whom is organized exclusively for charitable and educational purposes under Section 501(1)(3) of the Internal Revenue Code; and,
3. Pursuant to BMU-DzBA Inc. Articles of Incorporation, the purpose of the organization is to serve as the primary resource for Navajos living within the Peabody Western Coal Company (PWCC) leasehold area who may have been adversely affected by coal mining operations; and,
4. The Navajo Aquifer, a pristine confined groundwater aquifer, is the source water for the Manymules Waterline Project; and,
5. Since 2011, the Manymules Waterline Project has been on a timeline and has made significant progress working with Indian Health Service, The Navajo Nation, PWCC, Navajo Tribal Utility Authority (NTUA), Black Mesa United, Black Mesa Review Board, and Abandoned Mine Lands to complete environmental clearances, design and construction, matching funds, and infrastructure contributions, and household involvement; and,
6. Upon completion of the Manymules Waterline Project, it will be transferred to NTUA for maintenance and operation; and,
7. PWCC impacted funds supported the completion of Manymules Waterline Project Phase 1 and supported the cost for water infrastructure in phase 2, however, infrastructure funds are still needed to complete the Manymules Waterline Project Phases 3, 4, and 5; and,

8. On May 18, 2020, The Navajo Department of Health in coordination with the Navajo Epidemiology Center and the Navajo Area Indian Health Service reported the total number of positive COVID-19 cases for the Navajo Nation reached 4,071, total number of deaths of 142; and,
9. On May 18, 2020, Chinle Navajo IHS area had the highest number of COVID-19 cases with a count of 981 cases and Kayenta Navajo IHS area had a count of 643 cases; and,
10. Black Mesa is part of two Navajo Indian Health Service (IHS) Area COVID-19 hotspots including Chinle and Kayenta IHS area; and,
11. The Navajo Nation Office of the Controller notified the Office of the Speaker on Wednesday May 6, 2020 that the Navajo Nation has received \$600 Million in federal CARES Act funding for coronavirus relief efforts; and,
12. Navajo Nation Council will now begin accepting public comments and input by Navajo citizens about the specific needs and uses of \$600 Million COVID-19 relief funding; and,
13. Black Mesa is one of the most rural areas across the Navajo Nation with a history of coal mining activity that spans over 60 years; and,
14. The completion of the Manymules Waterline Project will bring water to nearly 200 homes across Black Mesa allowing Navajo residents to follow CDC guidelines of washing hands for 20 seconds to protect themselves from COVID-19; and,
15. Nearly 10 years and approximately \$16 Million have already been invested in the Manymules Waterline Project; and,
16. 100% of Navajo residents living within the Peabody Western Coal Company Leasehold Area do not have running water and increases risk to COVID-19 infection; and,
17. Many residents within the PWCC Leasehold area have underlying health conditions (black lung disease, lung cancer, asthma, other respiratory issues, stomach cancer, and other types of cancer) due to being subjected to 60 years of coal mining operations including air and water pollution; and,
18. Black Mesa residents lack access to drinking water and forces PWCC residents to haul water at the public drinking water location at Black Mesa which is used by many people outside of the PWCC and makes PWCC leasehold residents susceptible to COVID-19 infection; and,
19. Phase 1 of the Manymules Waterline Project is completed which includes water infrastructure and requires homeowners training before water can be turned on, however training is postponed due to Navajo COVID-19 stay-at-home order; and,
20. Cost for the water infrastructure for Phase 2 of the Manymules Waterline Project is secured and construction can begin with once the home assessments are cleared, however, cost for kitchen/bathroom additions were not included; and,

21. Completion of Phase 3-5 which has been in planning for nearly a decade allows water infrastructure across Black Mesa which will provide running water and decreases risk for COVID-19 infection for hundreds of Navajo residents living across Black Mesa.

**NOW THEREFORE BE IT RESOLVED THAT:**

The Navajo Nation Council to designate \$45 Million for FY 2020 for the Manymules Waterline Project, Phases 3-5 from the CARE funds.



I'm an enrolled member of the Navajo Nation. I moved away after I graduated from high school because I knew there was no options for me on the reservation. Today and many years later, I realize I escaped a covid-19 fate That's occurring right now, and I'm so sad and upset at the lack of preparation and misguided decisions by the NN leadership, President, Vice President, and chapter officials. Much reported in the news is about how elected officials steal from the tribal members! How could you steal from the Navajo people, elders, children, and Meanwhile look at the state of the Navajo Nation Today! How could you lead this nation year after year and there's no progress for the elders, and the children? The reservation is exactly as I left it, maybe worse!

I read the proposed legislation and I recommend the funds DO NOT GO TO THE CHAPTERS AND THE SWINDLING CHAPTER OFFICIALS. The stories about disgraced chapter officials stealing money is The legacy they left elders, citizens of the Navajo Nation. Why would you ever think to funnel money through them is the right way to help people?

In my own life, I'm a university professor, and I serve my Native Americans population, and I believe the students and youth deserve the money and the chance to live a better life than what's happening in the reservation currently! This past spring semester my students left back to the reservation and went to the epicenter of the pandemic, meanwhile they didn't have internet to complete their online classes. Many quit. Many had no support from their tribes. Many will not be retained and my job at the tribal college is to educate and empower the next generation of Native American students, meanwhile these students come not college ready, poorly prepared for college especially in math and English, and the added stress of not having internet, in the 21st century mind you, added to their struggles! Because the Navajo Nation does not have internet and the infrastructure, educating Native American students is impossible! And if there's no education, they will succumb to the social ills currently going on the reservation. By not having internet and the infrastructure, your administration is Surely delaying, and quite possibly ending their shot at a college education and a life that's better than what's happening on the reservation!

My Navajo students should have running water and electricity so they can receive an online education! They should be able to wash up and make it to online classes. How could my students receive an online education without electricity? Laptops, cellphones, printers all require internet!

This Nez and Lizer Administration prayed and acted with religion, but realists and scientists and doctors know you can't pray this disease and poverty out. Stop praying, close the churches, and lock down the people until it's safe!

The Dine' peoples are human beings! My students are human beings! They don't deserve unanswered prayers! They don't deserve stolen funds and mismanaged monies by chapter officials and administrators!

Human beings deserve homes, which there are none, and this is why the covid has consumed Dine' peoples! Human beings deserve water! All Dine' deserve water to live! Not survive! Thrive and live! Human beings deserve electricity!

My students deserve these things for themselves and their families, and it's a shame this administration has not made progress on these necessary human rights For them and ALL DINE' PEOPLES IN —HOMES, WATER, ELECTRICITY, INTERNET, and medical care for them!!!!!!!

My students are struggling by your lack of progress, and the NN President and Vice President and tribal council and officials have put out a plan to include those who don't serve Dine' peoples but themselves, with money that should reach all Dine peoples to attain safe, healthy, normal living Conditions and hopefully create lives that match the rest of America!

Without these necessary human needs Met for Dine' peoples, you're not serving Dine' Peoples but only yourselves! This is lack of progress; not progress!

I also feel very strongly against how this administration DID NOT SHUT DOWN CHURCHES and therefore caused much of the spread at the beginning of the pandemic.

I lived 18 years on the reservation, and it didn't take long For me to know that this pandemic would consume the Dine' peoples! I'm not even a current citizen yet I knew that lack of water, lack of grocery stores, lack of housing, electricity, internet, food, wealth, would all end up in catastrophe!

I recommend the funds and legislation be used only one these matters:

Internet

Running water for citizens

Electricity

Grocery stores

Medical equipment, supplies

Hazard pay for law enforcement and medical professionals!!!!!!!!!!



I am sending an email in response to Legislation No. 0116-20.

I would like to bring to light my experience in dealing with the Navajo Nation, the Nahata Dziil Chapter and the Navajo Nation Community Development Department. My project for a waterline extension has been with IHS since the early 1990's, that's over 20 years ago; the original application was made on behalf of my mom and my aunt. It's gone through cycles of "no funding", "it'll be in the budget next year", "we do not have the staff to construct", etc. It is now ready to be constructed but NTUA has no information on where the connection should be, there is NO coordination between the agencies. My family has an approved Residential Lease from BIA, it's been surveyed, studied and researched. I've gone through all the proper channels to get assistance; I got a motion to approve a resolution from the Nahata Dziil Chapter in 2016. They have not made any attempt to honor their resolution for a powerline extension. I've spent countless hours contacting various Navajo Nation agencies, including my chapter. I have had no success in getting on the Sihasin project list because my chapter of Nahata Dziil did not recommend it (after they supported it with a resolution). The chapter chose a pet project instead and completely ignored a family in need. My family (parents and brother (Veteran, recently deceased)) have lived without power and without running water for some time; they also were snowed in this winter without any water due to extremely muddy roads. At what point will the Navajo Nation actually begin to see the desperate need for basic infrastructure by the Navajo people? The recognition of the need should have happened well before this virus. I would like to state my sole reason for sending an email in support; "HOPE". I hope my parent's project gets picked, I hope they get running water, I hope they get electricity. They live less than half a mile from running water and electricity. 

**WHEREAS:**


1. Pursuant to the Navajo Nation Council Resolution Number CAP-34-98 and the "Local Governance Act", 26 N.N.C., Chapter 1, Subchapter 1, Section 3(a), the Mariano Lake Chapter is a certified local chapter of the Navajo Nation Government; and
2. Pursuant to Local Governance Act", 26 N.N.C., Chapter 1, Sub-chapter 1, Section 131 (1) (2), the Mariano Lake Chapter has the responsibility and authority to promote, protect, and preserve the interest and general welfare including the safety of its community people; and
3. In 2005, the Mariano Lake Chapter (the Chapter) received governance certification on its Community Land Use Plan in accordance with Title 26 of the Navajo Nation laws; and
4. The United States Congress on March 27, 2020 enacted the *Coronavirus Aid, Relief, and Economic Security Act (CARES Act)* – under Title V of the *CARES Act*, the *Coronavirus Relief Fund* set aside \$8 billion in emergency aid for Tribal governments for the COVID-19 pandemic; and
5. The Navajo Nation's share of sixty percent (60%) of the \$8 billion distributed by the Treasury Department to local and tribal governments on May 5, 2020 was six hundred million five hundred fifty-nine thousand five hundred thirty dollars and ten cents (\$600,559,530.10); and
6. The CARES Act provides the Coronavirus Relief Fund shall be used to cover only those costs that;
  - a. are necessary expenditures incurred due to the public health emergency with respect to COVID-19,
  - b. were not accounted for in the Tribal budget most recently approved as of March 27, 2020,
  - c. are incurred from March 1, 2020 through December 30, 2020; and
7. The citizens of Mariano Lake have determined the necessary expenditures due to the COVID-19 public health emergency and present the attached Mariano Lake Chapter Navajo Cares Fund Expenditure Plan (Exhibit A), with the Waterline Projects Summaries (Exhibit B), and the Multipurpose Building Justification (Exhibit C).

Justification Summary:

Justification to expend a portion of the \$600 Million CARES ACT FUND to build the multipurpose building for the community of Mariano Lake within the vicinity of Mariano Lake Chapter, Navajo Nation. Mariano Lake Chapter performed extensive activities to plan and replace the outdated Chapter House Building and administration which is annexed to the Chapter House.

In our community assessment and planning for a new facility, the majority of the community members agreed to a multi-purpose type building to provide more proficient services to all members. The building will serve under one roof the Senior Citizens, Veterans and the children who are enrolled in public, community/private schools and post-secondary schools.

The current pandemic situation on the Navajo Nation and the entire United States is only one reason why this multi-purpose building is so important. Firstly, it will provide immediate health and nutritional needs to all the citizens but more importantly to the senior citizens, who otherwise, have to travel many miles to existing services. Secondly, the educational delivery has been affected by this unforeseen epidemic and the multi-purpose building will be equipped with electronic and telecommunication systems to allow our children to access their assignments and continue their education without disruption. Thirdly, the multi-purpose building will provide an opportunity for the Veterans to receive the services they are in need of or desire. Finally, the building will be more proficient and affordable to operate, and will be equipped to include other forms of operational needs using solar, wind and traditional electricity to make it more economically affordable.

Ya' at'eeh President Nez:

It is an honor and spellbind to offer recommendations for the use of six million dollars (\$600 M) of the federal government awarded funds to the Navajo Nation for use in Coronavius-19 services, programs and projects.

The global pandemic coronavis-19 is severely affected the lives of the Navajo people and it has disrupted total Navajo Nation economic status. In that, there is unknown end to the pandemic coronavirus-19, so we need to carefully prepare ourselves and our home for long term threat to our lives and livelihood.

## RECOMMENDATIONS

A. Establish Navajo Nation Emergency Preparedness Operation Center: To establish Navajo Nation emergency preparedness requirements to ensure adequate planning for both natural and man-made disasters, and coordination with federal, state and local emergency preparedness systems. Use the basic public health and emergency management strategic planning techniques that would best services the Navajo Nation peoples.

I. Fund 100 % the Navajo Nation Emergency Preparedness Operation Center. Hire fulltime qualified Director who will have full management authority to:

1) Implement effective Communication: Use of traditional Navajo cultural relevant language which is most effective way to communicate with Navajo people than the Nav-lish language (mixing Navajo language with English language and vise verse). Nav-lish language is a joke to most Navajo.

2) Establish Coordination network with local communities: Establish emergency management center in each Navajo Government Agency area, and the Agency Command Center to network with the chapters' government emergency respond group.

3) Establish cooperation network with the local resources: Establish cooperative agreements with major public services on the Navajo Nation for emergency services for the people on the Navajo Nation.

4) Establish collaboration network with the various governments: Establish collaboration networks with counties, state and federal governments for the emergency assistance with vital resources.

The Emergency Preparedness Center must operate in professional manner which include the documentations, statistical data, accountability of all resources, and should be absolute free of politics. It needs to operate with utmost public safety interest.

B. Navajo Community Health Service Programs: Fund the Community Health Services Program with additional staff and training. The Navajo Nation Community Health Representatives (CHR) have done more goods, with minimum resources, in maintaining the well-being of the people and communities. Make the CHR Program a credited specialize training at Navajo

Technical University (NTU) and Dine' College (DC). It would be an exemplary Navajo Nation Human Resource Development Program for development of the skills and professional manpower.

C. Revitalization of Navajo Farm and Range land: Fund the Navajo Nation Agricultural and Farm Conservation Program. The Navajo have survived worse disasters in the past by use of the land to feed themselves. There are hundreds of prime farm and range land wasting away in Navajo communities. Navajo Nation need to revitalize the use of the land for economic production. The Navajo colleges (NTU and DC) use to offer agriculture and livestock training program, but for some reason the program ceased. Shiprock Navajo Irrigation System is outdated for modern farm operation practices, such as use of sprinkle system. The Navajo range land has been neglected so much that the uncontrolled erosions is destroying the grazing land, and open rangeland is invitation to over grazing. Put a qualification for Farm Board, Grazing Committee and Land Board membership and make it appointed position rather than elect the position and deputize as enforcement officer. Also, to institute land use fee, like Eastern Agency Land Use Permit, which individual permittee' pay separate annual grazing fee for trust land, and allotted, state and federal land. With the grazing fee fund establish Grazing Land Trust Fund and use the trust fund interest for leverage with outside fund for conservation projects.

D. Youth Centers: Fund Navajo Youth Centers. There are more than 20,000 young Navajo children on the Navajo Nation, yet there are only few youth centers, one center for each agency. Every youth center is under staff with amateur personnel. The main activities of the youth centers are basketball games, no creativities. The Youth Center facilities are poorly equipped, lack of transport, inadequate funding for operation and extra curriculum activities for underprivileged youth. Yet, Navajo Nation leaders claims, "Our Navajo youth are our future leaders". In that, let's invest some of the Cares Act fund into our youth as part of human resource development program.

E. Navajo Nation Economic Development Program: Sell the Navajo fried bread and mutton stew to international tourists. Invest some of the Cares Act fund to conduct the feasibility study of the Navajo Nation economic development system. Base on the feasibility study plan the business develop infrastructure carter to the Navajo and other business enterprises. The Navajo Nation to invest into the Navajo business infrastructure with business loan, commercial and professional facilities, adequate utilities, safe and secure accessible environment.

F. Community Infrastructure Development Programs. Over one half (1/2) of Shiprock town community is still use firewood to health the home. There are homes without electric connection. Other large towns on the Navajo Nation share experiences with Shiprock community. In smaller community, such as Tse' Daa Kaan community, an elderly woman (widow) is without running water in her house. She must haul water in several gallon bottles in small red wagon, about three (3) miles from her granddaughter's house. The Navajo Tribal Utility Authority (NTUA) head Quarter is in the mid of the Shiprock town and 15 miles from Tse' Daa Kaan Community. When Environmental Health Services of Indian Health Service install water line to in a person's resident, it takes more than three (3) years for NTUA to install water meter and turn on the water at the price of more than the poor person's monthly general assistance amount. It is similar with electric connection. In 2016 Navajo Northern Agency Veterans Administration built a house for disabled veteran (DAV). The DAV requested NTUA for connecting electricity to his new house. NTUA quota DAV \$5,000.00 for electric connection. The electric line is adjacent to DAV's new home. Fortunately, a retired electrician volunteered, who was still licensed, did connected the electricity to DAV's house. NTUA did approved the work and install the meter. The Navajo Nation need to invest Cares Act fund on community water, electric and natural gas infrastructure. The Nation needs to bid out all of the infrastructure projects to maximize cost efficient on infrastructure.

G. Navajo Veterans Services: Invest some of the Cares Act fund into the Veterans infrastructure service facilities. The most able young Navajos have served in U.S. military services, either draftees or volunteers, to defend the democratic of the free world. Many of the Navajo veterans have been traumatized while serving in the wars or just being exposed to harsh treatment while going through military training. Northern Agency Navajo Veterans Administration have secured \$200,000.00 of the NM state fund for planning and designing the multipurpose veterans center in Shiprock community. The veterans center needs seed construction funds. Veterans Center is needed to implement multiply veterans' services and treatment, socializing and training. The multipurpose facility will generate employment and economic development opportunities.

The planning for the use of the six million dollars (\$600.0 M) Cares Act Fund is for the benefits of the Navajo people. The three-branch government of the Navajo Nation need to work in cooperative manner, and not to use the CARES ACT fund as politic weapon against each other. The use of the CARES ACT fund needs to be planned

and use it wisely to get the maximum benefit out of it.
