#### AN ACTION

RELATING TO THE NAABIK'ÍYÁTI COMMITTEE; CONFIRMING THE APPOINTMENT OF ROBERT WINTER TO THE NAVAJO NATION GAMING ENTERPRISE BOARD OF DIRECTORS FOR A FOUR YEAR TERM

# SECTION ONE. AUTHORITY

- A. The Navajo Nation Gaming Enterprise (Enterprise) Board of Directors (Board) are subject to confirmation by the Naabik'íyáti Committee. 5 N.N.C. § 1707(C). See also CO-72-18.
- B. The Navajo Nation Council has legislative oversight over the Enterprise. 5 N.N.C. § 1718.

#### SECTION TWO. FINDINGS

- A. Pursuant to 5 N.N.C. § 1707(C), the President of the Navajo Nation shall select Board members; President Russell Begaye selected Robert Winter to the Navajo Nation Gaming Enterprise Board of Directors. Mr. Winter's appointment letter is attached as Exhibit A.
- B. The Board shall consist of nine members and at least five members shall be enrolled members of the Navajo Nation. 5 N.N.C. §§ 1707(B) and 1707(D). See also CO-72-18.
- At all times the nominees and the Directors shall possess the C. following qualifications: (1) shall have demonstrable knowledge of Class II and Class III gaming operations and work experience in the gaming industry; (2) shall be at least 25 years of age; (3) shall possess a bachelors and/or graduate degree, preferably in finance, accounting, marketing, economics, management, law or related fields; (4) shall have a minimum of seven (7) years mid-level management experience; preferred experience will take into account 12 years of midlevel or executive experience; (5) not be a board member of a Navajo Nation-owned corporation, enterprise or authority; and (6) shall not be a public official or public employee of the Navajo Nation. 5 N.N.C. § 1707(G). See also CO-72-18. Mr. Winter's letter of interest and résumé are attached as Exhibits B and C.
- D. Each appointee for the position of the Board of the Enterprise shall obtain a Gaming Facility Operator's License from the

Gaming Regulatory Office before submission of the appointment to the Naabik'iyáti Committee for confirmation. Mr. Winter has submitted his application to the Navajo Gaming Regulatory Office ("NGRO") for a temporary tribal license which is required per 5 N.N.C. § 1707(H). The Arizona Department of Gaming ("ADG") has issued a temporary certification. The NGRO temporary tribal license will be attached as **Exhibit D** and the ADG temporary certification is attached as **Exhibit E**.

E. A Board member selected to fill a vacancy shall serve the remaining term of his or her predecessor. Mr. Winter's appointment term is for a four-year staggered term beginning December 24, 2018 and ending December 24, 2022 per Exhibit A. He shall hold office until the qualification and selection of his successor. 5 N.N.C. §§ 1707(I) and 1707(F).

# SECTION THREE. CONFIRMING APPOINTMENT

Pursuant to 5 N.N.C. § 1707(C), the Navajo Nation hereby confirms the appointment of Robert Winter to serve on the Navajo Nation Gaming Enterprise Board of Directors, for a four-year staggered term beginning December 24, 2018 and ending December 24, 2022.

Twenty five years experience as an executive and corporate manager, in gaming, governmental, and private sectors. Selected to act as Chairman and member of government and judicial committees as well.

  located on the Reservation in Arizona and New Mexico including Class III and Class II gaming
  operations.
- Vice President/ General Counsel and member of the management team of the Foxwoods Resort and Casino/Hotel for six years. Assisted in operations management, reviewed and negotiated significant contracts pertaining to the billion dollar construction and operation of the Resort.
