PURPOSE: An action related to the Naabik'iyati' Committee and Navajo Nation Council; confirming the Navajo Nation Presidential appointment of Mr. Zane James, to the Commission on Navajo Government Development, to serve a term of four (4) years upon confirmation by the Navajo Nation Council.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

APPOINTMENT OF MR. ZANE JAMES, TO THE COMMISSION ON NAVAJO
GOVERNMENT DEVELOPMENT, TO SERVE A TERM OF FOUR (4) YEARS

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Naabik'iyati' Committee has legislative oversight authority over the Commission on Navajo Government Development and the Office of Navajo Government Development. 2 N.N.C. § 970.
- B. The Navajo Nation established the Naabik'iyati' Committee as a Navajo Nation Council standing committee and as such empowered Naabik'iyati' Committee to recommend all resolutions to the Navajo Nation Council on matters within the Committee's jurisdiction pursuant to 2 N.N.C. § 701 (A)(3).
- C. The Navajo Nation Council confirms appointments to the Commission on Navajo Government Development. 2 N.N.C. § 972 (A)(5).

SECTION TWO. FINDINGS

- A. The Commission on Navajo Government Development is a special entity created by the Navajo Nation Council with quasi-independent authority to accomplish the

2 responsible government. 2 N.N.C. § 970.

3 B. The Commission consists of twelve (12) members confirmed by and serving at the
4 pleasure of the Navajo Nation Council. 2 N.N.C. § 972 (A).

5 C. One (1) member shall be nominated by the Executive Branch through the President of
6 the Navajo Nation to serve a term of four (4) years from the date of confirmation by
7 the Navajo Nation Council. 2 N.N.C. § 972 (A)(1).

8 D. Commission members shall be chosen from among individuals who have demonstrated
9 scholarship, a strong sense of civic interest, knowledge of Dine' history and cultural
10 heritage, spiritual leadership, leadership in the Navajo government and abilities likely
11 to contribute to the fulfillment of the duties of the commission. 2 N.N.C. § 972 (D).

12 E. Mr. Zane James has been appointed by Navajo Nation President, Jonathan Nez, to
13 fulfill the Executive Branch appointment. *See* letter dated May 13, 2021 attached as
14 **Exhibit A**. Mr. James' letter of interest and resume are attached as **Exhibit B**.

16 **SECTION THREE. CONFIRMATION**

17 The Navajo Nation Council hereby confirms the Navajo Nation Presidential appointment
18 of Mr. Zane James, to the Commission on Navajo Government Development, to serve a
19 term of four (4) years from the date of confirmation by the Navajo Nation Council.

Coordinated meetings between the Navajo Nation President/Vice President and Centene Corporation executives to develop a professional relationship. Assist and prepare Centene employees in developing strategies for building relationship with the Navajo Nation and other Native American tribes.

Community Outreach Patient Empowerment

July 2015 – September 2018

Serve as a consultant working with Navajo Community Health Outreach serving as a leadership coach for select Navajo Nation youth. Assist in developing monthly gathering agenda and topics of discussions along with promoting and addressing the health disparities of the Navajo Nation. Mentor youth leaders as they prepare for presentations to organization outside of the Navajo Nation such as the National Council Teachers of English, La Casa Roja, National Indian Health Board and working with Navajo Nation tribal organizations. Provide reports and updates to Navajo Nation oversight committees and Navajo Nation Departments. Championed a presentation to the youth leaders in the leadership roles of Navajo young males in society.

New Mexico Appleseed

September 2015 – June 2015

Served as a consultant working on a Federal Grant that was awarded to the Navajo Nation and New Mexico Appleseed was contracted to provide technical assistance in administering the grant. The federal grant was to establish a Food Access Navigator network identifying food insecurities on the New Mexico portion of the Navajo Nation. Coordinated and worked with the Navajo Nation Chapters in New Mexico to identify potential storage locations for access to health foods such as schools, senior centers, chapter houses, etc. Additionally worked in promoting and advocating for a Breakfast After The Bell program to be initiated in Navajo Nation schools in addressing the food insecurities of the Navajo Nation. Worked with the Navajo Nation Department of Health in the implementation of the grant and provided technical assistance training to the food access navigators that was hired through the grant.

Navajo Nation Office of the President/Vice President

January 2012 – May 2015

Served as an executive staff assistant to the Vice President of the Navajo Nation. Tasked with all Navajo Nation issues pertaining to Health and Education. Assisted the Vice President with outlining priorities and execution of goals and objectives for the Navajo Nation, specifically in the areas of health and education. Coordinated and



championed a movement of the development of the Navajo Nation Department of Health by bringing together stakeholders of Health of the Navajo Nation that included the Indian Health Service facilities, 638 Health facilities, health clinics on the Navajo Nation, Navajo traditional medicine men organizations, non-emergency medical transportation groups and others to discuss and develop policies for the development of the Navajo Department of Health to operate similar to a state department of health. Coordinated this effort and accomplished this task by the passage of the establishment of the Department of Health. Worked to promote Navajo health issues and develop and implement solution in addressing the disparities of the health on the Navajo Nation. Assisted the Navajo Nation in national organizations such as the National Indian Health Board, Secretaries Tribal Advisory Committee, National Council of Teachers English, the United Nations and other work pertaining to advancing the interests of the Navajo Nation.

Navajo Nation Division of Transportation

June 2006 – January 2012

Coordinated with Navajo Nation communities on prioritizing local road projects for funding through the Fuel Excise Tax. Worked with Navajo Nation oversight committees to give reports on the status of the funding and completion of projects. Worked with the New Mexico State Tribal Infrastructure Program funding from the state legislature to advocate for cost sharing on road projects. Recommended and implemented changes to the Navajo Nation Fuel Excise Tax program legislation to ensure a comprehensive approach to the funding criteria. Attended Navajo Nation Agency Council meetings to provide updates on the status or road projects. Worked with Navajo Nation chapter to gain support of goals and objectives of the Navajo Nation Division of Transportation. Assisted in the elevation of the Navajo Department of Transportation to a cabinet level Navajo Division of Transportation through public forums and community outreach to the Navajo Nation.

New Mexico Office of the Secretary of State

January 2002 – January 2006

Worked as a Navajo interpreter for the Secretary of States office where I translated county, state, federal election documents into the Navajo language in compliance with the Federal Voting Rights Act. Coordinated with 6 counties in New Mexico that are under consent decrees with the Department of Justice to provide voter outreach to Native American Communities in New Mexico, specifically worked with over 50 Navajo Nation chapters, 2 Apache tribes, and 19 Pueblos to provide voter outreach and ensure Native American populations were advised of voting rights. Assisted in the development of a Navajo election terminology that translated election terminology into the Navajo language to ensure consistency. As a result of the 2002 Help America Vote Act passed by the United States Congress, interpreted a full election ballot into the Navajo language to assist Navajo language speakers to vote on voting machines without assistance.

Navajo Nation Office of the Chief Prosecutor

January 2000 – January 2002

Worked with the Navajo Nation Office of Chief Prosecutor and the United States Department of Justice, Juvenile Justice Delinquency Program to implement an adjudication program on the Navajo Nation for Navajo Nation Youth who were in violation of victimless crimes. Worked with the Navajo Nation legislative council in developing and revising criminal code to allow for the adjudication program. Coordinated an effort of stakeholders that included faith based organizations, Navajo traditional medicine men, tribal courts, tribal departments in the development of the Hoozhoji Youth Diversion Program that addressed truancy, and other victimless crimes on the Navajo Nation for Navajo Nation youth under the age of 18.

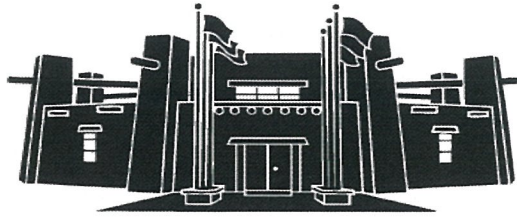



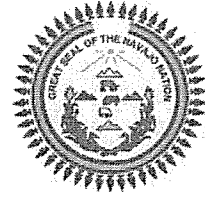
