25	A. Pursuant to 6 N.N.C. § 6	502 (A), The Navajo Nation established a public body of

- alteration or repair operation of low income dwellings; and promote economic growth and development activities within and near the Navajo Nation. *See* 6 N.N.C. § 604 (A)-(D).
- B. The affairs of the Authority shall be managed by a Board composed of eight persons. See 6 N.N.C. § 605.
- C. The Commissioner shall be a member of the Navajo Nation. See 6 N.N.C. § 606 (B).
- D. There shall be one representative on the Board from each of the five agencies comprising the Navajo Nation. See 6 N.N.C. § 606 (B).
- E. These individuals shall have some formal education or at least three years of leadership experience in a local unit of government. See 6 N.N.C. § 606 (B).
- F. The term of office shall be four years and staggered. When a Board is first established, one member's term shall be designated to expire in one year, another to expire in two years, a third to expire in three years, and the last two in four years. Thereafter, all appointments shall be for four years. See 6 N.N.C. § 607.
- G. Mr. Lee V. Bigwater has expressed his interest in being appointed to the Navajo Housing Authority Board of Commissioners to represent the Chinle Agency. *See* Exhibit A (Letter of Interest).
- H. Mr. Lee V. Bigwater is an enrolled member of the Navajo Nation. *See* Exhibit B (Certificate Indian Blood); *See also* 6 N.N.C. § 606 (B).
- I. Mr. Lee V. Bigwater satisfies the education and three years of leadership experience working with various government offices on the Navajo Nation. *See* Exhibit C (Resume); *See also* 6 N.N.C. § 606 (B).
- J. The Chinle Agency Council and Nazlini Chapter Government recommend Mr. Lee V. Bigwater to represent the Chinle Agency. See Exhibit D & E (Resolution of the Chinle Agency Council; Resolution of the Nazlini Chapter Government); See also 6 N.N.C. § 606 (B).
- K. The appointment of Mr. Lee V. Bigwater shall be for a term of four years. See 6 N.N.C. § 607

SECTION THREE. CONFIRMING APPOINTMENT

Pursuant to 6 N.N.C. 606 (B), the Navajo Nation hereby confirms the appointment of Mr. Lee V. Bigwater to serve on the Navajo Housing Authority Board of Commissioners as a representative for the Chinle Agency for a term of four years.

This letter is to justify my interest for the Chinle Agency Navajo Housing Authority Board Member. I am full Navajo, born and raised in Canyon DeChelly and I possess a fluent understanding of the Navajo language. I have immense knowledge of area socioeconomic, natural environment, way of life and future chapter initiatives to enhance public welfare. My interest is to help the chapter progress into a population of opportunity. I'm in good standing with the Navajo Nation and recently retired employment from the Navajo Nation Transit.

As former Navajo Transit Director, former Navajo DOT Director and former Federal Highway Administration TTAP Program Director, I have gain supervisory administrative experience. Here is a summary of attributes that will complement and assist to the NHA Board responsibilities:

- Wrote grant proposals and submitted to Federal Transit Administration, Utah Department of Transportation, Arizona Department of Transportation and New Mexico Department of Transportation for funding.
- Directed and managed a considerable sum of operating funds; managed a complex administrative structure, staffed with professional and highly technical personnel engaged in scientific, regulatory, or policy development with programs of diverse and multiple levels of supervisory controls; and made decision on impact of all aspects of the agency.

Therefore, I submit this Letter of Interest for your consideration to be part of Navajo Housing Authority Board. Thank you for your time and action.




