This legislation allows for the one-time payout of excess accrued annual leave that was earned and carried over during the years 2021 (Resolution No. HEHSCJA-01-22) and 2022 (Resolution No. HEHSD-12-22). This one-time payout recognizes the hard work of employees who prioritized their work for the Navajo Nation during the COVID-19 pandemic. There is no token of appreciation large enough to thank our employees who worked tirelessly during the COVID-19 pandemic. I thank the employees who are receiving payout for their excess annual leave from the years 2021 and 2022 for their service to the Navajo Nation and the Navajo People.

The Navajo Nation continues to heal from the pandemic, and I hope this payout of excess annual leave helps the Navajo Nation continue to move forward.

AN ACTION

RELATING TO THE BUDGET AND FINANCE, HEALTH, EDUCATION AND HUMAN SERVICES, AND NAABIK'ÍYÁTI' COMMITTEES, AND TO THE NAVAJO NATION COUNCIL; WAIVING SECTION X (B) (1) (e) OF THE NAVAJO NATION PERSONNEL POLICIES MANUAL; APPROVING \$3,535,773 FROM THE UNRESERVED, UNDESIGNATED FUND BALANCE TO THE OFFICE OF THE CONTROLLER FOR THE PAYOUT OF EXCESS ANNUAL LEAVE TO ALL EXECUTIVE BRANCH AND LEGISLATIVE BRANCH EMPLOYEES

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee ("BFC") is a standing committee of the Navajo Nation Council with the authority to review and recommend to the Navajo Nation Council the management of all funds. 2 N.N.C. § 300(A), and § 301(B) (2).
- B. The Health, Education and Human Services Committee ("HEHSC") is a standing committee of the Navajo Nation Council. 2 N.N.C. § 401(A). HEHSC is the oversight for the Division of Human Resources with the authority to implement, amend, and ensure compliance with, Navajo Nation employment laws and policies, including leave policies for Navajo Nation employees. 2 N.N.C. §§ 401(B) (1), 401(C) (1), and 401(C) (3).
- C. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council with the delegated responsibility to hear proposed legislation requiring final action by the Navajo Nation Council. 2 N.N.C. § 164(A) (9) and § 700(A).
- D. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102(A). As such, the Council ". . . may adopt and approve supplemental appropriations to the Annual Comprehensive Budget during the fiscal year. Supplemental appropriations of General Funds within the current fiscal year are permitted, if and when additional sources of revenues above and beyond the initial or current revenue projections are projected and which are also in excess of the reserve amount set forth at § 820(J)." 12 N.N.C. § 820(L).
- E. Title 12 of the Navajo Nation Code places additional restrictions on supplemental appropriations from the Unreserved, Undesignated Fund Balance ("UUFB"), including:

1. Payment of recurring government operating expenses shall be from recurring revenues, and payment of nonrecurring expenses shall be from nonrecurring revenues such as UUFB funds. 12 N.N.C. § 820(E); 12 N.N.C. § 820(F).
2. Specifically, the UUFB shall not be used for recurring government expenditures or operations. 12 N.N.C. § 820(J); 12 N.N.C. § 820(L).
3. Nonrecurring revenues such as UUFB funds may be used only after the Controller determines whether or not such revenues are subsidizing an imbalance between the Navajo Nation's recurring revenues and expenditures, and government expenditures shall only be authorized if a long-term (3-year to 5-year) forecast shows that the operating deficit will not continue; otherwise, nonrecurring revenues will be added to the UUFB. 12 N.N.C. § 820(F).
4. The above provisions in Title 12 may be amended or waived by a two-thirds vote of the full membership of the Navajo Nation Council. 12 N.N.C. § 820(F); 12 N.N.C. § 880.
5. Pursuant to 12 N.N.C. § 820(F), all UUFB funding requests must be reviewed by the Controller. The Controller ensures compliance with all provisions of 12 N.N.C. § 820(L).
6. Pursuant to 12 N.N.C. § 820(M) all UUFB funding requests must be submitted to the Office of Management and Budget ("OMB") for a budget impact analysis.

SECTION TWO. FINDINGS

- A. The Navajo Nation Personnel Policies Manual ("PPM"), as amended, was approved on June 3, 2020 by the Health, Education and Human Services Committee in Resolution No. HEHSCJN-08-20. The PPM sets forth the rights, benefits, and duties expected of Executive and Legislative Branch employees. PPM, Section I(A). The PPM applies to all employees of the Executive and Legislative Branches of the Navajo Nation government, regardless of funding source or employment status. PPM, Section I(B).
- B. The PPM may be amended from time to time by the Health, Education and Human Services Committee at the recommendation of the Division of Human Resources, which includes the Department of Personnel Management. PPM Section I(D).
- C. Section X(B)(1)(e) of the PPM states:

X. LEAVE ADMINISTRATION

B. Paid Leave

1. Annual Leave

e. Carryover

At the end of each leave year, all hours in excess of 320 hours shall be forfeited. Forfeited hours shall not be paid.

- D. The Coronavirus ("COVID-19") attacked the Navajo Nation in early 2020 and has since resulted in 87,075 confirmed cases and 2,224 deaths. In response to the COVID-19 attack, the Emergency Management Commission issued a Public Health State of Emergency for the Navajo Nation (CEM-20-03-11) on March 11, 2020.
- E. Due to the demands of responding to the COVID-19 pandemic and continuing to provide services to a devastated populace, including recovery services and projects, many Navajo Nation employees were not and are not able to utilize the annual leave hours that they have earned. The Health, Education and Human Services Committee was very concerned that many Navajo Nation employees would be losing hundreds of their earned annual leave hours. In response, HEHSC passed resolutions HEHSCJA-01-22 and HEHSCD-12-22, attached as **Exhibits A and B**, allowing employees to carry over all of their unused accrued annual leave for calendar years 2021 and 2022.
- F. The carryover of accrued annual leave for 2021 and 2022 is set to expire at the end of the 2023 employee leave year, i.e., the last 2023 pay period ending on January 12, 2024. At that time, Executive and Legislative Branch employees will forfeit and lose hundreds of hours of annual leave that they have duly earned. The forfeiture of duly earned leave will be unconscionable during this unprecedeted time of hardship.
- G. Recovery from the COVID-19 pandemic is still affecting communities throughout the Navajo Nation and stressing the government's continued provision of desperately needed services, particularly first responder and community/public

health services. Staffing shortages prevent Navajo Nation employees from utilizing their accrued annual leave to manage their own health and recovery and that of their family members. Those employees with the most leave hours subject to loss are the first responders and community/public health employees who have not been able to use their annual leave hours due to severe staffing shortages which are out of their control, as well as such employee's dedication to providing vital services to the Navajo populace.

- H. The Navajo Nation Department of Personnel Management has provided a breakdown, attached as **Exhibit C**, of the estimated accrued annual leave subject to forfeiture after the last 2023 leave year, pay period ending on January 12, 2024, by Executive and Legislative Branch employees paid through General Funds and/or external funding. The Judicial Branch is not included as the Judicial Branch Personnel Policies do not include or require forfeiture of accrued annual leave.
- I. The budget forms for the Supplemental Appropriation from the Undesignated Unreserved Fund Balance are attached as **Exhibit D**.
- J. The Controller has provided a memorandum, as required by 12 N.N.C. § 820(L). The Controller has identified the proposed one-time payout of excess accrued annual leave expenditures as nonrecurring. **Exhibit E**.
- K. The Office of Management and Budget has provided a budget impact statement required by 12 N.N.C. § 820(M). **Exhibit F**.
- L. HEHSC Resolution No. HEHSCD-12-22 specifically states that "[a]fter December 31, 2023 annual leave accrued by an employee in excess of 320 hours shall then be forfeited, unless a further carryover is approved by the Health, Education and Human Services Committee or the Navajo Nation Council." For purposes of employee well-being, morale, retention, and appreciation, the Navajo Nation Council finds that it is in the best interests of the Navajo Nation to waive Section X (B) (1) (e) of the Navajo Nation Personnel Policies Manual to provide all Executive and Legislative Branch employees with a one-time payout of their accrued annual leave in excess of three hundred twenty (320) hours as of the last 2023 leave year pay period ending January 12, 2024.

SECTION THREE. WAIVING SECTION X (B) (1) (e) OF THE NAVAJO NATION PERSONNEL POLICIES MANUAL

- A. The Navajo Nation hereby waives Section X (B) (1) (e) of the Navajo Nation Personnel Policies Manual as necessary to provide Executive and Legislative Branch employees with a one-time payout of their accrued annual leave in excess of three hundred twenty (320) hours as of the end of the 2023 leave year pay period ending January 12, 2024.
- B. The Navajo Nation hereby approves the carryover of 2023 annual leave by an employee in excess of 320 hours if necessary to provide Executive and Legislative Branch employees with a one-time payout of their accrued annual leave in excess of three hundred twenty (320) hours as of the end of the 2023 leave year, pay period ending January 12, 2024.

SECTION FOUR. APPROVING \$3,535,773 FROM THE UNRESERVED UNDESIGNATED FUND BALANCE TO THE OFFICE OF THE CONTROLLER

- A. The Navajo Nation hereby approves three million five hundred thirty-five thousand seven hundred seventy-three dollars (\$3,535,773) from the Unreserved, Undesignated Fund Balance ("UUFB") to the Navajo Nation Office of the Controller for the purpose of making a one-time payout of accrued annual leave in excess of 320 hours to Executive and Legislative Branch employees funded through General Funds and/or external funds, as set forth in Exhibits C and D.
- B. Pursuant to 12 N.N.C. § 820(J), the approved \$3,535,773 shall be from that amount of funds that exceeds the 10% minimum fund balance of the UUFB, as determined by the Office of the Controller.
- C. The Office of the Controller and Department of Personnel Management shall collectively ensure that all eligible employees receive payout of their excess annual leave by no later than the end of the second quarter of FY 2024, unless otherwise extended by the Budget and Finance Committee.
- D. After consultation with the Office of Management and Budget and Department of Personnel Management, the Office of the Controller is authorized to administratively transfer funds between accounts as necessary to execute the requirements and purposes of this supplemental appropriation.
- D. Pursuant to 2 N.N.C. § 820(N), approved UUFB funds not expended or encumbered by the end of the current fiscal year lapse and revert to the General Fund.

SECTION FIVE. EFFECTIVE DATE

This Action shall become effective at the end of the 2023 leave year, pay period ending January 12, 2024, and as provided in 2 N.N.C. § 221(B) and 2 N.N.C. § 164(A)(17).

SECTION SIX. SAVING CLAUSE

If any provision of this Action is determined invalid by the Navajo Nation Supreme Court or a District Court of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, the remainder of this Action shall remain the law of the Navajo Nation.

SECTION SEVEN. DIRECTIVES

The Office of the Controller and Department of Personnel Management shall issue guidance to the Office of the President & Vice-President and Office of the Speaker of the Navajo Nation Council, by no later than January 31, 2024, on any program information necessary to implement the one-time payment of excess annual leave to Executive and Legislative Branch employees.

RELATING TO HEALTH, EDUCATION AND HUMAN SERVICES; APPROVING A ONE-TIME WAIVER OF THE NAVAJO NATION PERSONNEL POLICIES MANUAL, SECTION X (B) (1) (e), TO ALLOW EMPLOYEES TO CARRY OVER ALL OF THEIR 2021 ACCRUED ANNUAL LEAVE FOR ONE CALENDAR YEAR UNTIL DECEMBER 31, 2022

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. §400(A)
- B. The Health, Education and Human Services Committee is the oversight for the Division of Human Resources with the authority to implement and ensure compliance with Navajo Nation employment laws and policies. 2 N.N.C. §§401(A) and (C)(1) and (C)(3).
- C. The Health, Education and Human Services Committee has the enumerated powers to establish Navajo Nation policy, and to promulgate rules and regulations governing the Navajo Nation's human services. 2 N.N.C. §401(B)(1).

SECTION TWO. FINDINGS

- A. The Navajo Nation Personnel Policies Manual is designed to assist supervisors in handling human resources issues in a fair and consistent manner, and to outline the rights, benefits, and duties expected of Executive and Legislative Branch employees. Navajo Nation Personnel Policies Manual, § I (A) (June 3, 2020). The Navajo Nation Personnel Policies Manual applies to all employees of the Executive and Legislative Branches of the Navajo Nation government, regardless of funding source or employment status. Navajo Nation Personnel Policies Manual, § I(B) (June 3, 2020).

- B. The Navajo Nation Personnel Policies Manual (June 3, 2020) may be amended from time to time by the Health, Education and Human Services Committee at the recommendation of the Division of Human Resources, which include the Department of Personnel Management and the divisions of the Executive Branch and Legislative Branch. Navajo Nation Personnel Policies Manual, § I (D) (June 3, 2020).
- C. The Navajo Nation Personnel Policies Manual, § X (B)(1)(e) states:

X. LEAVE ADMINISTRATION

...
B. Paid Leave

...
1. Annual Leave

...
e. Carryover

At the end of each leave year, all hours in excess of 320 hours shall be forfeited. Forfeited hours shall not be paid.

- D. The Health, Education and Human Services Committee of the Navajo Nation Council is concerned that many Navajo Nation Employees will be losing hundreds of their earned annual leave hours on December 31, 2021. Currently the COVID-19 pandemic is still rampant throughout the Navajo Nation, and Navajo Nation employees may need their accrued leave for their own health and their families, and the forfeiture of paid leave would be unconscionable during this unprecedeted time of health and financial hardships.
- E. The Health, Education and Human Services Committee of the Navajo Nation Council therefore finds it necessary to waive the Navajo Nation Personnel Policies Manual, §X(B)(1)(e), to allow employees to carry over all of their 2021 accrued annual leave for one calendar year until December 31, 2022.

SECTION THREE. APPROVAL OF A ONE-TIME WAIVER OF THE NAVAJO NATION PERSONNEL POLICIES MANUAL

The Health, Education and Human Services Committee of the Navajo Nation Council hereby approves a one-time waiver of the Navajo Nation Personnel Policies Manual, Section X(B)(1)(e), to allow employees to carry over all of their 2021 accrued annual leave for one calendar year until December 31, 2022. After December 31, 2022 annual leave accrued by an employee in excess of 320 hours shall then be forfeited, unless a further carryover is approved by the Health, Education, and Human Services Committee or the Navajo Nation Council.

SECTION FOUR. EFFECTIVE DATE

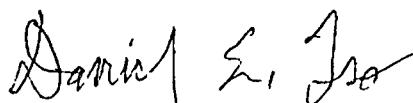

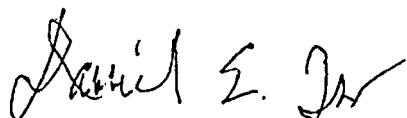

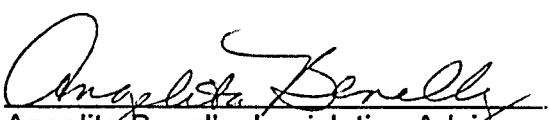

The Health, Education and Human Services Committee is the oversight for the Division of Human Resources with the authority to implement, amend, and ensure compliance with, Navajo Nation employment laws and policies, including leave policies for the Navajo Nation employees. 2 N.N.C. § 401(A), § 401(B)(1), § 401(C)(1), and § 401(C)(3).

SECTION TWO. FINDINGS

- A. The Navajo Nation Personnel Policies Manual ("PPM"), as amended, was approved on June 3, 2020 by the Health, Education & Human Services Committee in Resolution No. HEHSCJN-08-20. The PPM set forth the rights, benefits, and duties expected of Executive and Legislative Branch employees. PPM, Section I(A). The PPM applies to all employees of the Executive and Legislative Branches of the Navajo Nation government, regardless of funding source or employment status. PPM, Section I(B).

- D. At this time, the Health, Education and Human Services Committee of the Navajo Nation Council is very concerned that many Navajo Nation employees will be losing hundreds of their earned annual leave hours on December 31, 2022, pursuant to this PPM provision.
- E. Currently the COVID-19 pandemic is still affecting communities throughout the Navajo Nation, and it is likely that many Navajo Nation employees will need their accrued annual leave to manage their own health and that of their family members. In addition, those employees with the most leave hours subject to loss are the most hard-working employees who have used their annual leave hours sparingly because they have been dedicated to managing their work loads. Thus, the forfeiture of paid leave would be unconscionable during this unprecedented time of hardship.
- F. The Health, Education and Human Services Committee of the Navajo Nation Council finds it in the best interest of the Navajo Nation and its employees to waive Section X(B)(1)(e) of the PPM to allow employees to carry over all of their 2022 accrued annual leave for one calendar year until December 31, 2023.

SECTION THREE. APPROVAL OF A ONE-TIME WAIVER OF THE NAVAJO NATION PERSONNEL POLICIES MANUAL

- A. The Health, Education and Human Services Committee of the Navajo Nation Council hereby approves a one-time waiver of Section X(B)(1)(e) of the Navajo Nation Personnel Policies Manual to allow employees to carry over all of their 2022 accrued annual leave for one calendar year until December 31, 2023.

- B. After December 31, 2023 annual leave accrued by an employee in excess of 320 hours shall then be forfeited, unless a further carryover is approved by the Health, Education, and Human Services Committee or the Navajo Nation Council.
