#### Abstract

PURPOSE: Approving an amendment to Resolution RDCAP-007-19 which approved a grant of Right-of-Way to Jemez Mountain Electric Cooperative, Inc., for the Beyale Camp 14.4 kV electric powerline project on, over and across Navajo Nation Trust Lands in Nageezi Chapter vicinity, San Juan County, New Mexico. Jemez Mountain Electric Cooperative, Inc., requests a $100 \%$ waiver of the assessed consideration of $\$ 24,763.64$.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

## Section One. Authority

Pursuant to 2 N.N.C. Section $§ 501(B)(2)$, the Resources and Development Committee of the Navajo Nation Council has the authority to grant final approval for all land withdrawals, non-mineral leases, permits, licenses, rights-of-way, surface easements and bonding requirements on Navajo Nation lands and unrestricted (fee) land. This authority shall include subleases, modifications, assignments, leasehold encumbrances, transfers, renewals, and terminations.

## Section Two. Findings

A. Resources and Development Committee Resolution RDCAP-007-19 approved a grant of right-of-way to the Jemez Mountain Electric Cooperative, Inc., for the

Beyale Camp 14.4 kV Electric Powerline Project on, over and across Navajo Nation Trust Lands in Nageezi Chapter vicinity, San Juan County, New Mexico. RDCAP-007-19 is attached as Exhibit A (without attachments).
B. Resources and Development Committee Resolution RDCD-97-18 limited the amount of a waiver of consideration to no more than $50 \%$ for utility companies. Pursuant to RDCD-97-19, RDCAP-007-19 waived $\$ 12,381.82$ which is half of the assessed consideration of $\$ 24,763.64$.
C. The Jemez Mountain Electric Cooperative, Inc., requests an amendment of Resolution RDCAP-007-19 authorizing a $100 \%$ waiver of the assessed consideration of $\$ 24,763.64$.

## Section Three. Approval

A. The Resources and Development Committee of the Navajo Nation Council hereby amends Resolution RDCAP-007-19 SECTION THREE as follows:
"B. The Resources and Development Committee of the Navajo Nation Council hereby waives valuation and waives compensation of $\$ 12,381.82$, $100 \%$ (one hundred percent) of the assessed $\$ 24,763.64$ for the right-ofway project because it has determined that accepting the agreed-upon compensation and waiving valuation is in the best interest of the Navajo Nation pursuant to Title 25 CFR § 169.110.
B. The Resources and Development Committee of the Navajo Nation Council hereby authorizes the President of the Navajo Nation to execute any and all documents necessary to affect the intent and purpose of this resolution.

TO CONSTRUCT, OPERATE AND MAINTAIN THE BEYALE CAMP 14.4 KV SINGLE PHASE POWERLINE PROJECT LOCATED ON NAVAJO NATION TRUST LANDS IN NAGEEZI CHAPTER, NAVAJO NATION (SAN JUAN COUNTY, NEW MEXICO)


## BE IT ENACTED:

## SECTION ONE. AUTHORITY

Pursuant to 2 N.N.C. S 500 (B) (2), the Resources and Development Committee of the Navajo Nation Council has the authority to grant final appraval for all land withdrawals, non-mineral leases, permits, licenses, fight-of-way, surface easements and bonding requirements on Navajo Nation lands and unrestricted (Eee) land. This authority shall include subleases, modifications, assignments, leasehold encumbrances, transfers, renewals, and terminations.

## SECTION TWO. FINDINGS

A. The Jemez Mountain Electric Cooperative, Inc., P.O. Box 128 , Espanola, New Mexico 87532, has submitted a right-of-way application, to construct, operate and maintain the Beyale Camp 14.4 kV electric powerline on, over and across Navajo Nation Trust lands in Nageezi Chapter (San Juan County, New Mexico), attached as Exhibit C.
B. The proposed right-of-way is described in Exhibit B.
C. The Land Board Member of the Nageezi Chapter, District 19, has issued a memorandum dated April 17, 2017, Exhibit D, stating that "there is no grazing permit issued for Navajo Trust land located in [the proposed project area]."
D. $25 \mathrm{CFR} \$ 169.110$ addresses how much monetary compensation must be paid for a right-of-way over or across tribal land. It states: (a) A right-of-way over or across tribal landmay allow for any payment amount negotiated by the tribe, and we
will defer to the tribe and not require a valuation if the tribe submits a tribal authorization expressly stating that it:
(1) Has agreed upon compensation satisfactory to the tribe;
(2) Waives valuationi and
(3) Has determined that accepting such agreed-upon compensation and waiving valuation is in its best interest.
(b) The tribe may request, in writing, that we determine fair market value, in which case we will use a valuation in accordance with $\$ 169.114$. After providing the tribe with the fair market value, we will defer to a tribe's decision to allow for any compensation negotiated by the tribe.
(c) If the conditions in paragraph (a) and (b) of this section are not met, we will require that the grantee pay fair market value based on a valuation in accordance with \$ 169.114.
E. $25 \mathrm{CFR} \$ 169.103$ address bond, insurance or alternative forms of security. It states: (a) You must include payment of bonds, insurance, or alternative forms of security with your application for a right-of-way in amounts that cover:
(1) The highest annual rental specified in the grant, unless compensation is a one-time payment;
(2) The estimated damages resulting from the construction of any permanent improvements;
(3) The estimated damages and zemediation costs from any potential release of contaminants, explosives, hazardous material or waste;
(4) The operation and maintenance charges for any land located within an irrigation project;
(5) The restoration of the premises to their condition at the start of the right-of-way or reclamation to some other specified condition if agreed to by the landowners.
(f) We may waive the requirement for a bond, insurance, or alternative form of security:
****
(2) For tribal land, deferring, to the maximum extent possible, to the tribe's determination that a waiver of a bond, insurance or alternative form of security is in its best interest.
E. The Resources and Development Committee, through resolution number RDCD-97-18, limited the amount of a waiver of
compensation to no more than $50 \%$ that will be allowed for utility companies requesting a waiver of compensation.
G. The environmental and archaeological studies have been completed and are attached hereto as Exhibit E.
H. The application for the Right-of-way has been reviewed by the Eish and Wildlife; Historic Preservation; Minerals; Navajo Nation Environmental Protection; Division of Natural Resources and the Department of Justice and "Approved" or found "Sufficient". See documents included in Executive Official Review Document Number 009706, Exhibit F.

## SECTION THREE. APPROVAL

A. The Resources and Development Committee of the Navajo Nation Council hereby approves the grant of right-of-way to Jemez Mountain Electric Cooperative, Inc., to construct, operate and maintain the Beyale Camp 14.4 kV electric powerline on, over and across Navajo Nation Trust Lands in Nageezi Chapter (San Juar County, New Mexico), the location is more particularly described on the survey map attached as Exhibit B.
B. The Resources and Development Committee of the Navajo Nation Council hereby waives valuation and waives compensation of $\$ 12,381.82$ of the assessed $\$ 24,763.64$ for the right-of-way project because it has determined that accepting the agreedupon compensation and waiving valuation is in its best interest of the Navajo Nation, pursuant to Title 25 CFR S 169.110.
C. The Resources and Development Committee of the Navajo Nation Council hereby waives the requirement for a bond, insurance or alternative form of security on the part of the Grantee, based on the determination that the project benefits the Navajo Nation and such a waiver is in the best interest of the Navajo Nation, pursuant to Title 25 CFR S 169.103 (f) (2).
D. The Resources and Development Committee of the Navajo Nation Council hereby approves the grant of right-of-way subject to, but not Iimited to, the terms and conditions attached as Exhibit A.
E. The Resources and Development Committee of the Navajo Nation Council hereby authorizes the President of the Navajo Nation to execute any and all documents to affect the intent and purpose of this resolution.
