

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 300(A).
- B. Each oversight committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).
- C. The Budget and Finance Committee has oversight of fixed costs for certain programs. 12 N.N.C. §301(B)(2).

SECTION TWO. FINDINGS

1 A. The Budget and Finance Committee held a hearing and took budget testimony
2 regarding for Fixed Costs – IT Maintenance, Lease Cost – Large Equipment, the
3 Office of the Controller’s annual audit, building maintenance, FMIS debt service,
4 Insurance Premiums for Division of General Services, utilities,
5 telecommunications, radio communications, facilities maintenance, Hopi Partition
6 Land Rental, Division of Human Services Retirement Plan account, Department of
7 Justice litigation fund, and the Judicial Branch Information Sharing System, Fiscal
8 Year 2021 Budget. 12 N.N.C. § 840 (A).

9 B. The Budget and Finance Committee recommends a fiscal year budget for Fixed
10 Costs – Office of The Controller, Division of General Services, Division of Human
11 Resources, Department of Justice, Judicial Branch. 12 N.N.C. § 840 (A).

22 Human Services Retirement Plan account, Department of Justice litigation fund, and
23 the Judicial Branch Information Sharing System, as provided on the Fund Type Budget
24 Summary, attached as **Exhibit A**.

25 B. The Budget and Finance Committee requests the changes to the Budget, as set forth in
26 the General Fund Comparative Summary, **Exhibit B**, Recommended Changes to the
27 General Fund Budget, **Exhibit C**, Recommended Conditions of Appropriation and
28 Legislative Concerns, **Exhibit D**, and Recommended Unmet Needs, **Exhibit E**, be
29 incorporated into the Navajo Nation Comprehensive Budget.




