BE IT ENACTED:

## SECTION ONE. AUTHORITY

A. The Naabik'íyati' Committee is established as a standing committee of the Navajo Nation Council. 2 N.N.C. § 700 (A).
B. The Naabik'íyati' Committee, as a Standing Committee, has the authority to establish a subcommittee subject to the requirements of 2 N.N.C. § 186.
C. The Naabik'íyati' Committee of the $24^{\text {th }}$ Navajo Nation Council established the Naabik'íyáti' Committee Gaming Subcommittee through the adoption of Resolution No. NABIJY-37-19, incorporated herein as Exhibit A.

## SECTION TWO. FINDINGS

A. The Naabik'íyáti' Committee established the Gaming Subcommittee to negotiate all related issues regarding the separate gaming compacts the Navajo Nation has with the State of Arizona and the state of New Mexico respectively and to address related issues to protect Navajo gaming. Exhibit A [Section Three (A)].
B. Pursuant to NABIJY-37-19, the Gaming Subcommittee shall exist until it's assigned tasks are completed. Exhibit A [Section Five]. The Gaming Subcommittee tasks are not completed as there are still outstanding issues related to the state of Arizona and State of New Mexico gaming compacts.
C. The Naabik'iyáti' Committee Gaming Subcommittee shall consist of three (3) members who represent Chapters located in the State of Arizona and three (3) members who represent Chapters located in the state of New Mexico and two (2) at-large members. The Navajo Nation Council Speaker shall appoint Delegates to serve on the subcommittee. The appointed Delegates serve at the pleasure of the Naabik'iyati' Committee. Exhibit A [Section Three (C)].

## SECTION THREE. APPOINTMENT AND CONFIRMATION

A. The Speaker of the $25^{\text {th }}$ Navajo Nation Council hereby appoints and the Naabik'iyáti' Committee hereby confirms the following Delegates to serve, at the pleasure of the Naabik'iyati' Committee, on the Naabik'íyáti' Committee's Gaming Subcommittee:

1. Hon. Council Delegate Helena Nez Begay from Arizona;
2. Hon. Council Delegate Otto Tso from Arizona;
3. Hon. Council Delegate Casey Allen Johnson from Arizona;
4. Hon. Council Delegate Steven R. Arviso from New Mexico;
5. Hon. Council Delegate Seth Damon from New Mexico;
6. Hon. Council Delegate Eugenia Charles-Newton from New Mexico;

B. The Office of Legislative Service's Executive Director shall assign two Office of Legislative Services staff to assist the Naabik'íyáti' Committee's Gaming Subcommittee.
C. The Speaker shall determine a Subcommittee budget and identify the funds.

BE IT ENACTED:

## SECTION ONE. AUTHORITY

A. The Nabik'iyati' Committee of the Navajo Nation Council is a Standing Committee of the Navajo Nation Council. 2 N.N.C. S 700.
B. The Nabik'iyati' Committee, as a Standing Committee, has the authority to establish a subcommittee subject to the requirements of 2 N.N.C. \$186.

## SECTION TWO. FINDINGS

A. The Naabik'iyáti' Committee of the Navajo Nation Council finds it to be in the best interest of the Navajo People to establish the Naabik'iyati' Committee's Gaming Subcommittee to represent the best interests of the Navajo Nation in all matters related to gaming on the Navajo Nation.

SECTION THREE. ESTABLISHMENT OF THE NAABIK'ÍYÁTI' COMMITTEE GAMING SUBCOMMITTEE
A. The Naabik'iyati' Committee hereby establishes the Naabik'iyati' Committee's Gaming Subcommittee to negotiate the all related issues regarding the separate gaming compacts the Navajo Nation has with the State of Arizona and the State of New Mexico respectively and to address related issues to protect Navajo gaming.
B. The Naabik'iyati' Committee Gaming Subcommittee shall:

1. Work in cooperation and in coordination with the Navajo Nation President, Attorney General, and the Navajo Nation Gaming Enterprise or the designees from these respective offices and entity; and
2. Report monthly to the Speaker of the Navajo Nation Council on the Subcommittee's activities; and
3. Transfer information and recommendations to the Speaker of the Navajo Nation Council, the Naabik'iyati' Committee, appropriate Navajo Nation Standing Committees, and appropriate Legislative Branch boards, commissions, agencies and programs; and
4. Submit to the Naabik'iyáti' Committee for review and approval any and all proposed amendments and/or compacts which are the result of such negotiation.
C. The Naabik'iyáti' Committee Gaming Subcommittee shall consist of three members who represent Chapters located in the State of Arizona and three members who represent Chapters located in the State of New Mexico and two (2) at-large members. The Navajo Nation Council Speaker shall appoint Delegates to serve on the subcommittee. The appointed Delegates serve at the pleasure of the Nabik'iyati' Committee.

## SECTION FOUR. APPOINTMENT

A. The Speaker of the Navajo Nation Council hereby appoints and the Naabik'iyati' Committee hereby approves the following Delegates to serve, at the pleasure of the Nabik'iyati' Committee, on the Naabik'íyáti' Committee's Gaming Subcommittee:

1. Honorable Paul Begay - Arizona;
2. Honorable Eugenia Charles-Newton - New Mexico;
3. Honorable Pernell Halona - New Mexico;
4. Honorable Otto Tso - Arizona;
5. Honorable Thomas Walker, Jr. - Arizona;
6. Honorable Jamie Henio - New Mexico;
7. Honorable Jimmy Yellowhair - At-Large;
8. Honorable Elmer P. Begay - At-Large.

B. The Naabik'iyati' Committee's Gaming Subcommittee may include members of the Executive Branch with the Navajo Nation President's recommended appointments serving on the Subcommittee, including but not limited to Navajo Gaming Regulatory Office and the Navajo Nation Gaming Enterprise.
C. The Naabik'iyati' Committee's Gaming Subcommittee by majority vote shall select a chairperson and vice-chairperson at their first meeting. The chairperson and vice-chairperson shall serve at the Subcommittee's pleasure; replacement by majority vote.
D. The Naabik'íyati' Committee's Gaming Subcommittee shall establish a regular meeting day(s) of the month and shall meet more frequently during tribal-state compact negotiations. Due to the economic importance of the compact negotiation work, Subcommittee members absent from two or more meetings may be replaced at the recommendation of the Chair of the Subcommittee.
E. The Naabik'iyáti' Committee's Gaming Subcommittee may retain a legal consultant through the Office of the Speaker to render legal advice regarding negotiations.

## SECTION EIVE. SUBCOMMITTEE TERM

The Naabik'iyáti' Committee Gaming Subcommittee shall exist until it's assigned tasks are completed and shall report its recommendations to the Naabik'iyati' Committee, pursuant to 2 N.N.C. § 186.

## SECTION SIX. DIRECTIVES

A. The Speaker's Chief of Staff shall assign one policy analyst to assist the Naabik'iyati' Committee's Gaming Subcommittee.
B. The Legislative Service's Executive Director shall assign two Office of Legislative Services staffers to assist the Nabik'iyati' Committee's Gaming Subcommittee.
C. The Speaker shall determine a Subcommittee budget and identify the funds.
