FINDINGS** 27 A. The Navajo Nation Council approved Resolution No. CAP-35-18, entitled, "Adopting the 28 Síhasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14, as 29

SECTION THREE. APPROVAL

The Navajo Nation Council hereby approves a change to Resolution No. CAP-35-18, Exhibit D, Project No. 65, for the Chilchinbeto Chapter, as shown in the attached **EXHIBIT 2**.

- §§ 810 (F), 820 (I) And (M) And 860 (C) Relating to the Capital Improvement Budget and the Capital Improvement Process." CAP-35-18 is incorporated herein by reference.
- B. Section 4(C) of CAP-35-18 provides: "A chapter project, powerline, or waterline project may be changed, including the year funded, or added to Exhibits A through E with the concurrence of the Delegate representing the chapter's Council District and the approvals of the Resources and Development Committee and Budget and Finance Committee, as long as such project has been certified as construction-ready by CPMD or NTUA and the total Síhasin Funding for the District does not exceed \$4,166,666.67."
- C. The amount of \$300,000 for the Chilchinbeto Chapter Multipurpose Building Project in Year 1 was approved in Exhibit D of CAP-35-18. The CAP-35-18 Exhibit D showing the Chilchinbeto Chapter Project No. 65 is attached hereto as **EXHIBIT 1**.
- D. The Chilchinbeto Chapter desires to delete No. D-65 and replace it with a sewer lagoon project in Year 3, using the same \$300,000 allocation originally approved in CAP-35-18.
- E. Regarding the Chapter's change request, the Division of Community Development has submitted, on behalf of the Chapter, a Síhasin Project Amendment Certification Form, attached hereto as **EXHIBIT 2**. The CPMD Amendment Certification Form shows the signature of the Navajo Nation Council Delegate for the Chilchinbeto Chapter, as required by CAP-35-18 Section 4(C).
- F. As required by CAP-35-18 Section 4(C), the Project to be added has been certified by the Capital Projects Management Department as construction-ready and the total Síhasin Funding for the Chilchinbeto Chapter Council District will not exceed \$4,166,666.67. In fact, the original Síhasin funding amount of \$300,000 for the Chilchinbeto Chapter, as approved in CAP-35-18, will remain unchanged.
- G. The Síhasin Fund shall be reimbursed, in the amount of the allocation authorized in this Legislation, from prospective funds available to the Navajo Nation from any and all appropriate state and federal sources.


