SCHOOLS MAY SERVE

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Law and Order Committee of the Navajo Nation Council, pursuant to 2 N.N.C. 601(B)(14), reviews and makes recommendations to the Navajo Nation Council on proposed amendments to and enactments in the Navajo Nation Code.
- B. The Health, Education and Human Services Committee of the Navajo Nation Council, among other duties and responsibilities, has oversight authority over matters related to education within the Navajo Nation. 2 N.N.C. §401 (6) (a)
- C. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council. Pursuant to 2 N.N.C. § 164(A) (9), the committee reviews proposed legislation which requires final action by the Navajo Nation Council.

1 D. The Navajo Nation Council enacts laws and sets policy for the Navajo Nation. 2
2 N.N.C. § 102.

3 **SECTION TWO. FINDINGS**

4 A. The Navajo Nation Code empowers the Navajo Nation School Board to assume control
5 of local community controlled schools from the local community school board under
6 certain enumerated conditions. 10 N.N.C. § 106 (G) (1) (a)

7 B. The Navajo Nation Code establishes that “The chief administrative officer of the Board
8 shall be the ‘Navajo Nation Superintendent of Schools’, who shall be appointed by the
9 Navajo Nation Board of Education, subject to confirmation by the Navajo Nation
10 Council, and shall be empowered to do all things necessary and proper to carry out the
11 responsibilities of the Board.” 10 N.N.C. § 106(G) (2)(a)

12 C. The Navajo Nation Code empowers and directs the Dine Department of Education,
13 through the Superintendent of Schools to “Upon a directive from the Board, assume
14 control of community controlled schools in a situation where problems have been
15 identified that hamper the education of students in the school and the problems are
16 determined to be beyond the school’s ability to resolve.” 2 N.N.C. § 1803 (H)

17 D. The Navajo Nation Council finds it in the best interest of the Navajo Nation to ensure that
18 the Superintendent of Schools not serve as an active member on any board or commission
19 that has the capacity to make recommendations to remove or retain a school’s
20 accreditation. This prohibition shall not, however, prevent the Superintendent of Schools
21 from serving as an advisor to such board or commission on behalf of the Department of
22 Diné Education.

24 **SECTION THREE. Amending Title 2**

25 The Navajo Nation Council hereby amends the Navajo Nation Code, 2 N.N.C. § 1802 (B)
26 as follows:

28 **The NAVAJO NATION CODE**

29 **TITLE 2**

30 **Chapter 5 Subchapter 31. Department of Diné Education**

1 * * * *

2 **§ 1802. Staffing and Organization**

3 A. The Department is under the immediate direction of the Navajo Nation
4 Superintendent of Schools, subject to the overall direction of the Navajo Nation
5 Board of Education. The Navajo Nation Superintendent of Schools is appointed
6 by the Navajo Nation Board of Education, subject to confirmation by the Navajo
7 Nation Council.

8 B. The Navajo Nation Superintendent of Schools shall serve at the pleasure of the
9 Navajo Nation Board of Education. The Superintendent shall not serve as an
10 active member on any board or commission that has the capacity to make
11 recommendations to remove or retain a school's accreditation. All personnel
12 other than the Navajo Nation Superintendent of Schools shall be subject to all of
13 the Personnel Policies and Procedures of the Navajo Nation.

14 C. The Department shall be comprised of such programs and administrative
15 components as may be deemed necessary, subject to availability of
16 appropriations, and legislative approval of Department and/or program plans of
17 operation.

21 **SECTION FOUR. CODIFICATION**


22 The provisions of the Act which amend or adopt new sections of the Navajo Nation
23 Code shall be codified by the Office of Legislative Counsel. The Office of Legislative
24 Counsel shall incorporate such amended provisions in the next codification of the Navajo
25 Nation Code.

27 **SECTION FIVE. SAVING CLAUSE**

28 Should any provision of this Act be determined invalid by the Navajo Nation Supreme
29 Court or the District Courts of the Navajo Nation, without appeal to the Navajo Nation
30 Supreme Court, the remainder of the Act shall remain the law of the Navajo Nation.

AdvancEd Navajo Nation Accreditation Council

When I came to work at Department of Dine' Education in January 2015, I was informed by Dr. Anslem Davis, Director of AdvancEd Navajo Nation Accreditation Office, that as Superintendent of Schools I serve on the Navajo Nation Accreditation Council. The Accreditation Council meets two times a year, one in January and again in May. I attended four meetings up to January 2017.

In consultation with my administrative team within the last week, they strongly recommend DODE's involvement on the accreditation council be maintained because we have grant schools, BIE operated schools, public schools, and parochial schools that are accredited under AdvancED. Except for the 34 grant schools, DODE's oversight on the other schools are very limited to none. Therefore, DODE's involvement on these schools accreditation is critical to make sure they all meet a higher level of standards for governance, leadership, school improvement, accountability, and academic growth. I advise the Navajo Nation Council to be careful with this legislation as the Nation needs to have involvement in all schools for compliance.

Dine' College

As Superintendent of Schools, I serve on Dine' College Board of Regents as authorized by the Dine' College charter. I have attended Board meetings and other functions at Dine' College since April 2015 when I was confirmed by the Navajo Nation Council to be seated on the Board of Regents. Dine' College charter allows for eight people to serve on the Board of Regents as follows:

- President of Navajo Nation appoints a representative from each agency on the Navajo Nation and five positions are assigned in this manner.
- The Chair of the Education Committee, now HEHSC, serves on the Board. However; HEHSC Chair was not able to serve on the Board so the committee appointed Delegate Nelson Begay to serve on the Board of Regents since April 2015.
- The Superintendent of Schools for Department of Dine' Education serves on the Board of Regents.
- The Student Body President of Dine' College serves on the Board of Regents with full voting power.

In behalf of Dine' College, I attended a conference sponsored by the Association of Community College Trustees (ACCT) in New Orleans in September 2016. Through this conference I was asked to serve on the ACCT National Board of Directors representing tribal colleges. ACCT allows a tribal college representative to serve on their Board of Directors for a one year term. I attended my first meeting with the Board of Directors in January 2017 and another meeting is coming up in July 2017. My term on the National Board of Directors will expire on December 31, 2017.
