Purpose of this Legislation:

to allocate \$4,000,000 from the UUFb for the 110 Chapters' Summer 2022 Youth Employment Programs; waiving 12 N.N.C. §820(E), §820(F), §820(J), and §820(L) to allow use of UUFb funds for recurring Chapter expenses.



AN ACT

RELATING TO THE HEALTH, EDUCATION, AND HUMAN SERVICES,
RESOURCES AND DEVELOPMENT, BUDGET AND FINANCE,
AND NAABIK'ÍYÁTI' COMMITTEES, AND THE NAVAJO NATION
COUNCIL; APPROVING \$4,000,000 FROM THE UNRESERVED,
UNDESIGNATED FUND BALANCE ("UUF") FOR THE 110 NAVAJO
NATION CHAPTERS' SUMMER 2022 YOUTH EMPLOYMENT
PROGRAMS; WAIVING 12 N.N.C. §820(E), §820(F), §820(J), and §820(L) TO
ALLOW USE OF UUF FUND FOR RECURRING CHAPTER EXPENSES

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Navajo Nation established the Health, Education, and Human Services Committee as a Navajo Nation Council standing committee and empowered the Committee to review and recommend resolutions regarding employment matters. 2 N.N.C. §401(B)(6)(A).
- B. The Navajo Nation established the Resources and Development Committee as a Navajo Nation Council standing committee and gave the Committee oversight over the 110 Navajo Nation Chapters. 2 N.N.C. §164(A)(9); 2 N.N.C. §500(A); 2 N.N.C. §501(C)(1).
- C. The Navajo Nation established the Budget and Finance Committee as a Navajo Nation Council standing committee and authorized the Committee to review and recommend to the

1 Navajo Nation Council the management of all funds. 2 N.N.C. §164(A)(9); 2 N.N.C.
2 §300(A); 2 N.N.C. §301(B)(2).

3 D. The Navajo Nation established the Naabik'íyáti' Committee as a Navajo Nation Council
4 standing committee, and all proposed legislation that requires final action by the Navajo
5 Nation Council is assigned to the Naabik'íyáti' Committee for its review and consideration.
6 2 N.N.C. §164(A)(9); 2 N.N.C. §700(A).

7 E. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A).
8 As such, the Council “. . . may adopt and approve supplemental appropriations to the Annual
9 Comprehensive Budget during the fiscal year. Supplemental appropriations of General Funds
10 within the current fiscal year are permitted, if and when additional sources of revenues above
11 and beyond the initial or current revenue projections are projected and which are also in
12 excess of the reserve amount set forth at §820(J).” 12 N.N.C. §820(L).

13 F. The Title 12 restrictions on supplemental appropriations, including all amounts from the
14 UUFB, include:

15 1. Payment of recurring government operating expenses shall be from recurring revenues,
16 and payment of nonrecurring expenses shall be from nonrecurring revenues such as UUFB
17 funds. 12 N.N.C. §820(E); 12 N.N.C. §820(F).

18 2. Specifically, the UUFB shall not be used for recurring government expenditures or
19 operations. 12 N.N.C. §820(J); 12 N.N.C. §820(L).

20 3. Nonrecurring revenues such as UUFB funds may be used only after the Controller
21 determines whether or not such revenues are subsidizing an imbalance between the
22 Navajo Nation's recurring revenues and expenditures, and government expenditures shall
23 only be authorized if a long-term (3-year to 5-year year) forecast shows that the operating
24 deficit will not continue; otherwise, nonrecurring revenues will be added to the
25 Unreserved, Undesignated Fund Balance. 12 N.N.C. §820(F).

26 4. The above provisions in Title 12 may be amended or waived by a two-thirds vote of the
27 full membership of the Navajo Nation Council. 12 N.N.C. §820(F); 12 N.N.C. §880.

28 5. Pursuant to 12 N.N.C. §820(F) all UUFB funding requests must be reviewed by the
29 Controller. Such review is also required because the Controller determines which
30 revenues and expenses are recurring and which are non-recurring. 12 N.N.C. §820(L).

1 6. Pursuant to 12 N.N.C. §820(M) all UUFB funding requests must be submitted to the
2 Office of Management and Budget (“OMB”) for a budget impact analysis.
3

4 **SECTION TWO. FINDINGS**

5 A. All 110 Navajo Nation Chapters have indicated a need for supplemental funds to pay for
6 their summer youth employment programs for the Summer of 2022. On behalf of the 110
7 Chapters, the Division of Community Development (“DCD”) is requesting \$4,000,000 in
8 UUFB funds to distribute among all 110 Chapters.

9 B. The required Budget Forms, including Appendix K “Supplemental Funding Proposal
10 Summary” for the Chapters’ proposed expenditures, are attached as **EXHIBIT A**.

11 C. DCD has prepared a comprehensive list of each Chapter’s needed amount to fund its Summer
12 2022 Youth Employment Program, showing the total amount needed of \$4,000,000 for all
13 110 Chapters. **EXHIBIT B**.

14 D. Diné Customary Law declares and teaches that: “[i]t is the right and freedom of the people
15 that our children are provided with education to absorb wisdom, self-knowledge, and
16 knowledge to empower them to make a living and participate in the growth of the Navajo
17 Nation.” 1 N.N.C. §204(F).

18 E. The Navajo Nation honors Diné Customary Law by assisting high school and college
19 students with temporary employment during their summer breaks. Chapter summer youth
20 employment programs offer these students the opportunity to gain work experience during
21 their summer breaks, and to earn funds to pay for their school expenses.

22 F. Due to the COVID-19 pandemic, many Navajo Nation youth were largely unable to secure
23 summer employment during the Summers of 2020 and 2021; therefore, this \$4,000,000 in
24 funding is badly needed to assist them with jobs and income this Summer.

25 G. The Office of the Controller was asked to provide a memorandum as required by 12 N.N.C.
26 §820(L). This memorandum shall be provided to the assigned Committees and the Navajo
27 Nation Council when this legislation is up for consideration.

28 H. The Office of Management and Budget was asked to provide a budget impact analysis as
29 required by 12 N.N.C. § 20(M). This analysis shall be provided to the assigned Committees
30 and the Navajo Nation council when this legislation is up for consideration.

1 **SECTION THREE. ALLOCATING \$4,000,000 FROM THE UUFb TO THE DIVISION**
2 **OF COMMUNITY DEVELOPMENT FOR THE 110 CHAPTERS’**
3 **SUMMER 2022 YOUTH EMPLOYMENT PROGRAM**

4 A. The Navajo Nation hereby allocates \$4,000,000 out of the UUFb to the Division of
5 Community Development to be used for the 110 Chapters’ summer youth employment
6 programs for 2022, as shown in the attached EXHIBIT A and EXHIBIT B.

7 B. This supplemental appropriation shall be from those funds that exceed the minimum fund
8 reserve balance in the UUFb required by 12 N.N.C. §820(J), as determined by the Controller.

9 C. Pursuant to 12 N.N.C. §820(O) the \$4,000,000 shall be deposited with each of the 110
10 Chapters as follows: “fifty percent (50%) of the appropriation shall be divided equally among
11 all chapters and the remaining fifty percent (50%) shall be divided proportionately among
12 the chapters using a percentage equal to that figure which the number of registered voters in
13 each chapter bears to the whole of registered Navajo Nation votes as determined by the most
14 current voter registration figures available as of the date of the appropriation.”

15 D. Pursuant to 12 N.N.C. §820(N) the amount received by each of the 110 Chapters under the
16 overall \$4,000,000 allocation approved herein shall not lapse at the end of the fiscal year, so
17 long as each Chapter accounts for any funds that remain after the conclusion of its Summer
18 2022 Youth Employment Program and then budgets such funds in the next fiscal year for its
19 Summer 2023 Youth Employment Program.

20
21 **SECTION FOUR. WAIVING 12 N.N.C. §820(E), §820(F), §820(J), and §820(L) TO**
22 **ALLOW USE OF UUFb FUNDS FOR RECURRING CHAPTER**
23 **EXPENSES**

24 The Navajo Nation hereby waives 12 N.N.C. §820(E), §820(F), §820(J), and §820(L) to allow
25 use of the UUFb for the 110 Chapters’ summer youth employment programs for Summer 2022,
26 as shown in EXHIBIT A and EXHIBIT B. These waivers are necessary because the proposed
27 Chapter UUFb expenditures are considered recurring government expenses.

28
29 **SECTION FIVE. EFFECTIVE DATE**

30 This Act shall become effective as provided in 2 N.N.C. §221(B) and 2 N.N.C. §164(A)(17).

1 **SECTION SIX. SAVING CLAUSE**

2 If any portion of this Act is determined invalid by the Navajo Nation Supreme Court, or by a
3 District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the
4 remainder of this Act shall be the law of the Navajo Nation.



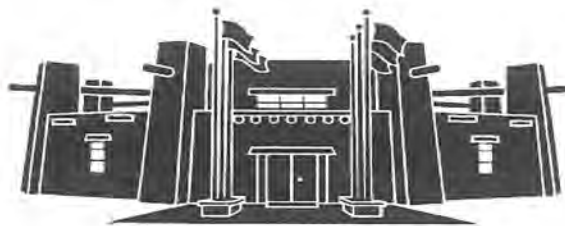

However, the Speaker may assign this legislation to any committee(s) other than those shown in the title, pursuant to his authority under 2 N.N.C. §164(A)(5).





WHEREAS:

1. Pursuant to the Navajo Nation Local Governance Act, (LGA), 26 N.N.C. §3 and Navajo Nation Council Resolution CAP-32-78, the Tse Dáá K'áán Community Chapter, (Chapter) is a duly certified chapter of the Navajo Nation Government as listed at 11 N.N.C. Part 1 Section 10, and Local Governance Certified as of June 21, 2007 per TDCJN-16-07.
2. Pursuant to the LGA, 26 N.N.C. §103, (A) and §103(B), the chapter is recognized as a local government entity and delegated certain authorities and responsibilities with respect to making decisions over local matters consistent with Navajo Nation law and had the authority enact upon 26 N.N.C. §103 et seq.
3. Pursuant to N.N.C. Section 4028(a), the chapter has the authority to review all matters affecting the community and make appropriate recommendations to the Navajo Nation, Private, County, and State Government agencies.
4. The Tse Dáá K'áán (Hogback) Chapter summer youth employment program offers high school and college students with the opportunity to earn funds to pay for some of their education expenses. According to Legislation 0060-22, the Tse Dáá K'áán (Hogback) Chapter allocation is \$39,890.00.
5. The Tse Dáá K'áán (Hogback) Chapter supports Legislation 0060-20 and requests that the Navajo Nation Council to approve the \$4 million for the summer youth employment programs for all chapters.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Tse Dáá K'áán (Hogback) Chapter respectfully requests that the Navajo Nation Council to approve Legislation 0060-22 to allocate \$4 million for the 110 chapter's summer youth employment programs.
2. The Tse Dáá K'áán (Hogback) Chapter requests a fifteen percent (15%) increase in funding for summer youth employment for all 110 chapters.

WHEREAS:


