PURPOSE: This legislation will confirm the Navajo Nation's purchase of two properties in Colorado and one property in Arizona and direct the Division of Natural Resources to pursue steps to add the properties to Navajo Nation permanent holdings.

This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each committee member to review the proposed resolution in detail.

Section One. Authority

- A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102 (A).
- B. The Navajo Nation Council, by Resolution CJY-54-94, established a Land Acquisition Trust Fund within the Navajo Land Department for the purchase of lands for the Navajo Nation according to the Land Acquisition Policy and Procedures and the Navajo Land Consolidation Act of 1988.

Section Two. Findings

- A. The Navajo Nation Land Acquisition of Lands Act, 16 N.N.C. § 2(A), states, “The Navajo Nation’s major purpose in acquiring new lands shall [include]: (5) Provid[ing] land necessary for approved Navajo Nation economic development.”
- B. The Navajo Nation shall acquire and dispose of real property subject to land acquisition regulations as approved by the Resources and Development Committee of the Navajo Nation Council. 16 N.N.C. § 3.

1 C. Through the Navajo Nation Land Acquisition Act, the Navajo Nation increased its
2 land property holdings and increased the territory of the Navajo Nation with the
3 purchase of land property in Colorado and Arizona. *See* NABIJY-57-17, RDCO-113-
4 17, and NABIMY-34-18.

5 D. To increase the Navajo Nation land holdings, funds were made available through the
6 Land Acquisition Trust Fund and the Navajo Land Department, pursuant to Rules and
7 Regulations, VI, General Procedures for Purchase of Real Property, (D)(1)(a),
8 prepared a recommendation to the approving authority and verified that funds were
9 available for the purchases.

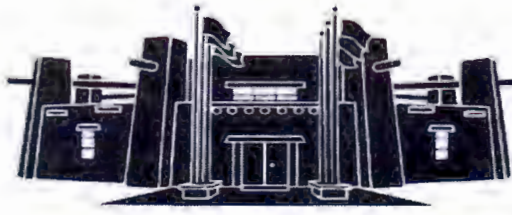
10 E. For each property holding the Navajo Division of Natural Resources and the Navajo
11 Land Department, pursuant to the Rules and Regulations of the General Procedure for
12 Purchase of Real Property, conducted preliminary assessments, negotiated the
13 purchase price for the properties, and conducted preliminary inspections of the
14 properties including title issues, inventory, and readily identifiable environmental
15 concerns.

16 F. In providing additional land necessary for approved economic development and
17 expanding the land holding of the Navajo Nation, the Navajo Nation finds it in the
18 best interest to confirm the acquisition of land holdings in the States of Colorado and
19 Arizona.

21 **Section Three. Confirming Land Purchases for the Navajo Nation with Directive**

22 A. The Navajo Nation Council, looking forward for future generations, confirms the land
23 acquisitions made by NABIJY-57-17, RDCO-113-17 and NABIMY-34-18 through the
24 Navajo Land Acquisition Act, 16 N.N.C. § 1 et seq., and the Land Acquisition Trust
25 Fund principal and income, 16 N.N.C. § 204.

26 B. The Navajo Nation Council directs the Navajo Division of Natural Resources and its
27 relevant Programs to ensure the Navajo Nation's land acquisition will be permanent land
28 holdings for the Navajo Nation and its future generations.

Pursuant to your request, attached is the above-referenced proposed resolution and associated legislative summary sheet. Based on existing law, the resolution as drafted is legally sufficient. However, as with all legislation, it is subject to review by the courts in the event of a challenge. NOTE: This will take a two-thirds vote of Council to approve.

The Office of Legislative Counsel confirms the appropriate review based on the Navajo Nation Council's authority outlined in 2 N.N.C. § 102. Nevertheless, "the Speaker of the Navajo Nation Council shall introduce [the proposed resolution] into the legislative process by assigning it to the respective oversight committee(s) of the Navajo Nation Council having authority over the matters for proper consideration." 2 N.N.C. § 164(A)(5).

Please review the proposed resolution to ensure it is drafted to your satisfaction. If this proposed resolution is acceptable to you, please sign it where it indicates "Prime Sponsor", and submit it to the Office of Legislative Services for the assignment of a tracking number and referral to the Speaker.


