20	SECTION ONE. AUTHORITY
21	A. The Resources and Development Committee is a standing committee of the Navajo Nation
22	Council with oversight authority over all 110 Navajo Nation Chapters. 2 N.N.C. §500(C)
23	and 26 N.N.C. §102.
24	B. The Budget and Finance Committee is a standing committee of the Navajo Nation Council
25	with the responsibility to "review and recommend to the Navajo Nation Council the
26	budgeting, appropriation, investment and management of all funds." 2 N.N.C. §301(B)(2).
27	C. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council that
28	considers all proposed final actions by the Navajo Nation Council. 2 N.N.C. §164(A)(9).
29	D. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A).
30	As such, the Council may approve appropriations from the Navajo Nation's Síhasin Fund.

E. 12 N.N.C. §2502, as amended by CJA-03-18, states the purpose of the Navajo Nation Síhasin Fund ("Síhasin Fund") as follows:

§2502 Purpose

- A. The purposes of this Fund are to provide financial support and/or financing for:
  - 1. The planning and development of economic development and regional infrastructure supporting economic development and community development, including such infrastructure as, but not limited to, housing, commercial and government buildings, waterline, solid waste management development, powerline projects, and transportation and communication systems, within the Navajo Nation; . . .
- B. For the Purpose in §2502(A)(1), Fund expenditures for infrastructure shall not be limited by 12 N.N.C. §1310(F) or TCDCJY-77-99.
- C. Leveraging the Fund by way of guaranteeing loans, match funding, direct funding in part, and other weighted uses of the Fund, including loan financing from the Fund, for the purposes in §2502(A)(1), shall be favored over direct funding in whole.
- F. The Síhasin Fund provides that "Fund Principal" shall consist of all deposits made to the Síhasin Fund and that "Fund Income" shall consist of all earnings (interest, dividends, etc.) generated and realized by the Fund Principal, and that Síhasin Fund Income shall be deposited in, and added to, the Fund Principal until such time as a Fund Expenditure Plan is duly approved. 12 N.N.C. §2504 and §2505(C).
- G. The Síhasin Fund provides that "Fund Principal and Income shall not be expended except pursuant to a Fund Expenditure Plan consistent with the purposes set forth in §2502 of this Chapter and adopted by a two-thirds (2/3) vote of all members of the Navajo Nation Council." 12 N.N.C. §2505(A).

#### **SECTION TWO. FINDINGS**

A. The Sawmill Chapter is requesting \$317,947 out of the Síhasin Fund for the purchase of a new motor grader for the Chapter, which is needed for grading, leveling, and repairing road in the community. The Sawmill Chapter explains its need and request for funds in Resolution

- B. The Sawmill Chapter has provided several price quotes for the motor grader, as well as a detailed description of the vehicle and appurtenant equipment. **EXHIBIT B**.
- C. Allocation of the \$317,947 as requested by the Sawmill Chapter meets the criteria for Síhasin expenditures because the proposed expenditure involves the improvement of transportation infrastructure that supports economic and community development, as described in 12
- D. The Red Lake Chapter is requesting \$120,000 out of the Síhasin Fund for the purchase of a new backhoe for the Chapter, which is needed for burials, irrigation projects, and repairing roads in the community. The Red Lake Chapter explains its need and request for funds in Resolution No. RLC-08-21-34, dated August 18, 2021, attached as **EXHIBIT C**.
- E. The Red Lake Chapter has provided a price quote for the backhoe, as well as a detailed

Allocation of the \$120,000 as requested by the Red Lake Chapter meets the criteria for Síhasin expenditures because the proposed expenditure involves the improvement of transportation and water infrastructure that supports economic and community development, as described in 12 N.N.C. §2502(A)(1).

# SECTION THREE. APPROVING \$437,947 OUT OF THE SÍHASIN FUND FOR THE

## PURCHASE OF VEHICLES AND RELATED EQUIPMENT FOR SAWMILL CHAPTER AND RED LAKE CHAPTER; APPROVING

#### THE RELATED EXPENDITURE PLANS

- A. In accordance with 12 N.N.C. §2505(A), the Navajo Nation hereby approves \$317,947 out of the Sihasin Fund for the purchase of a new motor grader and appurtenant equipment for the Sawmill Chapter, as explained in this Act.
- B. The Navajo Nation hereby approves the Expenditure Plan for the purchase of a new motor grader and appurtenant equipment for the Sawmill Chapter, as described in the attached EXHIBIT A and EXHIBIT B.
- C. In accordance with 12 N.N.C. §2505(A), the Navajo Nation hereby approves \$120,000 out of the Sihasin Fund for the purchase of a new backhoe and appurtenant equipment for the

- D. The Navajo Nation hereby approves the Expenditure Plan for the purchase of a new backhoe and related equipment for the Red Lake Chapter, as described in the attached **EXHIBIT C** and **EXHIBIT D**.
- E. The total amount of \$437,947 in Síhasin funds approved in this Act may be further leveraged by bond or loan financing pursuant to the Navajo Nation Bond Financing Act (12 N.N.C. §1300 *et seq.*, as amended), using Síhasin Fund earnings for repayment and financing costs, upon approval of the Budget and Finance Committee and upon further approval by a two-thirds (2/3) vote of the full membership of the Navajo Nation Council.
- F. The Controller shall determine whether the source of the \$437,947 approved herein will be Síhasin Fund Principal or Síhasin Fund Income, or a combination of both.
- G. The \$437,947 shall be disbursed to the Navajo Nation Division of Community Development ("DCD") within twenty (20) business days after the effective date of this Act. DCD shall then arrange for use of the \$317,947 for the Sawmill Chapter and the \$120,000 for the Red Lake Chapter, for the vehicle/equipment purchases described in EXHIBITS A-D, according to DCD's payment procedures for vehicle purchases for chapters not certified under the Local Governance Act (26 N.N.C. §1 §2005).
- H. Each Chapter shall be responsible for complying with the Expenditure Plans for the Síhasin funds approved herein, as shown in the attached EXHIBITS A-D.
- I. Each Chapter shall be responsible for the proper operation, regular maintenance, and necessary repairs, of its purchased vehicle and all related equipment, which responsibility includes ensuring that all vehicle operators are properly trained and licensed. Also, each Chapter shall obtain appropriate liability and/or comprehensive insurance coverage for its purchased vehicle and/or equipment, as may be instructed by DCD, which insurance shall be maintained for the useful life of the vehicle or equipment.
- J. Any and all savings or unused amounts of the Síhasin funds approved herein shall be immediately returned to the Síhasin Fund Principal once the purchases described herein are completed, or upon the reversion deadline in Section Three (K) below.
- K. The \$437,947 shall not lapse on an annual basis, which would otherwise occur pursuant to 12 N.N.C. §820(N). However, any Síhasin funds not spent or encumbered within six (6)

months of the date DCD receives the approved \$437,947 shall then immediately revert to the Síhasin Fund Principal, unless otherwise approved by both the Resources and Development Committee and the Naabik'íyáti' Committee of the Navajo Nation Council.

L. The Síhasin Fund shall be reimbursed the \$437,947 amount approved herein, from funds available to the Navajo Nation from any and all state and federal sources, including Congressional appropriations under the American Rescue Plan Act of 2021 or other COVID-19-related relief, so long as the Chapter expenditures described herein are deemed eligible under such COVID-19-related or other funding sources.

SECTION FOUR. EFFECTIVE DATE

This Act and the Expenditure Plans approved herein shall become effective pursuant to 12 N.N.C. §2505.

SECTION FIVE. SAVING CLAUSE

If any portion of this Act is invalidated by the Supreme Court of the Navajo Nation, or by any Navajo Nation District Court without appeal to the Navajo Nation Supreme Court, the remainder of this Act shall be the law of the Navajo Nation.

#### WHEREAS:

- 1. The Sawmill Chapter, a recognized certified local government of the Navajo Nation, vested with the power and authority to advocate on behalf of its constituents for the improvement of health, education, safety, and general welfare; and
- 2. The Budget and Finance Committee of the Navajo Nation Council is empowered to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment, and management of all funds. 2 N.N.C. section 301 (B) (2); and
- 3. The Resources and Development Committee of the Navajo Nation Council is empowered to provide oversight over chapter activities, as well as oversight over community and economic development on the Navajo Nation. 2 N.N.C. section 501 ( C ) (1); and
- 4. The Navajo Nation Code provides that the purpose of the Navajo Nation Sihasin funds is as follows: A. The purpose of this fund is to provide financial support and/or financing for: 1. The planning and development of economic development and regional infrastructure supporting economic development, and community development, including such infrastructure as, but not limited to, housing, commercial and government buildings, waterline, solid waste management development, powerline projects, and transportation and communication systems, within the Navajo Nation; and
- Pursuant to Navajo Nation Council resolution CAP-35-18, the Sihasin funded power line and chapter projects expenditure plan, which combined the undersigned unreserved fund balance and Sihasin funded totaling \$100,000,000.00 that was divided equally among the twenty-four Council Delegates district equaling \$4,1666,666.67 per district; and
- 6. The Sawmill Chapter received \$1,041,666.67 from the Navajo Nation Sihasin funding for power line extension, bathroom addition, chapter renovation, N-7 road repairs; and
- 7. The Sawmill Chapter is in dire need of a new motor grader equipment to be utilized for leveling and repairing roads for the community; and
- 8. The Sawmill Chapter has submitted price quotations to purchase a new motor grader equipment through the CARES ACT funding in early 2020, and also for the Navajo Nation Sihasin funding allocation for equipment, but the chapter's request was never considered for funding; and
- 9. The Sawmill Chapter has collected price quotations (Attached) again from various vendors to purchase a new motor grader equipment for the chapter.

#### NOW, THEREFORE BE IT RESOLVED THAT:

1. The Sawmill Chapter hereby requests the Budget & Finance Committee, Resources and Development Committee, Naabik' iyati Committee, the 24<sup>th</sup> Navajo Nation Council and the

- 2. Buyer agrees that Seller shall retain a security interest in and to the property sold hereunder and any additions or improvements thereto, until payment of the entire purchase price to Seller. Buyer shall execute a Uniform Commercial Code Financing Statement for fiting by Selfer to perfect the security interest retained in Selfer. If any note is given in connection herewith, it shall evidence the indebtedness only and not full payment and the security interest retained by Selfer constitutes security for the payment of amounts owing under the note. Unless otherwise provided on the face of this agreement, or any note in connection therewith, the purchase price shall bear interest at the rate of elighteen percent (18%) per annum or, if different, the highest honusurious rate allowed by law, upon the unpaid balance, if any, until maturity and after maturity at the highest lawful rate. 


