PURPOSE: This legislation will approve a supplemental funding request for the Division of Community Development to assist in meeting the funding needs for Chapter officials' stipend payments and worker's compensation.

NOTE: waiver of Title 12, § 820(F) requires a 2/3rds vote of the full Council

- D. The Navajo Nation council is the governing body of the Navajo Nation. 2 N.N.C. § 102(A).
- E. The Title 12 Appropriations Act Supplemental Appropriation requirements include:
 - 1. When the Controller identifies additional sources of revenues above and beyond the initial or current revenue projections, supplemental appropriations may be allocated by the Navajo Nation Council. 12 N.N.C. § 820(L).
 - 2. Supplemental appropriations made from non-recurring revenues shall only be made for non-recurring operations or purposes, as set forth at § 820(F). This provision may be amended or waived only by a two-thirds (2/3) vote of the full Council.
 - 3. The Controller of the Navajo Nation shall be responsible for designating recurring and non-recurring revenues. 12 N.N.C. § 820(L).
 - 4. All requests for annual operating funds and supplemental funds shall be submitted to the Office of Management and Budget for budget impact analysis and other appropriate actions. 12 N.N.C. § 820(M).

Section Two. Findings

- A. This is a funding request for a supplemental appropriation to the Navajo Nation Division of Community Development for Chapter Official stipends from the Unreserved, Undesignated Fund Balance (UUFB). See Exhibit A.
- B. The need and justification for the request of funds from the UUFB is the decrease in the Chapter budget for FY 2018. The impact of the decrease is a need created for Chapter Officials stipends of \$987,771 with worker's compensation need of \$33,660, a total of \$1,021,431.
- C. The Office of the Controller provided a memorandum dated, November 30, 2017, which indicated the request is a recurring cost. This memorandum is included in Exhibit B. The Office of the Controller also provided a document that the updated balance in the UUFB as of May 16, 2018 is \$3,378,986, which is included as Exhibit C.

I am pleased to present to you the following information related to General Fund financial data up to April 30, 2018.

The General Fund Financial data is as follows:

The gross General Fund Revenues (see Exhibit "A) as of April 30, 2018 is \$156,811,921 and the total set asides total \$43,426,146. The Net Revenue for the General Fund is \$113,385,775, which is 76.19% of the projection.

The total expenditures by branch are shown on Exhibit "B".

- The Legislative Branch has expenditures of \$8,444,720, encumbrances of \$552,041 with a remaining budget of \$9,831,455.
- The Executive Branch expenditures are \$104,593,344 encumbrances are \$11,530,480 with a remaining budget of \$91,000,419.
- The Judicial Branch expenditures are \$7,073,183 encumbrances are \$5,903 with a remaining budget of \$6,768,836.
- Total General Fund expenditures are \$120,111,247; total encumbrances are \$12,088,424 with an overall remaining budget of \$107,600,710.

The updated UUFB as of May 9, 2018 is \$3,378,986 (see Exhibit "C"). There have been twenty one supplemental appropriations during Fiscal Year 2018 in the total amount of \$27,446,724.

REQUESTING THE BUDGET & FINANCE COMMITTEE, THE 23rd NAVAJO NATION COUNCIL AND THE OFFICE OF THE PRESIDENT & VICE PRESIDENT TO APPROPRIATE SUPPLEMENTAL FUNDING IN THE AMOUNT OF \$17,000 PER EASTERN NAVAJO AGENCY CHAPTER THAT WERE NOT FULLY FUNDED FOR CHAPTER OFFICIALS STIPEND PAYMENTS IN THE FISCAL 2018 NAVAJO NATION COMPREHENSIVE BUDGET

WHEREAS:

- 1. The Eastern Navajo Agency Council is established under the Legislative Branch of the Navajo Nation and certified by Resolution IGRS-251-01; and
- 2. Pursuant to 26 N.N.C. Section 103 (D) (4), the Eastern Navajo Agency Council, a consortium of elected Chapter Officials representing thirty-one (31) certified Navajo Nation Chapters, agree to address and undertake common goals and interests for the benefit of the Eastern Navajo Agency Chapters; and
- 3. Pursuant 2 N.N.C SECTION: 4028; the Eastern Navajo Agency Council is vested with government authority to review all matters affecting the community to make most appropriate recommendations when necessary to the Navajo Nation, County, State, Federal and other local agencies; and
- 4. Pursuant to the Navajo Nation Appropriations Act the Navajo Nation Government has a fiduciary responsibility to plan for adequate funding of services desired by the Navajo people; and
- 5. Pursuant to CN-50-10, determined that a statutorily fixed rate of compensation for each chapter official would provide for more uniformity and additional stability in Navajo Chapter governance and each chapter president, chapter vice president, and chapter secretary/treasurer shall be paid \$500.00 each for one (1) regular chapter meeting and one chapter planning meeting per month; and
- 6. The standard annual Chapter Official Stipend budget for each of the 110 chapters is calculated as follows:

Planning Meeting: 3 officials x \$500/meeting x 12 months = \$18,000.00

Regular Meeting: 3 officials x \$500/meeting x 12 months = \$18,000.00

Agency Meeting: 3 officials x \$1500/meeting x 12 months = \$18,000.00

Workman's Compensation Expense: \$37,800 x .81% = \$306.18

TOTAL CHAPTER OFFICIAL STIPEND BUDGET \$38.106.18

7. On August 2017, the Division of Community Development distributed via spreadsheet the FY2018 Allocation to Chapters including a specific column of varied amounts for each Chapter's Stipend allocation, with the largest being the following:

Chinle Chapter \$71,072
Fort Defiance Chapter \$56,107
Kayenta Chapter \$48,911
Shirpock Chapter \$84,428
To'nanee'dizi Chapter \$63,527

- 8. In December 2017 the Eastern Navajo Agency Council Resolution ENAC-12-2017-012 requested the Division of Community Development to provide the formulation and determining factors in the FY2018 Allocation to the 110 Navajo Chapters as of this date, no response or action taken by 'Window Rock'; and
- 9. Navajo Chapters continue to question the allocation, specifically those Chapters who will experience a shortage in the coming months (same result occurred in FY2017); and

10. Conversations occur pertaining to compensation for elected positions at a rate that fairly compensates them for their work and should attract highly qualified candidates, while at the same time does not become the incentive for seeking public office – these talks should continue.

NOW, THEREFORE BE IT RESOLVED THAT:

 The Eastern Navajo Agency Council hereby requests the Budget & Finance Committee, the 23rd Navajo Nation Council and the Office of the President & Vice President to appropriate supplemental funding in the amount of \$17,000 per Eastern Navajo Agency Chapter that were not fully funded for Chapter Officials Stipend payments in the Fiscal Year 2018 Navajo Nation Comprehensive Budget.

- 10. In December 2017 the Eastern Navajo Agency Council Resolution ENAC-12-2017-012 requested the Division of Community Development to provide the formulation and determining factors in the FY2018 Allocation to the 110 Navajo Chapters – as of this date, no response or action taken; and
- 11. Navajo Chapters continue to question the allocation, specifically those Chapters who have and/or will experience a shortage in either or both Fiscal Years 2017 and 2018.
- 12. ENAC 03-2018-002 initially requested supplemental funding in the amount of \$17,000 per Eastern Navajo Agency Chapters that were not fully funded for Chapter Official Stipend payments.

1. The Eastern Navajo Agency Council hereby restates the request to the Budget & Finance Committee, the 23rd Navajo Nation Council and the Office of the President & Vice President to appropriate supplemental funding for Chapter Official Stipends – a recurring cost not sufficiently allocated by the Division of Community Development & Administrative Center to the 110 Navajo Chapters in Fiscal Years 2017 and 2018.

UUFB in the amount of \$1,021,431 for the Navajo Nation 110 Chapters

In April, 2018, OMB did a review memorandum on legislation 0088-18 which proposed the same purpose and funding. Today's memorandum will update the OMB review, as follows:

- 1. The balance in the available UUFB as of June 27, 2018 is \$4,678,986, according to the Office of the Controller. The 2018 BIM, FY 2018 budget resolution CS-53-17 (paragraph L), and Appropriation Act (§ 800 A) all call for planning and priorities. What are the priorities?
- According to the DCD Exhibit 'A' worksheet column D, nine chapters have sufficient funds to cover the Chapter Official stipends for FY 2018. Churchrock, Ft. Defiance, Shiprock, Upper Fruitland, St. Michaels, Kayenta, To'nanees'dizi, Chinle and Pinon Chapters have sufficient funds.
- 3. The Auditor General March 31 (2nd Quarter) report on Chapter Fund Balances showed \$75.5 in unexpended funds including \$1.5 million for stipends.
- 4. The Appropriations Act requires that non-recurring funds be used for non-recurring purposes (12 NNC § 820 (E), (F), (J), (L). The Controller previously determined that this would be recurring cost.
