### A. There are a total of 110 chapters within the Navajo Nation; and twenty-four (24) Council Delegates (Delegates) who serve as representatives to the Navajo Nation local government units.

- B. Delegates as representative of the Navajo Nation Council regularly attend chapter planning meetings and chapter meetings.
- C. When the local chapter conducts a meeting during a Naabik'íyáti' Committee meeting or the Navajo Nation Council session, the Delegates who opt to attend their chapter planning meeting or a chapter meeting are unable to perform their duties as a Delegate, therefore not serving their respective communities (*i.e.*, not being able to vote on their communities behalf).
- D. It is imperative due to the limited number of Council Delegates that all delegates are able to attend the Naabik'íyáti' Committee meetings as well as the Navajo Nation Council sessions, without conflicting meetings being held at the same time, to prevent loss of quorum.
- E. Pursuant to 2 N.N.C. § 700 (C), the Naabik'íyáti' Committee shall meet at least once per month at the call of the Chairperson on the second and fourth Thursday of each month until such time as the Committee adopts an annual meeting schedule and posts such schedule on the Council's website.
  - F. Pursuant to 2 N.N.C. § 162, there shall be four regular sessions of the Navajo Nation Council each year. Such sessions shall commence at 10 a.m. on the fourth Monday of January, the third Monday of April, July and October of each year.

G. It is within the Navajo Nation's best interest to amend Title 26, Navajo Nation Local Governance Act.

#### 29 SECTION THREE. AMENDING NAVAJO NATION CODE TITLE 26

The Navajo Nation amends the Navajo Nation Code, Title 26 as follows:

CODIFICATION The provisions of the Act which amend or adopt new sections of the Navajo Nation Code shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel shall incorporate such amended provisions in the next codification of the Navajo Nation Code. SECTION FIVE. SAVINGS CLAUSE Should any provision of this Act be determined invalid by the Navajo Nation

Supreme Court or the District Courts of the Navajo Nation, without appeal to the Navajo Nation Supreme Court, the remainder of the Act shall remain the law of the Navajo Nation.

#### Resolution of Input regarding Navajo Nation Legislation 0183-16

#### WHEREAS,

- 1. The Ojo Encino Chapter (the "Chapter") is a political subdivision of the Navajo Nation under 11 N.N.C. § 10 and a local governance certified chapter pursuant to 26 N.N.C. § 102, and the Chapter is responsible for the health and safety of its local residents/members and for stewardship of its Chapter lands and resources; and
- 2. The Chapter believes in the intent of Title 26 and strongly believes in the ideas of Local Governance and Local Empowerment; and
- 3. The Chapter also agrees with the intent of the the proposed legislation 0183-16 (the "legislation") which is to encourage council delegates to attend more chapter meetings; and
- 4. The Chapter feels that the legislation shows a fundamental flaw in Title 2 where attendance of chapter meetings is not a requirement of council delegates; and
- 5. Also, the Chapter believes that the issues addressed by the legislation can be better addressed by the few council delegates who are not attending chapter meetings to increase their communication and working relationship with chapter governments within their districts; and
- 6. In addition, the chapter believes that the proposed legislation would restrict the ability of local communities to hold chapter meetings when the community may see fit which would be counter to the intent of Title 26; and
- 7. That if legislation is required to fix this situation that Title 2 should be amended at §106 and §167 to require and pay stipends for council delegates to attend chapter meetings; and
- 8. The chapter would like to note that any amendments to Title 26 by the Navajo Nation Council will also require approval by the majority of chapters according to 26 N.N.C. §1.E:

Amendment. This Act may be amended by the Navajo Nation Council subject to approval of a majority of all chapters of the Navajo Nation; or this Act may be amended by referendum vote of a majority of all chapters as set forth in 11 N.N.C., Navajo Nation Election Code.

- 1. The Chapter is opposed to legislation 0183-16
- 2. The Chapter would instead support legislation that amends 2 N.N.C §106 and §167 that would codify the importance of delegates attending chapter meetings and encourage them to do so.

Council delegates attending an official Regular Chapter meeting (to be considered as a meeting in regards to 2 N.N.C §106 F) within their district may receive sixty dollars (\$60.00) per diem per quarter per chapter and mileage reimbursement for use of a private vehicle per quarter per chapter at the rate established in the Navajo Nation Travel Policy and Procedures Handbook, and amendments thereto. \*\*\*

 $\underline{CD}$ . For every week of a session of the Navajo Nation Council, delegates shall be paid mileage equal to one round trip to Window Rock from their residence and return, according to the official mileage chart of the Controller.

 $\underline{DE}$ . For each complete committee meeting delegates to the Navajo Nation Council shall be paid mileage equal to one round trip to Window Rock, from their residence and return, according to the official mileage chart of the Controller.

 $\underline{\text{EF.}}$  Full per diem shall be paid only for attendance of at least three hours of meeting or until all agenda items are concluded.

FG. Delegates, or their beneficiary in the event of death, are paid a deferred compensation benefit when they leave office.

2. Suggested potential changes to 2 N.N.C §167:

<u>A.</u> All delegates to the Navajo Nation Council shall attend all regular and special meetings of the Navajo Nation Council or Committees. If any delegate is absent from sixty percent (60%) of the meeting days within a one year period, the Navajo Nation Council may consider a motion to censure said delegate. If his/her absence continues, the Navajo Nation Council shall have the authority to declare the delegate's seat forfeited and vacant.

B. All delegates to the Navajo Nation Council shall attend at least one regular chapter meeting per quarter (one regular chapter meeting per 3 months) for each chapter within their district. If any delegate is absent for more than 50% of their required quarterly regular chapter meetings within a one year period the offended chapter may pass a resolution for the Navajo Nation Council to consider the censure of said delegate. If his/her absence continues, the Navajo Nation Council shall have the authority to declare the delegate's seat forfeited and vacant.

- 1. Pursuant to N.N.C., Section 3 (A), the Ts'ah Bii Kin Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C., part 1, section 10; and vested with the authority to discuss all matters affecting the Navajo people and its Nation; and
- 2. Pursuant to N.N.C., Section 1 (B), the Ts'ah Bii Kin Chapter is vested with the authority to review all matters affecting the community, make appropriate corrections when necessary, and provide recommendations to the Navajo Nation and other local agencies for appropriate action(s); and
- 3. The Ts'ah Bii Kin Chapter Opposes the Legislation No: 0183-16 to Amend Navajo Nation Code Title 26: Navaio Nation Local Governance Act. and:
- 4. The Ts'ah Bii Kin Chapter believes that it is not in the best interest of the Navajo people to subject them to only certain days to have their meetings, and;
- 5. The Ts'ah Bii Kin Chapter and Community does not approve no chapter meetings to be held during meetings scheduled by the Council, it is the Council whom should schedule their meetings around their constituents meetings.

#### NOW THEREFORE BE IT RESOLVED THAT:

The Ts'ah Bii' Kin Chapter hereby is opposes Legislation No: 0183-16 to amend Navajo Nation Code Title 26: Navajo Nation Local Governance Act. The Navajo Nation Council should not limit the communities of the Navajo Nation to certain days when they can hold their meetings.
