BE IT ENACTED:

**Section One. Authority**

- A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102 (A).
- B. The Naabik'iyati' Committee of the Navajo Nation Council is empowered to review all proposed legislation which requires final action by the Navajo Nation Council. 2 N.N.C. §164(A)(9).
- C. The Budget and Finance Committee of the Navajo Nation Council is empowered to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment, and management of all funds. 2 N.N.C. § 301 (B)(2).

- 1 D. The Resources and Development Committee of the Navajo Nation Council has  
2 oversight of the chapters of the Navajo Nation. 2 N.N.C. §501 (C)(1).
- 3 E. The Naabik'íyáti' Committee established the Naabik'íyáti' Síhasin Fund  
4 Subcommittee to recommend to the Naabik'íyáti' Committee and Navajo Nation  
5 Council financial support and/or financing plan(s) for the purposes designated in the  
6 Síhasin Fund. NABIAP-20-15. However, approval by the Naabik'íyáti' Síhasin  
7 Fund Subcommittee is not a requirement for legislation.
- 8 F. The Navajo Nation Code provides the purpose of the Navajo Nation Síhasin Fund  
9 ("Síhasin Fund") is as follows:

10 § 2502 Purpose

- 11 A. The purposes of this Fund are to provide financial support and/or  
12 financing for:

- 13 1. The planning and development of economic development  
14 and regional infrastructure supporting economic  
15 development, and community development, including such  
16 infrastructure as, but not limited to, housing, commercial  
17 and government buildings, waterline, solid waste  
18 management development, powerline projects, and  
19 transportation and communication systems, within the  
20 Navajo Nation; and  
21 2. Education opportunities for members of the Navajo  
22 Nation.

- 23 B. For the Purpose in § 2502(A)(1), Fund expenditures for  
24 infrastructure shall not be limited by 12 NNC § 1310(F) or  
25 TCDCJY-77-99.

- 26 C. Leveraging the Fund by way of guaranteeing loans, match  
27 funding, direct funding in part, and other weighted uses of the  
28 Fund, including loan financing from the Fund, for the purposes  
29 in § 2502(A)(1), shall be favored over direct funding in whole.

30 12 N.N.C. § 2502, as amended by CJA-03-18.



1 G. The Síhasin Fund provides that "Fund Principal" shall consist of all deposits made  
2 to the Síhasin Fund and that "Fund Income" shall consist of all earnings (interest,  
3 dividends, etc.) generated and realized by the Fund Principal, and that Fund  
4 Income shall be deposited in and added to Fund Principal until such time as a  
5 Fund Expenditure Plan is duly adopted. 12 N.N.C. §§ 2504 and 2505 (C).

## 7 **Section Two. Findings**

- 8 A. The Crownpoint Youth Center project is detailed in the project overview, scope of  
9 work, and an architectural design schematic attached as **Exhibit A**.  
10 B. Project process schedules are attached as **Exhibit B**.  
11 C. Navajo Housing Authority has awarded the Navajo Nation Office of Diné Youth a  
12 grant of \$7,432,446.02 contingent upon the project securing an additional  
13 \$2,500,000 in match funding. See **Exhibit C**.  
14 D. Both Crownpoint Chapter and Littlewater Chapter have passed resolutions in  
15 support of this project. These resolutions are attached as **Exhibit D**.  
16

## 17 **Section Three. Allocation of \$2,500,00 to the Crownpoint Chapter and approval** 18 **and adoption of the Crownpoint Youth Center Expenditure Plan**

- 19 A. The Navajo Nation hereby allocates to the Crownpoint Chapter the total amount of  
20 \$2,500,000.00 to construct the Crownpoint Youth Center as detailed in **Exhibits A**  
21 **and B**.  
22 B. The Navajo Nation hereby approves and adopts the Crownpoint Youth Center  
23 Expenditure Plan, attached and incorporated herein as **Exhibits A and B**.  
24 C. The Síhasin Funds allocated for the Síhasin Fund Crownpoint Youth Center  
25 Expenditure Plan may be further leveraged by bond or loan financing pursuant to  
26 the Navajo Nation Bond Financing Act, 12 N.N.C. § 1300 *et seq.*, as amended,  
27 using Síhasin Fund earnings for repayment and financing costs upon the  
28 recommendation of the Budget and Finance Committee and approval by a two-  
29 thirds (2/3) vote of all members of the Navajo Nation Council.  
30

1       **Section Four. Approval and Adoption of Expenditure Plan Administration**

2       The Navajo Nation hereby approves administration of the Síhasin Fund Crownpoint  
3       Youth Center Expenditure Plan as follows:

- 4       1. The Navajo Nation Controller shall determine whether the source of the annual  
5       allocations from the total allocation of \$2,500,000.00 will be Síhasin Fund  
6       Principal or Income or a combination of both;
- 7       2. The funding to the Crownpoint Chapter shall be distributed by the end of the first  
8       quarter of the respective Navajo Nation Fiscal Year;
- 9       3. The funds allocated for the Crownpoint Youth Center shall be used solely to  
10      design, plan, and construct the Crownpoint Youth Center described in **Exhibits**  
11      **A and B**. Any and all cost-savings shall be returned to the to the Síhasin Fund  
12      once the Crownpoint Youth Center is completed; and
- 13      4. The funds allocated for the Crownpoint Youth Center shall not lapse on an  
14      annual basis pursuant to 12 N.N.C. §820 (N), however, any funds not spent or  
15      encumbered within twenty-four (24) months of the date funds are made  
16      available to the Crownpoint Chapter shall revert to the Síhasin Fund principal,  
17      unless recommended otherwise by the Resources and Development Committee  
18      and approved by the Naabik'íyáti' Committee.

19  
20      **Section Five. Effective Date**

21      The Síhasin Fund Crownpoint Youth Center Expenditure Plan, as set forth above, shall  
22      become effective pursuant to 12 N.N.C. § 2505.

23  
24      **Section Six. Directives**

25      The Crownpoint Chapter and the Office of Dine Youth shall report the status of the  
26      Crownpoint Community Youth Center to the Division of Community Development  
27      and the Naabik'íyáti Committee a least once per quarter after the initial disbursement  
28      of funds.

To the Office of the President/Vice-President and the 23<sup>RD</sup> Navajo Nation Council:

On Thursday, May 10, 2018 at 2:00 p.m. (MDT) the Office of Diné Y.O.U.T.H., Weller Architects P.C. and the Navajo Housing Authority held its Bid Opening of Proposals for the construction of the Crownpoint Youth Complex in Albuquerque, New Mexico. A total of eight (8) bid proposals were received.

The Project is "shovel ready", however the opening of the bid proposals revealed, even with the lowest bid, that the project requires additional funding in the amount of \$2,500,000.00 to cover unanticipated costs, including but not limited to the following:

- Material costs, including but not limited to steel, have substantially increased due to changes in Federal trade policy under the country's current administration. In addition, overall cost of construction track with the cost of inflation, typically at 3% per year, which has substantially increased since the initial allocation of NAHASDA funding of the project in 2011.
- At the onset of the project the Navajo Housing Authority did not require a Construction Manager, nor did they require the Special Inspections as required by the current building code. Due to changes in NHA Policies and Procedures, in their continual effort to improve construction quality, we are now required to comply with these unforeseen costs which further strain our budget. The project is anticipated to last fourteen (14) months, and as one can imagine, the costs of a Construction Project Manager and Special Inspections are substantial.
- Bid security shall be submitted with each bid in the amount of 10 percent of the bid amount. No bids may be withdrawn for a period of 60 days after opening of bids subsequent to the date of opening thereof without the Owner's consent. Owner reserves the right to reject any and all bids, whether within the estimated total contract price or not, and to waive informalities and irregularities and to accept the bid it deems to be in its best interest. Therefore, The Bid Bond that each contractor submitted with their bid is only valid for 60 days. After the 60 days, the contractors can withdraw their bid. July 8, 2018 is 60 calendar days from May 10, 2018.

The Crownpoint Youth Complex consists of the construction of a new 27,140 sf youth complex in Crownpoint, New Mexico, situated adjacent to the existing Office of Diné Youth. The facility includes a gymnasium with adjacent stage area and adjoining locker/shower facilities, full kitchen, weight room, teen center, art classroom, library, offices, equipment rental space, and classrooms for the growing membership of local children, ages 5 to 18. Exterior amenities will include a playground, amphitheatre and gardening area along with much needed parking.

The single story structure is comprised of masonry and steel stud clad with either metal panels or EIFS, steel roof joists and membrane roofing, and a concrete slab on an engineered fill foundation along with related site improvements. The arrangement of building masses and interior spaces provide high visibility during operational and especially non-operational hours. Hard, durable and easily maintainable surfaces including exposed architectural concrete, load-bearing masonry construction in various colors, textures and massing throughout the building and insulated metal wall systems, provide a building that is not only beautiful but able to withstand many years of heavy use. In ongoing efforts to address ever-increasing concerns for energy conservation and sustainability, both passive and active energy conserving strategies are employed throughout.

The mission of the Office of Diné Youth is "To advocate, educate and develop resilient healthy generations of youth through partnerships to balance and live in a diverse society." Contemporary Navajo life results in conditions that differ widely from the traditional lifestyle long enjoyed by the Diné People. In the model unit of self-sufficiency, the Navajo Family Unit, children are mentored within the family unit; education, responsibility and life-skills are taught and learned from parent to child. The traditional Navajo homestead, typically being remote and isolated, reinforced these notions of self-reliance so fundamentally important to the Diné way of living well. Contemporary Navajo life has become a limiting factor relative to the amount of time that parents spend with their children. Over time, higher density Navajo communities have developed, so also the development of a commuting workforce where parents more often than not no longer work the homestead, oftentimes commuting and/or working long hours. Children spend long hours during the daytime away from parents; school occupies a portion of their day but does not fill all of their time. Many have been desensitized to more traditional pastimes opting for the multi-media bombardment of electronic bells and whistles. Like children everywhere, idleness, boredom, and a lack of focus to funnel their energies leaves them susceptible to more destructive physical and mental tendencies exhibited through vandalism, disobedience and a general lack of respect for themselves, order and rules. The strain on the family unit oftentimes hastens these tendencies. This facility is intended to assist the community by allowing for a structured focus of free time and interaction through the fundamental reinforcement of cultural understandings and relationships. This building is designed to capture certain aspects of Navajo culture and will form a backdrop that will assist this facility's administration in fulfilling an important community need.

Children must feel safe and confident to participate in structured and non-structured activities; fear overwhelms confidence. It is of paramount importance that this facility engenders a distinct and recognizable sense of security. Visibility of activity areas and access points is critical. Children of differing age groups act differently and their activities differ between groups; recognition of these needs also reinforces self confidence and self esteem which in turn fosters participation.

Parents' concerns relative to the safety and security of their children is also an important function of this facility; parents should have confidence in the facility and its employees to maintain order and an environment that offers beneficial activities free from inside or outside threats. Structured and non-structured activities in spaces which are monitored are important factors for their arrangement within the building. The check-in counter for example commands a location with optimum monitoring of building entries/exits and affords quick response times to issues that need to be addressed. Its location and prominence reinforces the notion of authoritative presence and security. Another example of spatial arrangement is the visibility into and out-of classrooms to the main corridor which increases the security of both spaces.

## **OFFICE OF DINE' YOUTH EASTERN NAVAJO AGENCY**

Office of Diné Youth/Eastern Navajo Agency was established by the Navajo Tribal Council in 1979. Our program is within the Department of Diné Education with the Central Office located in Window Rock, Arizona and offices located in each of the five (5) agencies.

Our program believes it has the moral obligation to insure that the Navajo Youth be entitled to all benefits and services available to them and that they be provided in a manner that develops positive attitudes, enhances self-image, confidence, maturity and pride in being a productive member of society.

We are located in the midst of what is known as the "Checkerboard Area". Eastern Navajo Agency offers a unique setup with Crownpoint being the "Central Point". The target group of the Office of Diné Youth is 5 – 24 years of age. We are a community based program and its concept focuses on the youth and their daily well-being. The hours of operation are Monday – Friday from 8:00 a.m. – 7:00 p.m. If necessary, the hours will go well beyond normal working hours including holidays and weekends; catering to the program's activities. At the present time, we have ten (10) regular status employees whom provide services to approximately 15,000 youth in the areas of; Recreation, Counseling, Career Youth Incentive Program within the Eastern Navajo Agency.

The Mission Statement for the Office of Diné Y.O.U.T.H. is to advocate, educate and develop resilient healthy generations of youth through partnerships to balance and live in a diverse society. Our goal is to instill in our youth a sense of personal responsibility and accountability for their actions.

**Through the Afterschool Programming**, our goal is to inspire and enable young people to realize their full potential as productive, responsible and caring citizens. Our strategy is to promote the development of young people by instilling a sense of competence, a sense of usefulness, a sense of belonging and a sense of power or influence. When this strategy is fully implemented, self esteem is enhanced and an environment is created which helps boys and girls achieve their full potential. The age groups that we serve are from 5 years to 18 years of age. Services are provided Monday thru Friday and some weekends.



**Through the Recreation Program** our goal is to basically provide a variety of recreational activities that enable the youth to show improvement in their self-esteem and lifestyles; and be inspired to continue their creativeness and ability to communicate with other mentally and physically through group/team efforts such as Sports, Cultural teachings and other social activities. The age groups that we serve are from 5 years to 21 years of age.

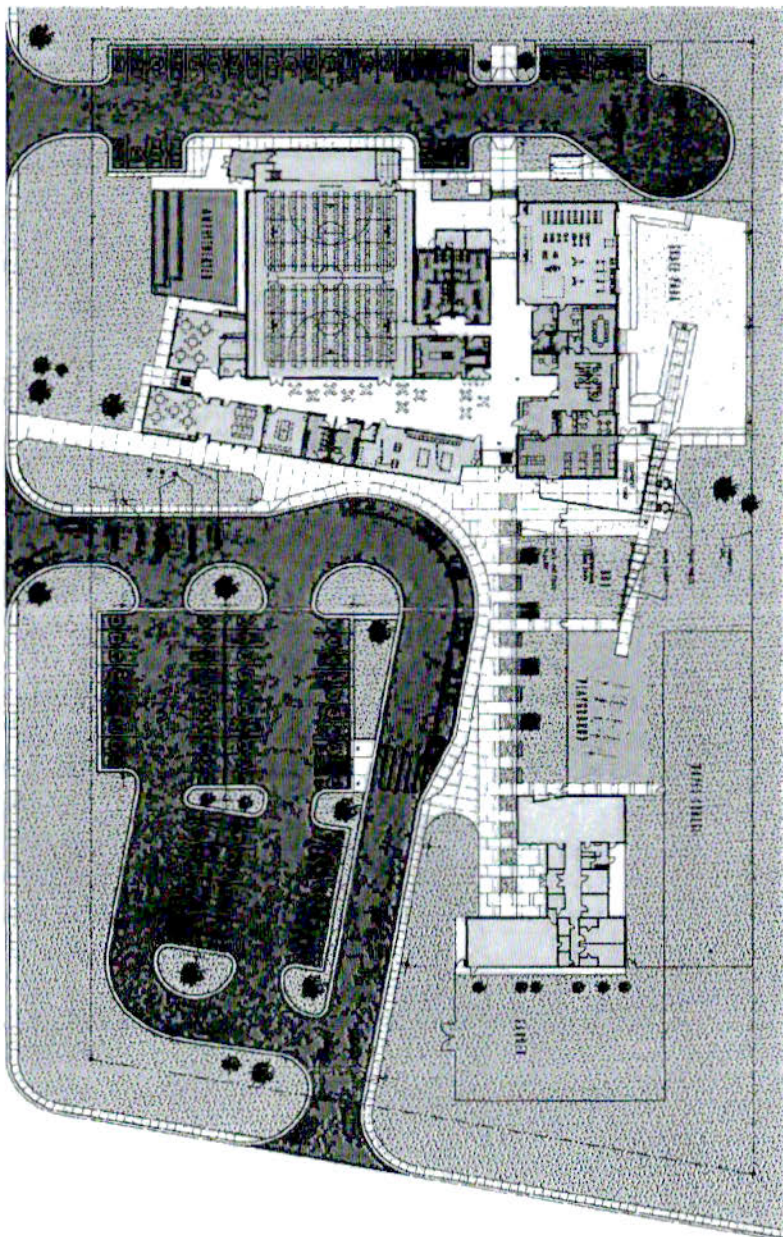
**Through our Counseling Program** our goal is to identify positive alternatives for youth, while emphasizing and encouraging family and social interaction through direct services. Prevention is a healing tool and may be very helpful to youth whom confront various issues involving substance abuse, violence, staying in school and others.

**Through the Career Youth Incentive** The Career Youth Incentive Program it also incorporates preparation for employment; post-secondary education; linkages between academic and occupational learning; and connections to intermediaries for job development assistance. The age groups that we serve are between the ages of 14 – 24 years of age.

Therefore, by building a Crownpoint Youth Complex we will be able to offer outreach programs and information to various Navajo Nation Communities, programs, Navajo Nation Chapters, Counties, and School Districts on or near the Navajo Nation, and to take a lead role to be involved in the youth prevention activities and outreach to reduce crime, alcohol/drug and other substance abuse involvement and boredom due to the lack of infrastructure, operation cost and human resource.
