
PURPOSE: The purpose of this legislation is to confirm the Law and Order Committee's selection of Chair and Vice Chairperson.

Section One. Authority

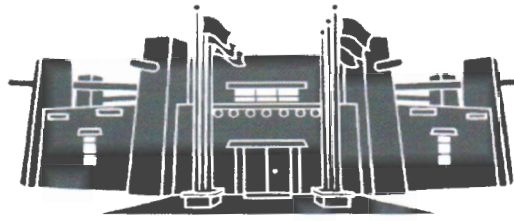
A. The Navajo Nation Council established the Law and Order Committee as a Navajo
Nation Standing Committee. 2 N.N.C. §600(A).

Section Two. Findings

- A. The Law and Order Committee shall consist of five members. 2 N.N.C. § 600 (B).
B. The Law and Order Committee's Chairperson and Vice-Chairperson shall be selected
by a vote of the Law and Order Committee. 2 N.N.C. § 184 (A).

Section Three. Confirming Chairperson and Vice-Chairperson
