## RESOLUTION OF THE NAVAJO NATION COUNCIL

#### 23RD NAVAJO NATION COUNCIL -- Fourth Year, 2018

#### AN ACTION

RELATING TO RESOURCES AND DEVELOPMENT AND NAABIK'ÍYÁTI' COMMITTEES, AND THE NAVAJO NATION COUNCIL; APPROVING COMPLIANCE WITH CAP-26-16 REGARDING FOREST LAKE CHAPTER RANGE UNIT BOUNDARIES AND AFFIRMING DIRECTIVE

#### Section One. Authority

- 1. The Resources and Development Committee is designated by the Navajo Nation Council as the Central Grazing Committee. 3 N.N.C. § 831.
- 2. Pursuant to 2 N.N.C. § 164(A)(9), a proposed resolution that requires final action by the Navajo Nation Council shall be assigned to the Naabik'íyáti' Committee before it is heard by the Navajo Nation Council.
- 3. Pursuant to Navajo Nation Code Title 3 § 705, "The Commissioner of Indian Affairs has established and will retain the present land management districts within the Navajo Indian Reservation, based on the social and economic requirements of the Navajo Indians and the necessity of rehabilitating the grazing lands. District boundary changes may be made when deemed necessary and advisable by the District Grazing Committees, Central Grazing Committee and the Navajo Nation Council, with approval by the Superintendent, Area Director, and the Commissioner of Indian Affairs."

#### Section Two. Findings

1. The Navajo Nation Council passed Resolution Number CAP-26-16 entitled Adopting and Confirming the Range Unit Boundaries and Grazing Districts Established by the Bureau of Indian Affairs for the Navajo Partitioned Lands. Resolution CAP-26-16 was certified on April 28, 2016 and is attached as Exhibit A.

#### 2. CAP-26-16 stated:

In the best interest of the Navajo Nation, the Navajo Nation Council hereby adopts and confirms the range unit boundaries established by the Bureau of Indian Affairs. For areas not included in range unit boundaries, the following range units of the Navajo Partitioned Lands shall be adopted:

Precinct 1, consisting of 19 range units in Tolani Lake, Low Mountain, Teesto, White Cone, and Jeddito, having approximately 177,037 acres.

Precinct 2, consisting of 17 range units in Forest Lake, Black Mesa, Hard Rock, Pinon, Blue Gap and Whippoorwill, having approximately 466,588.2 acres.

Precinct 3, consisting of 15 range units in Tonalea, Shonto, Chilchinbeto, Kayenta and Black Mesa, having approximately 262,758.2 acres.

3. After the adopting the Precincts and range units, CAP-26-16 also states:

Allow Navajo Partitioned Land Chapters 120 days to make proposed alignments for range units through: 1) chapter resolutions, and 2) grazing committee resolutions. Division of Natural Resources is directed to stake proposed range unit boundaries in Precinct 2, provide chapters with large maps of individual proposed range units, and provide detailed information on number of cancelled permittee(s) from that range unit, living cancelled permittee(s) and non-living cancelled permittee(s) for possible heirs who live in that range unit to get agreement on alignment changes through resolutions or the proposed alignment will stand for which exterior fencing will begin.

- 4. The Navajo Nation Council amended CAP-26-16 approving an additional 60 days for the Navajo Partitioned Land Chapters to make proposed alignments for range units. See CO-53-16, passed on October 19, 2016 and certified on October 27, 2016.
- 5. The additional time approved in CO-53-16 was based on the request from Forest Lake Chapter, through Resolution No. FLC-16-07-002 dated July 29, 2016, to request additional

days for Navajo Partitioned Land Chapters to make proposed alignments to the range units.

- 6. The Forest Lake Chapter Resolution, FLC-16-07-002, stated that the chapter made attempts to obtain information regarding the range units from the Resources and Development Committee and that the chapter is making every effort to meet with families in its chapter and adjacent chapters to adjust the proposed range units.
- 7. The Forest Lake Chapter held a number of meetings to discuss the range unit issue and memorialized comments from the community and the District Four Grazing Committee which resulted in a Resolution devising an alignment plan for certain range units, namely 309 and 311, by consent of the community members and requesting an opportunity to present the proposed amended range unit plan. See Forest Lake Chapter Resolution, FLC-16-08-006 attached as Exhibit A.
- 8. It is in the best interest of the Navajo Nation to approve Forest Lake Chapter's compliance with CAP-26-16 and to approve the recommended proposed alignments to the affected range units.

## Section Three. Approving Compliance with CAP-26-16 and Affirming Directive

The Navajo Nation approves the recommendations of the Forest Lake Chapter, in compliance with CAP-26-16, notwithstanding the time limitation, with regard to the proposed alignments for range units 309 and 311, directs the Division of Natural Resources to comply with CAP-26-16 with regard to staking proposed range unit boundaries, providing maps to the Chapter, and providing detailed information on permit holders.



Resolution of the Forest Lake Chapter FLC-16-08-00

The Forest Lake Chapter strongly recommends District Grazing and the Resource Development Committee to study and reconcile the attached Navajo Partitioned Land (NPL) Range Unit alignments as proposed by the Forest Lake Chapter before approving Navajo Nation Council (NNC) Resolution. CAP 26-16.

#### WHEREAS:

- Pursuant to the Local Governance Act, 26 N.N.C., Chapter 1, Sub-Chapter, Section 3 (a) The Forest lake Chapter is continued as a Certified Chapter of the Navajo Nation by the Navajo Nation Council Resolution number CAP-34-98; And
- 2. Pursuant to Chapter 1, Section 131 (1) (2), of the same Act, the Chapter has the responsibility and authority to promote, protect and preserve the interest and general welfare including the safety of it community, people, programs, property, etc.; And
- The Forest Lake Chapter's entire boundary is located within the Navajo Partitioned Land; the Chapter includes Eleven (11) Range Units which includes 101, 302, 303, 305, 306, 308, 309, 310, 601, 602, and 603; And
- 4. Eight (8) of the Eleven (11) Range Units are part of the Forest Lake Chapter and these Range Units also affect the Hardrock, Pinon, Black Mesa, Kayenta, Shonto, and Chilchinbeto Chapters. Three (3) of the Range Units are within the Peabody Western Coal Company Lease Boundary; And
- The Forest Lake community members met with a Resource and Development Committee on June 6, 2016.
   The time clock for a 120-day deadline was already running and the deadline date was slated for August 26, 2016; And
- 6. The Forest Lake community members joined together to pursue the NNC Resolution CAP 26-16 Amendment by having numerous meetings of constituents in the affected Range Units to propose realignments in a manner to preserve their livelihoods and protect their principles, beliefs, and customary use: And
- 7. The Forest Lake Chapter community members worked together and devised alignment plans which assured there were consent agreements between people living in the area and their neighbors; And
- 8. The Attached documents, exhibits and maps are documented as transparent agreements which will be presented before the NNC Resource and Development Committee to determine changing alignments from its original Bureau of Indian Affairs (BIA) Range Unit Boundaries, And
- The Forest Lake Chapter supports and recommends immediate approval and implementation of this
  Resolution and strongly believes that this resolution is in the best interest of the Navajo Nation, Forest Lake
  community, and NPL residents.

#### NOW THEREFORE BE IT RESOLVED THAT:

- 1. The Forest Lake Chapter strongly recommends the District Grazing and Resource Development Committees to study and reconcile the attachments (Exhibits) Navajo Partitioned Land Range Unit alignment as proposed by the Forest Lake Chapter before approving the NNC Resolution CAP 26-16.
- 2. The Forest Lake Chapter further request the District Grazing and Resource and Development Committee to give opportunities to members of the Forest Lake Chapter land users to present their proposed amendments.

#### **RESOLUTION OF THE DISTRICT 4 GRAZING COMMITTEE**

## APPROVING THE RANGE UNIT BOUNDARY LINE TOP HALF OF 309 AND 311 LINE WHERE IT MEETS 310 TO BE MOVED WESTWARD AND REQUESTING THE RESOURCE DEVELOPMENT FOR THEIR SUPPORT AND APPROVAL

#### WHEREAS:

- The District Grazing Committee of the Navajo Nation were established by the Navajo Tribal Resolution CJ-6-53 and Navajo Tribal Advisory Committee Resolution ACA-1-55 and CAN-83-57; and
- The District Grazing Committees are administered bodies within the Navajo Nation
   Government with primary responsibilities of managing range land, livestock management,
   enforcing Navajo Grazing Regulations, and other related land use issues on the Navajo Nation;
   and
- 3. Pursuant to 3 NN SS852 (C), the Resource Committee will serve as principal coordinators between the District Grazing Committee and the Bureau of Indian Affairs; and
- 4. In October 1973 the Federal District Court cancelled all grazing permits in Executive Order Reservation Exclusive of Hopi Grazing District 6 and in 1974 Congress enacted PL-95-531 authorizing (25 CFR, 161) the Bureau of Indian Affairs in coordination and consultation with the Navajo Nation will re-issue grazing permits in Navajo Partitioned Lands; and
- 5. Under section 161.202 (a) the BIA with the concurrence with the Navajo Nation will establish the range unites on NPL for which range management plans can be developed to improve forage, resources, watersheds, residential concentration and historical land use will be considered in determination of range unit boundaries and (b) BIA may modify range unit boundaries with concurrence of the Navajo Nation; and
- 6. The BIA established proposed boundaries in all of NPL and in Oak Ridge Community, Forest Lake Community, and Ta'iit'!' community have agreed on an alternate boundary line; and
- 7. The current boundary line is a few yards from the homesites of the Oak Ridge Community, does not allow the Oak Ridge Community (7400 feet elevation) access to lower elevation areas (7200 feet elevation) which they rely on in winter months, and does not allow access to their ancestral home sites located north, northeast, and east side in Range Unit 311; and
- Resource and Development Committee, Navajo Nation Council Legislation 26-16, as amended
  gives 120 days from the date the legislation was approved to allow local residents an
  opportunity to make adjustments of range unit boundaries to fit their living more closely; and
- The community held several chapter meetings out in the field and at the chapter house to discuss the proposed changes and large majority agrees with the change and it appears to represent in the best interest of range unit 309; and
- The Oak Ridge community are fenced into high elevation (7400 feet) land by 309/310 of snow accumulation in unbearable; and
- 11. The Oak Ridge community which consist of five major families are claim some ancestral homesites, corrals, and farmlands, which they would not have access anymore due to the 309/310 boundary lines.

#### NOW THEREFORE BE IT RESOLVED:

The District 4 Grazing Committee, with the support of the Forest Lake Chapter hereby approves the top half of Range Unit 309 and 310 line to be moved southwest as four communities (see three attachments, Exhibits A, B & C) and also see (map exhibit D and description of land boundary lines exhibit E) are in agreement of the boundary extension towards Range Unit 309 and that will accommodate the Oak Ridge Community. And furthermore request the Resource Development Committee to approve the adjustment.

Dear Forest Lake Chapter President, Ms. Helena Begay; Council Delegate Mr. Dwight Witherspoon; Grazing Representative Ms. Irene Begay; Chapter Members:

#### **RE: REQUESTING FOR SUPPORT AND RESOLUTION**

An amendment of 120 days extension was granted at the request of Mr. Dwight Witherspoon to Legislation 0093-16 for the Range Units to come to an agreement of the re-alignment of the boundary BIA established for RU 302 and 309.

The boundary line put in place by BIA is almost half way into Range Unit 302 and this was done without proper consultation with the residents of RU 302 and failed to follow the existing federal laws and regulations. It seems like the only things taken into consideration when setting up the boundaries were the vegetation, forage, wild life and water sheds. NOT taken into consideration was customary use area, historical and sacred sites. There are other hills and mountains where the boundary line could have been put for water sheds if water sheds were a priority. From RU 302 side, our major concern is that a good portion of land (approximately 2 to 1.5 miles by 6 – 7 miles long) located north of Forest Lake Chapter in the vicinity of Toh Ne Zhonnie Springs is being added to RU 309. For south side of RU 302, we would like the realignment placed along east Dinnebito Wash. In this area my great grandmother and grandparents used this area primarily for grazing livestock. So at this time we would like to preserve the area for grazing of livestock only. In the Toh Ne Zhonnie Springs area there are old hogans and sheep corrals still standing that were used by our grandparents. Some hogans were used for sacred ceremonies. On southwest side, we are asking for the pocket of Della's homestead and our ancestral

scay

cornfield. Tradition and culture encompass, consideration for customary use area, historical and sacred sites. The residents of the proposed RU 302 are respectfully asking to realign 302 to include range used by our grandparents. We like to realign RU 302: east, south, and southwest sides. The residents on the northwest, north, and northeast border the Hopi Partition Land, therefore, no realignment is required on this side. Most importantly, RU 302 is respectfully asking BIA to leave behind all the rules of bureaucracy and all the fancy talking and meet us half way to resolve the issues of re-alignment of RU 302 and develop good relationship between the Range Units 303, 309, 308 and 310.

Because of the apparent existence of the boundaries and BIA's lack of concern for the best interest of Range Unit residents, we must inform our Navajo Leaders so that they would have a good working knowledge of our issues and concerns.

Range Unit 302 has been solely responsible for the preparation of this letter expressing our concerns and thus far without the use of any legal help.

The items listed below and the above statements are why NEW boundaries should not be put in place but rather re-align the boundary.

- 1. The following are the premittees and re-issuing of permits to the heirs should be a priority if the original permittees are deceased:

  - b. Asdzaa'h Nanithode
  - c. Roy Huskie

- 2. Too much surface land from RU 302 is being added to RU 309 and RU 309 is also gaining land from RU 308. How did this happen and why?
- 3. On the last inventory, the new BIA boundary is creating less vegetation and forage because a large area is being added to RU 309 from RU 302. Not only that but we are told that two new families with permits are being added to RU 302. We feel that there is not enough grazing area if new permittees are added onto RU 302 and IF the new BIA boundary is left as it is.

#### **Forest Lake Chapter Range Unit Meeting**

#### August 19, 2016 @ 10:30AM

#### "NOTES"

Gloria Johns started the meeting around 10:30AM. She reviewed the agenda that she wrote on the board.

Gloria went over the history of the Range Units listed on the agenda. Several Range Unit meetings have been held going back to maybe February or March 2016. At first it was just Range Unit 302 meeting when it was discovered that the BIA had drawn boundary line putting most of the customary use area from RU 302 into Range Unit 309. Started having Range Unit meeting with 302, 303 and 309 and later 308 and 310 joined in to ask Resource Development Committee (RDC) for an extension of 120 days to work out re-alignment of the boundary lines put in place by the Bureau of Indian Affairs.

We had Walter Phelps and Dwight Witherspoon attend our range unit meetings at one time or another.

What is the purpose of requesting to have a boundary re-alignment that BIA implemented? We will need to submit our paperwork to the chapter officials along with a map on Monday at the Forest Lake Chapter meeting. We also need to let the residents of each range units know what is going on and make sure they are in agreement with the re-alignment that are being requested. We have requested the chapter officials to have their meeting on the 22<sup>nd</sup> instead of 18<sup>th</sup>. The chapter officials will do one resolution for all range units. If the chapter resolution is approved, it will then go to Grazing Officials. The Grazing officials will meet at a special meeting on the 23<sup>rd regarding</sup> the resolution from the previous day. We request for your presence again at this special meeting. After the Grazing Officials meeting, and if they approve the resolution, then it will go to RDC.

We lost a whole month of the granted 120 day extension because we were not notified when the first day began which was April 21st. We are requesting for another 30 day extension in place of the month we lost at the start. We don't know if the 30 day extension will be granted or not. Therefore, have all your papers ready for chapter officials on Monday, the 22<sup>nd</sup>.

We had several RU meetings for several months now. By now you have probably realized that we all need to take care of the land we use. And how are we going to take care of the land for future generations. We are not saying the land belongs to me. We are just saying we need to take care of the land. Over grazing is the main issue here. Along with erosion control. Water dikes. Coming to these meetings has also reintroduced some lost relatives.

302 and 303 have elected officers comprised of president, vice-president and secretary.

Before we go into up-dates on RU status let me brief on the Dept. of Agriculture. Dept. of Ag said they were going to help us. They passed out papers and that was it. We were supposed to be working with them on the grazing permits that were cancelled. Number of cancel permits, provide maps. But none has happened.

Kescoli: She was told Hands Off on Peabody Lease Area and Hopi Partitioned Land.

Man: BIA might turn around and tell us to pay for the land that we are using. Gloria said it was already in the document that one day there will be a fee.

Woman: I don't think the boundary line the BIA established can be changed. Believe it is meant to stay as is.

#### Range Unit Up-Date Reports:

Eddie Etsitty on RU 302: Briefly went to tell about attending Land Board meeting at Fire Rock Casino August 8-9, 2016 where Leo Watchman stated that NN Land Administration is trying to do away with consent from neighbors when individuals requesting for home-site lease. Mr. Watchman disagrees with doing away with consents when requesting for home-site lease. Individuals still need to get consent from people living in the area already.

My relatives, brothers, sisters, aunties have talked and are talking about putting the boundary line back to customary use area. Because a big chunk of the land our grandparents and parents use to use in now in RU 309. And we understand that RU 309 will also be gaining some land from RU 308. We would like to negotiate with 309 regarding the re-alignment.

Range Unit 303: We agree with the way things are.

Priscilla Bahe: We use that area you are talking about and we also do traditional ceremony. I resigned three years ago so I can take care of my place. So we would like to keep that area you are talking about.

Gloria: I don't think that the boundary line the BIA established means that we will be fenced in with no way out. I believe that we can still go across the fence for our use. We can come to an agreement with our neighbors about using land across the fence. But I think this is something that is not going to happen with the next few days, months. It will be sometime before the fencing happens. Regarding RU 308. We were raised in the area. Ashii clan. It will probably cost a lot of money to do all the fencing. The meetings has brought relatives together and where we are coming from. Clan history. Shedazhie and shima said they are requesting for a corner area of 308. So leave as is. 308 leave as is.

RU 309 we will leave as is. We will work with sheyazhe, Eddie on his request to re-align boundary.

Jerry Begay: We use to move into RU 308 in the winter. Tse el ka roadway. Our grandmother use to live there. And our cattle moves down into RU 308 in the winter. When it snows deep, cattle moves down there on their own and come back up in the spring.

Older James sister: Jerry Begay does not live or has not live in the area for some time. When I was a little girl my family and I use to live up the Pretty Water area. There were no chapter officials at that time. People just lived close together and they use to help one another. Gloria and her brother Marshall are intimidating residents of RU 308. They are telling us to move back where we came from. You (Gloria) are talking about a land that you are not from.

Gloria: I don't appreciate what you just said. I am not doing this for myself only. I am doing it for all my people. So what you are saying is not true.

Sarah James: The lady that just spoke is my older sister and we live in the area SW, 306 and 308, we still have a claim to that area of where the Silver live. And Gloria is pushing the Silver family onto us. And we would like for that to stop.

Gina Johnson: I would like to say something on my behalf regarding what everybody is saying about my family and RU 308. Why are we saying this to one another as Ahshii clan? Have you no respect for me as a born for Ahshii clan? We need to stop pointing fingers at one another and start working together. And quit blaming my sister Gloria and my brother Marshall for everything that is going on. Have you no respect for my mother who is probably the oldest living mother in the Forest Lake area. She is 90 YO. Show some compassion for her. That is all I have to say.

Johanson: We come to you from Oak Tree Hill area, RU 310, Todeschini clan and our mother is in a nursing home and we are the children and grandchildren that are concern about the boundary the BIA establish. We have been having these RU meetings and at those meetings we were all saying that the b boundary the BIA establish is not agreeable to some of the residents of these range units. Some of those boundaries are going across our already existing homes. Separating home-sites. We also agreed that the BIA does not know how we exist, our life style, up in these rural areas. And now Gloria is saying we are going to leave the boundaries as the BIA has established. What happened to saying that we do not want what the BIA has done with the boundaries without any consideration about how we live and are surviving? Did we all wasted our time and efforts for nothing in working on our paperwork to establish boundaries those we can live with? What happen to all the saying that we do not have to live with the boundaries the BIA is putting in? And I do not agree what Gloria said earlier about sharing grazing area over the fence. Once we are fenced in, we will only be allowed a certain amount of livestock to graze in the fenced area. I am sure I will not say, sure come over and I will open my gate and bring your sheep or cows over to my fenced area and let your livestock graze in my area. I do not believe any of you will say that to me or anyone that is living on the other side of the fence either. You are just telling us that we can share fenced area to fool us and lay to us because no one is going to do that. That is reality. And when we met we said to one another that we need to submit a proposal and or a resolution for our re-alignment request. Me and my younger brother have been meeting with the residents of the RU to come to an agreement on the re-alignment. We met with the Koscoli and they agreed to our request. Don't understand why the BIA boundaries are all crooked. Boundaries are set like you are just playing around. They must have a lot of money to waste running fencing all crooked. Why not fence in a straight line. Makes a lot sense to fence in straight line to save money and man-power. We visit the residents and we approach their homes in a friendship way. We don't want to create a

hostile environment with the RU residents. Us older people should have respect for one another instead of getting into a heated argument. We don't want our children in the same situation because our children and grandchildren are not as patient as we are. They are short tempered. And again I would like to say again that I really don't believe us sharing grazing area as Gloria is saying. No one is going to do it, don't care what anybody says.

RE: Proposed realignment of Range unit 302 and 309

On behalf of my Haas'kanhadzohi clan people. My great grandmother, Asdzaalh Nanithode and my great grandfather lived in common with the Asdzaalh Asiih and her clan people in the Toh Ne Zhonnie Springs area for along time, not just for water but ceremonies as well. In recent years we utilized the area mostly for traditional offerings. However, my late grandparents Todachine Nez and Grace Todachine, and their family have used the Many Greasewood Valley aka Coal Valley Wash in common with our neighboring Asiih people for grazing cattle for years. The practice is still in existence.

We have asked our neighboring relatives for the re-alignment thru the Coal Valley Wash. A recognized permit holder, Mary Bitsuie, acknowledge our common grazing area a long standing agreement between my late grandparents, her late parents and other elders who have passed. At one of our range meetings she announced she is standing firm on this boundary. I understood this to be our agreed boundary. The spokes person for Range 309, decided to pull the agreement because we will not settle for the next valley, Sweathouse Valley. This didn't seem right. Mrs. Gloria Johns and family have in recently years obtain homesite leases in this protected area. Why? It appears she is the one who is moving the boundary further south.

The spokesperson for Range 309 has not been working with us faithful. As we were all under the impression we were going to realign the boundaries, in the end, she elected with draw her plans and go with the original BIA plans. Further more, she attempted to be crafty in submitted her request. At the chapter meeting on August 22, 2016, after our request for alignment was passed, she decided with draw her proposal and submit separately as soon as we left the chapter house. She receive opposition for her plan as it had been approved as a group. We return and to hear her stand, then decides to withdraw her request. She indicated she would present it the Special Grazing Meeting the next day. At the Special Grazing Meeting I learn that she went with original plan. I believe her plan is not completed in good faith as she has bluffed and proved to a crafty person during recent meetings.

The memorandum is being written because we still live in the proposed Range 309. Our customary grazing area was divided in 3 range units 302, 303 and 309. It would have been ideal to realign so we work with other extended family members who live in Range 302 faithfully. In the early 1980s we learn of BIA alignment plans. We tried to work with them, however in the presence of former Navajo Partition Land Director, James Dee, BIA officials informed my grandparents and mother that we are actually blessed with our customary land use being divided. They indicated in in years to come each of grandchildren of schildren could live in each unit and get grazing permits. I pray this will happen.

Your time and patience in reading and reviewing the documents submitted is very appreciated. Your decision will be respected. Again review the Range unit 309 plan with care as it maybe deceitful.

#### Whereas:

- 1. Pursuant to the Navajo Tribal Council Resolution: C-20-35, the Forest Lake Chapter of the Navajo Nation was established possessing full authority to act in the best interest and welfare of its constituents; and
- The Navajo Nation, through its Purposed Range Unit Management Plan and Master Plan, which
  included goals for: improvement of quality of life, production, landscape as to the 1998 goals
  regarding land and livestock use pursuant to established Navajo Partition Land(NPL) regulations
  for use; and
- 3. The Navajo Nation published for comment on March 23, 2016 proposed legislation titled: "An Action Relating to Resources and Development NAABIK'IYATI' Committee and The Navajo Nation Council: Adopting and Confirming The Range Unit Boundaries and Grazing Districts Established By The Bureau Of Indian Affairs For The Navajo Partitioned Lands (Legislation No. 0093-16)," wherein it creates a comprehensive plan to address NPL lands including those lands located within the Forest Lake Chapter; and
- 4. A proposed amendment was submitted to Legislation No. 0093-16, include the following language: "Allow Navajo Partitioned Land Chapters 120 days to make proposed alignments for range units through: 1) chapter resolutions and 2) grazing committees' resolutions. Division of Natural Resources is directed to stake a proposed range unit boundaries in precinct 2, provide chapters with large maps of individual proposed range units, and provide detailed information on number of cancelled permittee(s) from that range unit, living cancelled permittee(s) and non-living cancelled permittee(s) or possible heirs who live in that range unit to get agreement on alignment changes through resolutions or the proposed alignment will stand for which exterior fencing will begin;" and
- Lorenzo Yazzie (C#2698) and Lorene Greyeyes (C#123320) and family members are lifetime
  residents of the forest Lake community, with established dwelling, grazing and planting fields
  and the overall use of the family's customary use area for five generations; approximately since
  1700; and

- 6. Lorene Greyeyes and her family have always resided in the 303 Purposed Range Unit with her father, Lorenzo Yazzie (C#2698; Permit No. 4-5434 with 11 siblings, their children, grandchildren and great grandchildren. Their customary use area is approximately (5) Five miles wide and (8)eight miles long, which include (2)) two grazing permit and were issued according to estimated land base in January 2,1941, Part 22, 25-CFR which have always been under the jurisdiction of the Forest Lake Chapter; and
- 7. Lorene Greyeyes and her family object to the proposed amendments to Legislation No.0093-16 to the extent it reduces the family's customary use area established on January 02, 1941, because the established and recognized areas and the new amendment will subject the family's established customary use area to division and reduction from encroaching individuals who are already situated in 306 Purposed Range Unit, namely Rita Benally and Mary Lou Slim; and
- 8. Lorene Greyeyes and her family further object to the proposed amendments to Legislation No. 0093-16 to the extent it will allow non community and unofficial community member to improperly influence the determination for boundaries and demarcation of already established customary use areas, including to redistrict the Forest Lake Chapter boundaries by a wide margin, namely Percy Deal a member of the Hard Rock Chapter.

#### THEREFORE be it RESOLVED that:

- The Forest Lake Chapter is in agreement with Resource and Development Committee and the proposed Legislation No. 0093-16, and further acknowledge that it is the best plan for range unit improvement and regulation for NPL located within Forest Lake Chapter; and
- I, Lorene Greyeyes respectfully request that The Forest Lake Chapter hereby approves and
  acknowledges that Lorene Greyeyes and her family as described herein, may continue and
  exercise all right conferred for grazing, planting and homes as already established within (5) five
  by (8) eight mile customary use area within the 303 Purposed Range Unit; and

We have not been notified formally regarding the realignment meetings at the Chapter level. Some of us did not participate in any decision making or approved of realignment in the 120 days extension at the Forest Lake Chapter. We only approve of what is established by the BIA for NPL because it is very fair and assessed.


I really do not think it is a wise choice to allow non official residents of any community to be designated to make decisions on The Purposed Range Unit Boundaries. It makes the committees' authority vague where Officials making their own interpretation of delegation in any way that suits their personal agendas.

It is unfortunate that some of us with few in clan system, non dominate society and without power over our original The Legitimate 1941Customary Use Area that was established according to 1941 Estimates, Surveys and Decisions on issuance of Grazing Permits that was provided to whom ,how many acreage with how many livestocks were allowed to certain acreage to be divided by another family that have established customary use area 306 Purposed Range Unit under Precinct 2 Forest Lake Chapter..

There is no legitimate reason for Rita Benally, Mary Lou Slim and Percy Deal to claim portions of our Customary Use area when they have sufficient Customary Use Area of their own in 306 The Purposed Range Unit. Attached reports of incidents they have demonstrated upon us with no current solution. We have exhausted all remedies to solve the dispute because Rita Benally and Mary Lou Slim do not abide by regulations. The worst part is they involve families and their children like an organized gang.

- 4. My immediate family members and relatives well all be located in range unit 303.



- 4. Under Section 161.202 (a) the BIA with the concurrence of the Navajo Nation will establish range units on NPL for which range management plans can be develop to improve forage resources, watersheds, residential concentration and historical land use will be considered in determination of range unit boundaries and (b) BIA may modify range unit boundaries with the concurrence of the Navajo Nation; and
- 5. The BIA established a proposed boundaries in all of NPL and in Hardrock Chapter there are two range units (304 and 305), there is no opportunity in 304 to adjust any of the boundaries due to the Hopi Partition line and in range unit 305 in the most northern portion of the unit where it joins range unit 303 the propose BIA line divides one family into two units, takes approximately 80% of the family's grazing land and it separates them from their cornfield; and
- The proposed changes involving range units 305 and 303 have an agreement from the local immediate resident, however it does need approval from Forest Lake chapter; and
- 7. Resources and Development Committee, Navajo Nation Council Legislation 26-16, as Amended gives 120 days from the date the legislation been approved to local resident an opportunity to make adjustment of range unit boundaries to fit their living more closely; and
- 8. The community held several meetings out in the field and at the chapter house to discuss the proposed change and majority agrees with the ajustment and it appears to represent the best interest of range unit 305.

Now Therefore Be it Resolved That

The Hardrock Chapter hereby approves Range Unit 304 as is and also approves Range Unit 305, subject to approval by Forest Lake chapter as adjusted by the residents making minor adjustment in the far northern portion of range unit 305 where it adjoins Range Unit 303 and further pursuant to 25 CFR. Parts 161.202 (b) request the District Grazing Committee and the Resources and Development Committee, Navajo Nation Council to approve the adjustment.

- The community held several chapter meetings out in the field and at the chapter house to discuss the proposed changes and large majority agrees with the change and it appears to represent the best interest of range unit 309; and

- The Oak Ridge Community are fenced into high elevation(7400 feet) land by 309/310 boundary line, which is not suitable for their animals in the long winter months and the depth of snow accumulation is unbearable; and
- 10. The Oak Ridge Community which consist of five major families are claim some ancestral homesites, corrals, and farmlands, which they would not have access anymore due to the 309/311 boundary lines.





The Range Unit 309 will remain as is, however we are in full support of Oak Ridge community's request to extend Range Unit 310 south into Range Unit 309, Oak Ridge (Tse Ch'il Bil Dah Yisk'idi) per Exhibit "B". This will provide access to their ancestral land use.

We are pleased to have been given the opportunity to provide extended time to meet with our community members to discuss ways to carry on our traditional way of life. More importantly to care for the ianc.

Our great-grandparents come upon the Dzil yijiin region returning and/or escaping the "Long Walk" (Hweedi) Fort Sumner, NM. They established a strong land use base on their traditional beliefs and knowledge and we strongly value these historical information and clan lineage of the Saanii Ashiihi.

In the 1930's, the Range Riders came upon the land of Dzil Yijiin area to create and establish customary use area by natural boundaries and landmarks for our great grandfather Hastiin Kiyaa'aanii Diil who was married to our great-grandmother Asdzaan Ahiihi. Majority of the customary use area is in Range Unit 309. Though families are divided among Range Units 303, 308 and surrounding Range Units, however we will continue to utilize and care the land. Our great-grand parents, grandparents, parents utilized the customary use area to care for their animals and the land. They cared for the land by rotating grazing areas based on the seasons, winter and summer camps, built earthen dams for water catchments, established several area for corn fields. Therefore, they knew and practiced the traditional land management system including respecting the wildlife, plants, vegetation, seasons, herbal medicine, spiritual connection with traditional prayers and ceremonies.

Therefore, as the generation of the Ashiihi Clans of today and for our future generation, we continue to live on the land of our ancestors. We fully support keeping Range Unit 309 as is, and to extend Range Unit 310 south into Range Unit 309, per Exhibit Signatures (C). In addition,


continue planning for land management as specified in the 25 CFR Part 161 and the Navajo Nation guidelines. In coordination with resources available from BIA and the Tribal entities.

We appreciate your support and approval on our request. Again, thank you as you provided extended timeline to complete our discussion on the boundary line modifications.


