AN ACTION

RELATING TO RESOURCES AND DEVELOPMENT; REVIEWING AND APPROVING THE SACRED EAST BOTTLED WATER PROJECT ECONOMIC DEVELOPMENT PLAN FOR USE OF THE BUSINESS AND INDUSTRIAL DEVELOPMENT FUND

Section One. Standing Committee Powers and Authorities

- A. Pursuant to 2 N.N.C. §§ 500, the Resources and Development committee is hereby established as a standing committee of the Navajo Nation Council.
- B. Pursuant to 12 N.N.C. § 1704 "[t]he Resources and Development Committee shall review and approve all proposed economic development plans which require use of [Business and Industrial Development Fund] BIDF money, and shall be the central point of contact for all economic development activities utilizing BIDF money. Further, the RDC shall have the authority to establish a process and procedures for review and approval of purposes and projects utilizing BIDF money."
- C. Pursuant to Resolution EDCJ-01-10, the Former Economic Development Committee (predecessor to the Resources and Development Committee) enacted amendments to the Tourism, Commercial and Industrial Development Operating Guidelines (Operating Guidelines).
- D. Section 7 of the Operating Guidelines lists the requirements to be satisfied for the processing of any request for financing from the Business and Industrial Development Fund. One of the requirements is that "[t]he plans for the project must be reviewed and approved by the RDC (formerly the EDC), through a Resolution certified by the RDC (formerly the EDC) Chairperson."

Section Two. Findings

A. Pursuant to 12 N.N.C. §§ 1702, as amended by CAP-29-12, the Business and Industrial Development Fund was established to create "a special Navajo Nation monetary account to provide

financial assistance for business and industrial development purposes and projects located within the territorial boundaries of the Navajo Nation. The BIDF will be utilized for tourism, commercial and industrial development projects, small business development projects, and other economic development purposes and projects, through financial assistance in the form of a Direct Loan, Direct Investment, Loan Guarantee, or Debt Security, as provided for in § 1705 C.1. of this Act. The BIDF may be utilized to leverage or facilitate other non-BIDF sources of funding for project development and implementation."

- B. Pursuant to 12 N.N.C. $\S\S 1704$ (B) (1) and (2) as amended by CAP-29-12, the Program Management for the Business and Industrial Development Fund has been delegated to the Division of Economic Development (DED).
- C. Pursuant to 12 N.N.C. § 1704 (B) (1) the DED is delegated the responsibility "[t]o administer and monitor the use of BIDF money for any purpose or project, and to ensure that such use of BIDF money is consistent with this Act and applicable Navajo Nation and federal laws, regulations, and policies.
- D. Pursuant to 12 N.N.C. \S 1704 (B) (2) the DED is delegated the responsibility "[t]o develop policies, proposed regulations and procedures pertaining to specific projects, plans or the use of BIDF money, for review and approval by the RDC."
- E. The eligibility requirements for the BIDF are stated in 12 N.N.C. § 1706, as amended by CAP-29-12. 12 N.N.C. § 1706 states: "Except for any Navajo Nation Entity, compliance with the provisions of the Navajo Business and Procurement Act, 12 N.N.C. §§ 1501 et seq., is a condition precedent to any transactions or granting of any business opportunity, contract, procurement activity; or processing any easement, permit, lease transaction; or considering any loan application by or from the Navajo Nation to any individual, business, corporation, partnership or entity other than the Navajo Nation. Therefore, "eligibility and compliance under the Act" as defined in 12 N.N.C. §§ 1504 must be satisfied and met prior to further consideration and processing of any application or request for project financing through the BIDF."
- F. A Navajo Business and Procurement Act clearance check was conducted and responses were received: In a memorandum dated February 18, 2016, the Accounts Receivable Section, Office of the

Controller, determined that Wilbert Tsosie dba Sacred East Bottled Water Co., Inc. is "Procurement cleared"; In a memorandum dated February 16, 2016, the Credit Services Department, Office of the Controller conducted a Procurement Clearance on Sacred East Bottled Water Co., Inc., and determined that the business does not have any loans outstanding with the Navajo Nation Credit Services Department; In a memorandum dated February 26, 2016 the Office of the Navajo Tax Commission determined that Wilbert Tsosie dba Sacred East Bottled Water Co., Inc., is registered and in compliance with the Navajo Tax Commission. These memoranda and other clearance check memoranda are attached as **Exhibit B**.

G. The Sacred East Bottled Water Company, LLC, has requested a Business and Industrial Development loan for a proposed water bottling plant project to be housed in the former BCDS building in Shiprock, Navajo Nation (New Mexico). The Sacred East Bottled Water Company Project proposed economic development plan is attached as **Exhibit A**.

Section Three. Review and Approval

The Resources and Development Committee hereby reviews and approves the proposed economic development plans submitted by Sacred East Bottled Water Project, attached as **Exhibit A**.

EXECUTIVE SUMMARY

Enclosed is a complete set of documents requesting the Resource and Development Committee of the Navajo Nation Council approve a Business and Industrial Development Fund (BIDF) loan for Sacred East Bottled Water Company, LLC. Sacred East Bottled Water Company, LLC proposes to redevelop a vacant business site and the former BCDS building in Shiprock, New Mexico to house a new water bottling plant and manufacture and package bottled water.

The Shiprock RBDO is requesting a resolution from the Resources and Development Committee of the Navajo Nation Council in support of this proposed water bottling plant project as required by the Navajo Nation Business and Industrial Development Fund Tourism, Commercial and Industrial Development Operating Guidelines and other Division of Economic Development financing programs.

Mr. Wilbert Tsosie is the Chief Executive Officer (CEO) and Organizer of Sacred East Bottled Water Company, LLC. Mr. Tsosie is requesting funds to start the business. The total cost of the project is estimated from \$8 to \$10 million. Mr. Tsosie proposes to retain the services of the Diné Bi Keyah Regional Center, LLC to design an EB-5 immigrant investment opportunity and the Whitman Group, LLC to broker a new market tax credit finance opportunity in order to fund the total cost of the project. Sacred East Bottled Water Company has already obtained an initial \$350,000 in equity investment which meets the equity requirement for the BIDF financing that they are requesting.

The Shiprock RBDO has reviewed the request for funding for financial and market viability of the project. Sacred East Bottled Water Company's due diligence is being performed by the Shiprock RBDO to ensure that the company is eligible according to the Navajo Business and Procurement Act.

The funding request will be forwarded to the Business & Industrial Development Fund Approving Committee for further review and approval. Mr. Tsosie is working with the Division of Economic Development, Project Development Department to apply for the former BCDS business site tract.

Sacred East Bottled Water Company LLC (Sacred East) is requesting \$605,000 from the Business Industrial Development Fund (BIDF) start-up funding for a bottled water manufacturing plant to be located at Shiprock, New Mexico on the Navajo Nation. Sacred East was incorporated in New Mexico on June 21, 2012 as a Limited Liability Company owned by Mr. Wilbert "Will" Tsosie, an enrolled member of the Navajo Nation. The STIM Investment Group of Atlanta, GA invested \$350,000.00 of initial seed capital for the project. The seed capital funding was used primarily for a professional Feasibility Study, Business Plan preparation including financial Pro Formas, sales & marketing analysis, management team recruitment and MBE Certification. Part of the seed funding was employed to investigate various bottled water markets and determine the best point of entry. After receiving over 7.7 million case pre-sale potential, it was determined that Shiprock will be the location of our first plant. Numerous customers buying bottled water in that market, including Basha's, Safeway and others are anxious for us to commence operations.

Sacred East has invested much time and effort in obtaining national certification as an Minority Business Enterprise (MBE), and as such has received formal approval from the National Minority Development Council to offer its products to Fortune 500 companies, i.e. Wal-Mart, Costco, Target, PepsiCo, Cocoa Cola, including large supermarket chains, and other major brand chain outlet that are in the region. Additionally, Sacred East is eligible to enter with Federal Government and States minority 8(a) contracts. There is also marketing of bottled water sales to all four Navajo Casinos, the two Ute Casinos, all the Pueblo and Apaches Casinos in New

The market potential also includes bottled water sales to National Football League (NFL) clients, i.e., the Washington Redskins, Denver Broncos, Dallas Cowboys, New Orleans Saints, etc., and others as they come aboard. To date, Sacred East is the only identified minority owned bottle Water Company that is certified by National Minority Supplier Development Council in this region. Sacred East is also a member of the world's largest bottled water trade group, the International Bottled Water Association (IBWA) and attended IBWA's most recent National Conference, making numerous important contacts and connections, and also receiving tremendous support and encouragement for this project.

Sacred East Bottled Water Company LLC is a visionary concept put together by CEO Will Tsosie with the objective to obtain diversity/minority sales agreements with Fortune 500 companies, and government contracts with both state and federal governments, and . We attempted to obtain capital via private capital markets (Investment Banking route), however the consultant we retained (Venture Capital Investment Group, Los Angeles, CA) suggested doing away with Sacred East's critical minority enterprise business aspect. Along with eliminating the MBE aspect of the business, it also appeared that Mr. Tsosie's role as a minority business owner would leave him not owning the business. Therefore, Mr. Tsosie aggressively took control of the situation, avoiding the takeover by others as majority shareholders of Sacred East, and sought an alternative source of project funding. Now with Mr. Tsosie at the helm, Sacred East has witnessed the recent certification of DBK Regional Center owned by the Navajo Nation as an opportunity to grow the business using EB 5 and New Market Tax Credit funding sources.

With the assistance of \$605,000 in financing from BIDF, Sacred East will now proceed to work with Jay Carter as consultant to obtain the required financing using DBK Regional Center, and New Market Tax Credit. Sacred East has made a formal request to lease the former Wool Industrial Building aka: BCDS building located in Shiprock, NM as their bottled water plant location.

On behalf of myself and the strong team of professionals that have been assembled to make this project successful, I extend my thanks to BIDF for its consideration of this request.





- 1. The Dineh Chamber of Commerce was established in July 2013 as a 501(c)6 non-profit corporation and incorporated under the laws of the Navajo Nation; and
- The Dineh Chamber of Commerce is also established to assist, advocate, create, and develop Navajo-owned and operated businesses within, and the surrounding areas of the Navajo Nation.
- One of the primary function of the DINEH Chamber of Commerce is assist
 developing businesses, and it is within this endeavor that this resolution is aim to
 assist Sacred East Bottled Water Company, LLC (Sacred East) to wit:
 - a.) Sacred East is a Navajo-owned Company that is requesting \$600,000 a start-up capital to launch its operation in the manufacturing of bottled water plant at Shiprock, New Mexico.
 - b.) Sacred East has secured complete financing using EB 5 program, and New Market Tax Credits program, to begin its operation.
 - c.) However, Sacred East needs capital to pay upfront fees and cost to initiate the two programs in operation; in addition, Sacred East will use part of the capital as operating capital to implement its marketing plan to procure client contracts.
 - d.) Sacred East has prepared business plan with financial pro formas in place including market strategies so it will develop a market base by using National Minority Supplier Certification, to gain crucial business relations with Fortune 500 Companies, U.S. Government Set Aside program particularly with U.S. Military agencies, Homeland Security, and FEMA programs.
 - e.) The launching of Sacred East business will create around 167 jobs for local Navajo people in Shiprock and surrounding areas. Sacred East will also promote and create scholarships and internship programs for Navajo Graduate Students studying business.
- 4. Dineh Chamber of Commerce is in full support of Sacred East's business endeavor as herein stated, and herewith recommend, advise, and inform to expedite the funding immediately to Sacred East per their request for startup capitalization.
