Purpose: to approve \$267,184 out of the UUFB to Animal Rez-Q, Inc. to conduct its "Navajo Nation Spay, Neuter, Vaccination Blitz 2022" project across the Navajo Nation, which will consist of 4000 free spaying, neutering, and vaccinations of animals for Navajo Nation residents, to address and mitigate the overpopulation of unwanted animals on the Navajo Nation.

21	SECTION ONE. AUTHORITY
22	A. The Resources and Development Committee is a Standing Committee of the Navajo Nation
23	Council with statutory authority over the Division of Natural Resources ("DNR"). 2 N.N.C.
24	§501(C). The Department of Fish and Wildlife is within the DNR and the Navajo Nation's
25	Animal Control Program is under the Department of Fish and Wildlife. 13 N.N.C.
26	§1700(B)(1), Resolution No. CJY-64-18. The Resources and Development Committee
27	recommends to the Navajo Nation Council the approval of resolutions that will accomplish
28	the Committee's purposes. 2 N.N.C. §501(B)(4)(f).
29	B. The Budget and Finance Committee was established as a standing committee of the Navajo
30	Nation Council with the authority to review and recommend to the Council the budgeting,

appropriation, investment and management of all funds. 2 N.N.C. §300(A), §301(B)(2).

C. The Naabik'íyáti' Committee was established as a standing committee of the Navajo Nation Council with authority to hear all proposed resolutions requiring final action by the Navajo Nation Council. 2 N.N.C. §164(A)(9), §701(A)(5).

D. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A). As such, the Council "... may adopt and approve supplemental appropriations to the Annual Comprehensive Budget during the fiscal year. Supplemental appropriations of General Funds within the current fiscal year are permitted, if and when additional sources of 8 revenues above and beyond the initial or current revenue projections are projected and which are also in excess of the reserve amount set forth at §820(J)." 12 N.N.C. §820(L).

E. The restrictions on supplemental appropriations, including all monies from the Navajo 11 Nation's Unreserved, Undesignated Fund Balance, include: 12

- 13 1. Payment of recurring government operating expenses shall be from recurring revenues, and payment of nonrecurring expenses shall be from nonrecurring revenues such as 14 15 UUFB funds. 12 N.N.C. §820(E), §820(F).
 - 2. Specifically, the UUFB shall not be used for recurring government expenditures or operations. 12 N.N.C. §820(J), §820(L).
 - 3. Nonrecurring revenues such as UUFB funds may be used only after the Controller determines whether or not such revenues are subsidizing an imbalance between the Navajo Nation's recurring revenues and expenditures, and government expenditures shall only be authorized if a long-term (3-year to 5-year year) forecast shows that the operating deficit will not continue; otherwise, nonrecurring revenues will be added to the Unreserved, Undesignated Fund Balance. 12 N.N.C. §820(F).
 - 4. The above provisions in Title 12 may be amended or waived by a two-thirds vote of the full Navajo Nation Council. 12 N.N.C. §820(F), 12 N.N.C. §880.
 - 5. In compliance with 12 N.N.C. §820(F) all UUFB funding requests must be reviewed by the Controller. Such review is also required because the Controller determines which revenues and expenses are recurring and which are non-recurring. 12 N.N.C. §820(L).
 - 6. In compliance with 12 N.N.C. §820(M) all UUFB funding requests must be submitted to the Office of Management and Budget ("OMB") for a budget impact analysis.

7. Supplemental funding such as UUFB appropriations shall lapse at the end of the current fiscal year unless the Navajo Nation Council decides otherwise. 12 N.N.C. §820(N).

A. Animal Rez-Q, Inc. ("ARQ") is a private nonprofit Section 501(c)(3) entity that was incorporated under Navajo Nation law in 2014. ARQ provides affordable animal wellness services to tribal nations. See *www.animalrezq.org.* ARQ's Founder and President is Glenda Davis, who has over 30 years of experience working for the Navajo Nation in various programs involving veterinary services, livestock management, and animal control. EXHIBIT 1.

B. ARQ is requesting \$267,184 in UUFB funds to conduct a widescale spaying, neutering, and 11 vaccination project across the Navajo Nation from April 1, 2022 to September 30, 2022, in 12 13 cooperation with the Navajo Nation Animal Control Program, and Altered Tails Barnhart Clinic in Phoenix, Arizona. Altered Tails is the largest nonprofit spay and neuter 14 15 organization in Arizona. See www.alteredtails.org. ARQ's project, titled: "Navajo Nation Spay, Neuter, Vaccination Blitz 2022" will address and mitigate the problem of the current 16 overpopulation of some 250,000 unwanted animals on the Navajo Nation. ARQ explains 17 the need for this project, its request for funds, and the logistics of its plan to provide free 18 spaying, neutering, and vaccinations of 4000 animals for Navajo Nation residents. 19 **EXHIBIT 2**. 20

C. ARQ has prepared a detailed timeline and budget for its proposed project and expenditures
 of the requested \$267,184 in UUFB funds. EXHIBIT 3. ARQ will also be submitting a
 Navajo Nation Grant Application for its funding request, which will be attached hereto as
 EXHIBIT 4.

- D. ARQ has submitted support letters for its "Blitz 2022" project, from its proposed partners
 the Navajo Nation Animal Control Program and Altered Tails Barnhart Clinic in Phoenix,
 Arizona. EXHIBIT 5.
- E. The Controller has been asked to prepare a memorandum regarding this funding request, to
 comply with 12 N.N.C. §820(F) and §820(L). This memorandum may be provided to the
 assigned Committees and the Navajo Nation Council when this legislation is considered.

F. OMB was asked to prepare a budget impact analysis regarding this funding request, to comply with 12 N.N.C. §820(M). This analysis may be provided to the assigned Committees and the Navajo Nation Council when this legislation is up for consideration.

G. The Navajo Nation has determined that approving the requested UUFB funds for ARQ is a critical priority for the Navajo Nation, to address and mitigate the widespread problem of animal overpopulation on the Navajo Nation.

SECTION THREE. APPROVAL OF \$267,184 FROM THE UUFB FOR ANIMAL REZ-Q'S PROPOSED PROJECT TITLED: "NAVAJO NATION SPAY, NEUTER, VACCINATION BLITZ 2022"

A. The Navajo Nation hereby approves \$267,184 out of the UUFB for Animal Rez-Q, Inc. to implement and conduct its proposed "Navajo Nation Spay, Neuter, Vaccination Blitz 2022" project across the Navajo Nation, in accordance with the attached EXHIBIT B.

B. The \$267,184 in UUFB funds shall be from those revenues that exceed the 10% minimum balance of the UUFB which must be maintained according to 12 N.N.C. §820(J).

C. Pursuant to 2 N.N.C. §820(N), the \$267,184 shall lapse at the end of Fiscal Year 2022 and
all unexpended and/or unencumbered amounts shall revert to the UUFB, unless otherwise
determined by the Navajo Nation Council.

D. Starting thirty (30) business days after the effective date of this Act, the Controller shall
 begin releasing the UUFB funds approved herein to ARQ, provided that an appropriate grant
 agreement, memorandum of agreement, or other legal document establishing a project
 schedule, payment or drawdown plan, fund management plan, or other relevant procedures,
 has been agreed to by the Controller and is executed by ARQ and the Navajo Nation.

E. The \$267,184 in UUFB funds shall be used by ARQ strictly for its "Navajo Nation Spay,
 Neuter, Vaccination Blitz 2022" project, in accordance with the attached EXHIBIT B.

F. As a condition of receiving the \$267,184 in UUFB funds, upon request ARQ shall allow the
Navajo Nation full access to its financial records related to the UUFB funds that ARQ has
received, for the purpose of the Navajo Nation's review and audit of ARQ's expenditures
of UUFB funds, if such audit is determined by the Controller to be necessary or appropriate.
G. By October 31, 2022, ARQ shall submit a written report, and a verbal report if so requested

by the Committee Chairperson, explaining the status of its "Blitz 2022" project and its use of the approved UUFB funds, to the Resources and Development Committee, the Budget and Finance Committee, and the Naabik'íyáti' Committee.
SECTION FOUR. EFFECTIVE DATE
This Act shall become effective pursuant to 2 N.N.C. §221(B) and 2 N.N.C. §164(A)(17).
SECTION FIVE. SAVING CLAUSE
If any portion of this Act is determined invalid by the Navajo Nation Supreme Court, or by a

If any portion of this Act is determined invalid by the Navajo Nation Supreme Court, or by a District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the remainder of this Act shall be the law of the Navajo Nation.



Abstract/Summary

The Navajo Nation Spay Neuter Vaccination Blitz 2022 will give our Navajo Nation, the opportunity to aggressively impact our 250,000 pet overpopulation problem through the completion of 4,000 free vaccinations, deworming, microchip, spay or neuter of Navajo Nation pets.

Animal Rez-Q Inc seeks to coordinate a massive spay/neuter vaccination campaign to strategically deliver the animal services throughout the Navajo Nation. Our organization has partnered with the Altered Tails entity to establish sixteen days of mass spay neuter functions on Navajo and to complete twenty days of drivethrough vaccination clinics on Navajo in 2022. Since the Navajo Nation has a huge land base of 270,413 sq. miles, it is imperative that an on-the-ground entity, Animal Rez-Q Inc complete the communications and leg work needed to develop, implement and successfully assist the delivery of animal services, i.e., Mass Spay Neuter Clinics and Drive-through Animal Vaccination Sites.

Altered Tails is a leader in quality high-volume spay neuters in central Arizona. Given their experience, it is important to bring the professionalism and expertise to the Navajo Nation. Altered Tails currently performs >25,000 companion animal spay/neuter surgeries annually. This team of veterinarians and technicians will take on the task to surgically alter the 4,000 pets on Navajo. We want the best team for this monumental effort and Altered Tails is the organization that can do the work.

The Navajo Nation Spay Neuter Vaccination Blitz 2022 will require the mobilize of the Navajo Nation to create a movement and to finally make an impact on the pet issues that threaten our health and safety. Let's put a stop to the unnecessary suffering of our pets that are starving, abandoned, lie along our highways dead and have to be euthanized because they are uncared for. Let's instill in our children and future generations that this is NOT normal and to bring back the empathy and compassion for the life of a pet. Let's address our pet overpopulation problems head on with an aggressive solution by taking the first step to protect the lives of our children, youth, adults and elderly of the Navajo Nation.

"The Navajo Nation's overpopulation has reached over 250,000 feral and roaming pets", as stated by Kevin Gleason, acting program manager for the Navajo Nation Animal Control Program. Presently, we are in crisis. These pets continue to reproduce uncontrollably. Pets are observed roaming the streets in search of food within clustered housing communities, gas stations, businesses and local fast-food establishments. Many of these roaming animals can be found lying on the sides of our highways, dead from being hit by vehicles. Other feral pets run in packs and attack the livestock of nearby homesites and ranches.

The impact of these 250,000 feral and roaming pets, *threatens the health and safety of our Navajo People.* In May 2021, a young teen was mauled to death by the neighborhood dogs in Ft Defiance, AZ. Another 2016 mauling death was a three-year-old just outside of his grandparents' home in Seba Dalkai, AZ. Over the last ten years, **six** children, youth, adults and elderly have died from dog attacks and mauling events on our Navajo Nation. Our children have to carry sticks to protect themselves from dogs as they play outside. The young and old are unable to enjoy the outdoors for exercise, hiking or camping, for fear of being attacked by roaming dogs. On an annual basis, an estimate of **3,000** children, youth, adults and elderly visit Navajo hospitals with bites and punctures from attacks by vicious dogs. Many of these dog attack victims are scared and maimed for life, many with psychological traumas long after the dog attack wounds have healed. *Stats from the Navajo Nation Animal Control Program.*

Uncontrollable Reproduction

The pets on the Navajo Nation are allowed to reproduce uncontrollably. It has been reported from the Spay USA organization that, "An unspayed female dog, her mate and all of their future puppies and their puppies' puppies, if none are ever neutered or spayed, add up to: 16 dogs in one year to 12,288 dogs in 5 years" (*Exhibit A: ARQ Spay Neuter Pyramid Poster*). Since the Navajo Nation has not had a free spay neuter event since 2005 (Exhibit I: 2005 Free Spay Neuter Poster), it can be estimated, using the Spay USA concept, that we now have a minimum of 37,000 pets from one breeding pair. If we assume that of the 250,000 roaming pets we

presently have and they are breeding pairs, we should expect an excess of 2 million new puppies born within the next year. (125,000 x 16 = 2,000,000)

Present spay neuter services on/near Navajo

There are multiple mobile spay/neuter clinics that visit Navajo Nation to provide services, such as Soul Dog and The Parker Project. While instrumental, *they do not have the capacity* to have more than two surgeons working at a time, *limiting the number of daily surgeries*. Similarly, while Navajo Nation has 2 full-service brick-and-mortar veterinary clinics, those clinics are multi-species, and provide a full gamut of services, not just a focus on spay/neuter.

Data obtained, January 21, 2022, on the veterinary clinics near the Navajo Nation demonstrates that the shear expense and scheduling for a surgery is months out, prohibits our Navajo pet owners from securing spay neuter services. (*Exhibit B: Local veterinary clinic fees near Navajo*) On an average, *it would cost \$241.75 for a spay on 45# female dog* at the clinics on or surrounding the reservation. This cost is an expense that most Navajo families are unable to afford.

Pet services at the Navajo Nation Animal Shelters are being utilized. Observe the lines of vehicles at the Ft Defiance and Shiprock Animal Shelters.

Animal Rez-Q Inc & Altered Tails Partnership

The Navajo Nation is already challenged with significant dog overpopulation; the Nation encompasses over 27,000 square miles with only two veterinary service providers. The needs of the People have not been met for decades, and as a result, the animal shelters have a **7-10%** live release rate with the average feral pet euthanasia of **10,000+** each year.

Spay/neuter has long been recognized as a primary factor in reducing companion animal overpopulation and shelter euthanasia. Due to the COVID-19 pandemic, there were Nation-wide shelter-in-place orders which eliminated spay/neuter across the Navajo Nation beginning in mid-2020. While mobile spay/neuter services are slowly returning to the Nation, these efforts will not be able to meet the incredible need for access to spay/neuter. Instead, an intensive spay/neuter campaign like the Navajo Nation Spay Neuter Vaccination Blitz 2022 must be undertaken to create an initial strong tide of spay/neuter support with the completion of 4,000 free spay neuters, vaccinations, deworming and microchipping of Navajo pets. Funding this proposal will allow Altered Tails to pilot an initial intensive effort (4 MASH-style clinics, completing 4,000 s/n surgeries total), to determine the viability of a more sustained MASH-style campaign on Navajo Nation.

Our vital partner in this project is the Altered Tails organization. *(Exhibit F – Altered Tails Letter of Support)* Altered Tails has the capacity and experience to execute the MASH-style clinics with Animal Rez-Q Inc as the on-the-ground partner essential to not only the success of the NNSNVB 2022, but also in assuring the sustainability of services. *(Exhibit H – Resume' Glenda Davis, Founder & President Animal Rez-Q Inc*)

Impact of 4,000 FREE spay neuter surgeries, vaccination/deworm & microchip

An aggressive spay neuter campaign is the first step to addressing our overpopulation issues on Navajo. The NNSNVB of 2022 will help the Navajo Nation and pet owners get themselves out of a monumental pet overpopulation crisis. This massive spay neuter service of 2022 should be the start of years of proactive planning for future spay neuter, vaccinations and deworming services that are greatly needed on the Navajo Nation.

4,000 free vaccinations, deworming, microchip and the spay & neuter surgeries will definitely assist Navajo pet owners by:

Pet vaccinations will prevent the spread of disease among pets

- An oral dewormer will decrease internal parasite loads
- Your pet's microchip will allow pets and the owner to be in compliance with the new Animal Ordinance, CJY-64-18, for the mandatory microchipping of pets
- Spaying your pet will prevent the birth of additional puppies and kittens; decrease puppy abandonment incidents; decrease the nuisance of female dogs in heat in a community
- Neutering your pet will keep your pet home and decrease roaming

It is encouraging to learn that our Navajo leadership is open to funding an aggressive spay neuter campaign to help our Navajo communities become healthy and safe once again.

Methodology and Outcomes

Goals/Objectives

1.0 Provide 4,000 FREE surgical alterations (spays and neuters) on Navajo Nation pets in four community sites between May and September 2022 by utilizing five surgical teams from Altered Tails.

- 1.1 Each of the five surgical teams will complete 50 surgeries per day for a total of 250 surgeries daily.
- 1.2 Each surgery site will be held for four days, 1,000 animals will be surgically altered each week therefore the four sites will alter 4,000 pets to prevent further reproduction and prevent further pet overpopulation issues.
- 1.3 Community surgical sites are scheduled for: May 24-27, 2022, June 28-July1, 2022, July 26-29, 2022 and August 30-September 2, 2022.
- 1.4 FREE spay neuter services are ONLY for Navajo Nation residents; A utility bill and ID will be required to prove you live within one of our Navajo Nation communities.
- 2.0 Provide 4,000 FREE pre-surgical vaccinations, deworming and microchipping on Navajo Nation pets prior to their spay or neuter surgery between April and August 2022 by Animal Rez-Q Inc and the Navajo Nation Animal Control Program. (Drive-through vaccination services)
 - 2.1 Free vaccinations, deworming and microchip services are ONLY for Navajo Nation residents; A utility bill and ID will be required to prove you live within one of our Navajo Nation communities.

- 2.2 Vaccinations and deworming will ensure that pets are disease and parasite free prior to surgery within each of the four community surgery sites. Services will be completed by Animal Rez-Q Inc and the Navajo Nation Animal Control Program.
- 2.3 Provide microchips to help pet owners comply with the 2018 Animal Control Ordinance, CJY-64-18, mandatory microchip requirement for pets.
- 2.4 Each drive-through vaccination site will be held for five days for four sites within recommended chapters by the Animal Control Program based on dog bite, vicious animal attacks, livestock damage, pet surrender pickup, nuisance reporting and abandonment issue cases logged into DNR dispatch; a total of twenty community drive-through vaccination sites will completed.
- 2.5 Community pre-surgical vaccination sites are scheduled for: April 25-29, 2022, May 30-June 3, 2022, June 20-24, 2022 and August 1-5, 2022.

3.0 Coordinate pet transport teams to bring pets of the elderly in remote areas (without a means to bring their pet(s)) to one of the four surgery sites between May and September 2022 by the first responders of the Navajo Nation.

- 3.1 The first responders of the Navajo Nation are those staff that are in direct communication with Navajo residents and have first-hand knowledge of their communities they serve such as Animal Control Program, Resource Enforcement, Community Health Representatives, Health Educators, Public safety and Chapter leadership.
- 3.2 Utilize the Altered Tails transport van (capacity of 20 pets), and provide ARQ transport kennels to Resource Enforcement, concerned relatives and friends of the elderly to assist with the transport of pet(s) to one of the four surgery sites; and other animal organizations will be encouraged to assist with transport.
- 3.3 Coordination dates are: May 23, 2022, June 27, 2022, July 25, 2022, and August 29, 2022.

4.0 Implement a massive communication platform to announce the Navajo Nation Spay Neuter Vaccination Blitz beginning February to August 2022.

- 4.1 Begin with a Navajo Nation Presidential Proclamation to address the Nation and our Navajo People to take advantage to this opportunity to have pets vaccinated and surgically altered.
- 4.2 Utilizing newspaper advertisement, radio advertisement, billboards, printed flyers and posters.

- 4.3 Utilize social media including Facebook (Meta), websites, LinkedIn and Instagram avenues.
- 5.0 Work with the Navajo Nation Animal Control Program to provide animal surrender sites at each of the twenty pre-surgical vaccination sites between May and August, 2022.
 - 5.1 A combination of services will be required to reduce the number of roaming feral pets and may require the surrendering of animals that the owners are no longer able to care for.
 - 5.2 The Animal Control Program will make an effort to have the socialized, adoptable pets picked up by animal organizations that have the capacity to rehome them off the Navajo Nation.
 - 5.3 It is understood that those surrendered animals that demonstrate aggressive behavior, are not socialized or have disease issues will be humanely euthanized by the Animal Control Program staff.

Approach (Exhibit C – NNSNVB 2022 Timeline)

Once funded, equipment purchase will take place immediately to assure arrival in time for the first scheduled clinic. Target completion date for purchase of equipment is 30 days from the receipt of funds. Additionally, once funding is confirmed, strategic planning and stakeholder discussions will be scheduled to assure for timeliness of any permissions that need to be obtained prior to scheduling of the drive-through vaccination and mass spay neuter clinics. Target completion date for stakeholder discussion is 30 days after receipt of funding.

Coordination of targeted drive-through animal vaccination sites and mass spay neuter sites

Animal Rez-Q Inc will be working with the Navajo Nation Animal Control Program to determine sites that have an extreme number of bites cases, livestock damage, surrender and abandonment issues & nuisance calls. These will be the sites proposed for the mass spay neuter and animal vaccination clinic sites. Meetings with NNACP will begin as soon as the grant is awarded. (Exhibit G – Letter of Support Navajo Nation Animal Control Program)

Provide twenty targeted drive-through animal vaccination sites

Animal Rez-Q Inc will partner with the Navajo Nation Animal Control Program for each of the twenty animal vaccination sites. Each vaccination clinic will take in

account the nearby clustered housing sites on Navajo, i.e., the fifteen Navajo Housing Field Management Sites, employee housing of our Navajo schools, housing of the eight Indian Health Services hospitals, Navajo Employee Housing and Navajo Tribal Utility Authority (NTUA) housing. All pets whether in a housing site or from a remote loving home will be vaccinated, dewormed, microchipped and will receive a Navajo Nation Animal license. Animal Rez-Q Inc is prepared to vaccinate 200+ pets per day at each 5-day site scheduled in April, May, June and August, if necessary additional vaccine will on hand, dependent on the community's population size. The Navajo Nation Spay Neuter Vaccination Blitz 2022 funding will pay for the vaccination of 4,000 pets preparing and registering them for a specific mass spay neuter site. At each of the twenty drive-through vaccination sites, the Navajo Nation Animal Control Program will have voluntary pet surrender for those pet owners that no longer have the ability to care for their pets.

Assist with sixteen mass spay neuter clinic days on Navajo

Animal Rez-Q Inc will work within the proposed communities to identify all logistic issues to support a successful mass spay neuter clinic. A 1,000 sq ft space is the recommended site appropriate for in-take, the volume of surgeries, traffic control and recovery area for patients for each mass spay neuter site. Once approved by Altered Tails, ARQ will travel to each of the four sites to secure rental agreements with the facility. The ARQ Team will be physically present at all sixteen mass spay neuter clinics to provide assistance. After each four-day clinics, ARQ and Altered Tails will debrief on the activities and develop after action improvements if necessary.

The first clinic would be scheduled for approximately May of 2022, followed by June, July & August clinics. The clinics will function as a mash type spay neuter clinic. Clinics will run with 4 surgical days in a row, with one setup and one breakdown day on either side of the clinic, for a total of 6 days. Each veterinarian can perform approximately 50 spay/neuter surgeries daily, and Altered Tails currently employs 5 veterinarians that can complete high volume spay neuter procedures with the support of 10 vet technicians. This team will provide a total of approximately 4,000 free spay/neuter surgeries over the May through August clinics.

Once permissions from the Navajo Nation have been obtained, pre-surgery vaccination clinics as well as the spay neuter clinic sites will be established, and advertising can begin. Advertising will take place via new paper ads, bilingual radio announcements, billboards, social media, and outreach efforts. Advertising will

commence at least 1 month prior to the first pre-surgical vaccination clinic date. Twenty pre-surgical vaccination/deworm/microchip clinics and four four-day spay neuter clinics will be scheduled.

Primary oversight for all clinics will be provided cooperatively by Animal Rez-Q Inc and the Altered Tails leadership. Any equipment purchased with this proposal will remain with Animal Rez-Q after the completion of the pilot program.

Coordination of pet transport for the elderly

Altered Tails has a transport van that can transport at least 20 pets to and from a mass spay neuter site for a Navajo elderly pet owner. Referrals for pet transport can be made by Animal Control Program, Resource Enforcement, Community Health Representatives, Health Educators, Public safety and chapter leadership to a designated person to tally and have available for the coordination meetings set for May 23, June 27, July 25 and August 29, 2022. Animal Rez-Q Inc along with the Navajo Nation Animal Control Program will seek the assistance of mobile field personnel to bring animals from remote areas to a surgery site for the elderly in remote areas without transportation. A request for assistance from executive staff employees that work in the field as first lines of defense such as Resource Enforcement, Community Health Representatives, Health Educators, Public safety and general Navajo Community volunteers that would like to provide assistance will be made to support this activity. Animal Rez-Q Inc will provide twenty large transport kennels to assist with pet transport for the elderly. All transport kennels will be returned by September 2, 2022, to Animal Rez-Q Inc after the final day of surgical alterations on pets.

Payment of stipends

Two ARQ staff members will be paid a \$75.00 stipend to assist with the twenty drive-through vaccination sites and sixteen mass spay neuter surgery days. Additional stipends will be given to four students that have an interest in a career in veterinary medicine. These students will be from the communities that sponsored the surgical sites. ARQ staff will be paid mileage for travel to communities and targeted sites for mass spay neuter or animal vaccination services which will include canvassing the area and planning the site, coordination with community leadership, signing of facility usage agreements, and flyer distribution and posting.

Covid-19 Protocol

The Animal Rez-Q Inc and Altered Tails teams will be covid-19 vaccinated and boosted. Each team member will wear N95 masks and social distance, when possible, at the pre-surgical drive-through vaccination and mass spay neuter sites. All other tribal staff, volunteers will be expected to maintain the same requirements as the Animal Rez-Q Inc and Altered Tails teams to protect our Navajo public.

Evaluation

Quantitative

Data on pre-surgical pet vaccinations: All data will be complied for each animal and pet owner that received services at one of the twenty drive-through vaccination sites. Our goal is for 4,000 pets to be vaccinated, dewormed and microchipped. Success will be measured by the number of pets that receive services.

Data on surgery sites and the number of surgeries completed: All data will be complied for each animal and pet owner that received services at one of the sixteen spay neuter days. Our goal is for 4,000 pets to be surgically altered. Success will be measured by the number of pets that receive services.

Documentation & Reporting: Animal Rez-Q Inc staff will consolidate the data per vaccination site and per mass spay neuter clinic. Animal Rez-Q Inc will follow the recommended reporting dates and deadlines within the proposal timeline.

Qualitative

Immediate success will be felt by the Navajo Nation pet owners. This is the first time in the last sixteen years, that the Navajo Nation sponsored free vaccination and spay neuter services. Pet owners will be relieved that their pets are going to be disease free, parasite loads decreased, microchipped to comply with our codes and spayed or neutered, preventing the birth of additional puppies and kittens. These families will be alleviated of the excessive expense of \$290 it would cost to have these exact services completed without the support of Navajo Nation Spay Neuter Vaccination Blitz 2022.

Future successes will be measured by our Navajo businesses that will not have animals roaming around their premise', there will be reduced number of dead

animals lining our highways, reduced number of calls to the Animal Control Program of a nuisance female dog in heat and decrease in puppy and kitten abandonment.

Moreover, a paradigm shift in the mindset of our People on pet ownership and their responsibilities and a shift in the complaints that "nothing is being done about Navajo's pet overpopulation". Allow for the outside animal organizations to see and understand that we making a positive difference as a Tribal Nation, that our own leadership sponsored the Navajo Nation Spay Neuter Vaccination Blitz 2022.

Dissemination

Massive Communication Strategy

Animal Rez-Q Inc will request for a Navajo Nation proclamation to launch the Navajo Nation Spay Neuter Vaccination Blitz 2022. This proclamation will be used to mobilize the services and inform the Navajo Public of the free services for the 4,000 pets that will receive the vaccination, deworming, microchip and surgical alteration services. Through the proclamation and its distribution, we are seeking the support of family members to assist the elderly with bring in their pets for the services.

Key to this process is a well-organized media platform in print and bilingually in Navajo & English languages to ensure that our Navajo People have knowledge of our targeted animal services on our Nation. The Navajo Nation Spay Neuter Vaccination Blitz 2022 will have posters, flyers, public service announcements for mass spay neuter and animal vaccination events for media advertisement by newspaper, bilingual radio announcements and messaging on several billboards. Once all the sites, whether pre-surgical vaccination or spay neuter, are confirmed, flyers, posters, bilingual radio announcements and billboard graphics will be developed by Animal Rez-Q Inc to go to the Navajo Times and several radios stations (KTNN and others based on the reach on Navajo) to advertise our events, targeting all age groups. Flyers will be delivered to each community. Social media will be used to assist with getting the word out. Additional resources will be sought such as the Navajo Nation Office of the President and First Lady for additional print or radio ads including other departments and programs within the executive branch of the Navajo Nation government.

This communication platform requires a combination of direct communication with our tribal government, renewing partnerships with outside organizations and outreach to our Navajo People all the while providing an understanding of the cultural aspects of humane animal work. Since our People are bilingual and the appropriate matrix of media is required to share information on our animal events. We need to target all age groups especially remote households.

Our Navajo People want to be responsible pet owners, they only need the animal service delivery into key areas of the reservation. Navajo chapters want to address the pet over-population issues to strive to keep their communities healthy and safe. Services need to be better coordinated to reach the distant Navajo households. It is this process of communication that will reach directly to the families and allow for them to coordinate which clinics will be closest to their homes.

Budget and Continuation of Funding

Exhibit D – Budget – Overall

The overall budget for the Navajo Nation Spay Neuter Vaccination Blitz 2022 is \$267,184.00. It includes personnel, travel, supplies, equipment and indirect cost breakdown to complete 4,000 free vaccinations, deworming, microchip and surgical alterations. This gives an average cost of \$66.80 per pet. Noting that the cost without the support of the NNSNVB would cost pet owners (\$50 + \$240) \$290.00. Given that low-cost vaccinations, deworming & microchip cost, \$50.00 and the average spay of a #45 female is \$240. At regular pricing for 4,000 pets, it would cost \$1,160,000.00 (\$290 x 4,000pets)

Exhibit E - Budget - Breakdown per animal by sex and size

The breakdown per animal budget is the actual costs for the spaying and neutering of a cat or a dog, based on their body weight by the Altered Tails team. It includes all the supplies, equipment and staff time it takes to complete one surgery on each animal. For the Navajo Nation Spay Neuter Vaccination Blitz 2022, we are using the average cost of a spay for a 45# dog: Altered Tails cost is \$90.50. In Altered Tails' own stationary clinic's, they have a cost of \$100 for a #45 dog spay while with other veterinary clinics near the reservation, it will cost an average of \$240.00. This budget gives a through picture of what it will take to surgically alter our pets.

Continuation of Services

As a Navajo Nation sponsored Free Spay Neuter Vaccination Service, sustainability will be achieved directly through the success of the Navajo Nation Spay Neuter Vaccination Blitz 2022, as funding for expansion is dependent entirely upon it. Data from this project will be used to inform further funding.

As previously mentioned, any equipment purchased with funds from this grant would remain with Animal Rez-Q. By leaving this equipment with a community provider, it gives the organization the ability to be nimble and provide services quickly and provides the groundwork to begin the development of the Nation's own spay/neuter infrastructure for the first time since 2005.

Future MASH-style Spay Neuter clinics would be planned to occur once a quarter, with as many as 15 trained surgeons operating daily, run simultaneously across multiple chapters of the Nation, giving the ability to perform up to 600 spay/neuter surgeries daily. We believe that ongoing funding for continued spay/neuter efforts is possible with the success of the Navajo Nation Spay Neuter Vaccination Blitz 2022.

Brief organization description

In 2014, **Animal Rez-Q Inc (ARQ)** was incorporated on the Navajo Nation and received non-profit statis as a 501(c)3. We provide affordable cost animal wellness services directly into tribal nations. Our mission is "Healthy Animals, Healthy Families, Healthy Communities" We focus on vaccinations for disease prevention and the reduction of internal and external parasites for animals. Animal Rez-Q Inc coordinates vaccination sites as well as providing animal wellness services directly to the homes of our Native People. We are committed to provide quality animal services with integrity, respect for our Native American communities, compassion for the animal/human bond, and have a cultural emphasis on our humane education. 
Altered Tails Barnhart Clinic began in 2003 as a small non-profit organization committed to help resolve the problems of pet overpopulation and needless euthanasia of cats and dogs. In 2013, Altered Tails had grown to two brick-andmortar clinics that provide service to over 25,000 companion animals annually. Our focus is clients who need discounted spay/neuter services. These clients at times have difficulty even paying full price at low-cost spay/neuter clinics. They typically live in multiple pet households, with more than one pet that is not sterilized. These pets are most frequently acquired through friends/family, making it the new owner's financial responsibility to get them sterilized. Those receiving public assistance are also more likely to have an intact pet (Source: 2018 AVCC Report). To this day, Altered Tails continues to focus on providing high quality, low-cost services. In 2021, Altered Tails performed over 27,260 low- or no-cost sterilization surgeries for dogs and cats. (Exhibit F – Support letter Altered Tails)

Please accept this email of support for legislation 0052-22. It is unfortunate, but many people don't take the responsibility of pet care seriously or believe that curbing the pet population (dogs & cats) is important. The uncontrolled pet population has led to many dogs and cats being hit on the roads, to dog packs attacking livestock, attacking people, and dog fights. Of course, everyone probably remembers the local girl in Fort Defiance who was attacked and killed by a pack of dogs that were "owned" by one family. Everyone was shocked, but not shocked enough to do something about ensuring their pets don't continue to breed. Other things you'll observe are the dogs waiting at the local grocery stores or convenience stores hoping for someone to give them some food. Most likely these dogs get together and breed more dogs.

I've seen how cruel people can be. Recently, driving the back road near my home, I came upon a weathered cardboard box with a rope tied to a nearby tree. I found a dead mother dog with her newborn puppies dead in the box. It was horrifying to see and I cursed the people who could be so cruel to these animals. Two summers ago, we found 2 puppies who were dumped off on a road near my home. By the time we got there, someone had run over one of the puppies. The other puppy that was alive was hungry and scared. When we got closer it was covered in dog ticks. We took him home and cleaned him up, treated him for the ticks. Luckily, we were able to get him to one of the puppy adoption organizations and he is now with a family in Utah. Over the years, we've rescued many puppies that show up at our house. Even my own dog, Sobie, was a stray dog that showed up one day. We fed her and she was a loyal dog for many years. Unfortunately, someone shot her and we ended up putting her down. I remember once following a police vehicle and a dog was crossing the highway. The police officer actually tried to hit the dog! He swerved off the road and kicked up some dirt on the shoulder. I remember it because I thought the Navajo Nation Police were supposed to protect and serve and it made no sense why an officer would intentionally cause harm to this dog. Once again, I state it, people are cruel. I think animals are deserving of a better quality of life and to die with some care rather than the horrific way many of them die. As a people who pray for and with hozho, it makes no sense to me why we would treat our animal relatives so cruelly.

So, perhaps this legislation will help curb the population. But it also needs education on pet care and ownership too. People need to learn to be more sympathetic to our animals. Thank you.

On behalf of Animal Protection Voters, a New Mexico nonprofit and legislative advocacy arm for 501(c)(3) Animal Protection New Mexico, I am writing respectfully in support of funding requested for the "Navajo Nation Spay, Neuter, Vaccination Blitz 2022," proposed in Legislation No. 0052-22.

The "Blitz 2022" project is spearheaded by Animal Rez-Q, Inc., a Navajo Nation-based nonprofit with a strong background and expertise on animal care issues. The requested funding aims to provide free spay/neuter surgeries and vaccinations for 4,000 animals of Navajo Nation residents, which will help to address and mitigate the overpopulation of homeless animals.

Spay and neuter surgeries are safe, common procedures performed by licensed veterinarians in order to render female and male animals sterile so they cannot produce offspring. Dogs and cats have greatly improved chances of living healthier lives if they are spayed or neutered. Spaying and neutering also often remedy many common behavioral problems, including roaming and aggression.

Investment in spay/neuter programs also saves money in the long run. The more homeless animals there are, the higher the cost to communities to provide animal care and control services sufficient not only to protect the animals but to protect the public from related risks such as bite injuries and fatalities, disease transmission, traffic accidents, and property damage.

As spay/neuter efforts reduce animal overpopulation and homelessness, associated costs of animal control such as personnel, facilities, equipment, training, sheltering, and euthanasia decrease proportionally. Studies have shown that for every \$1.00 invested in low-cost accessible spay/neuter programs, approximated \$35.00 is saved in animal care and control costs over ten years.

Vaccination services are also an important component of the "Navajo Nation Spay, Neuter, Vaccination Blitz 2022" project. Vaccination in dogs and cats can prevent devastating diseases, such as rabies and distemper, which can be expensive to treat and may cause death. It is also a key element in keeping Navajo Nation residents healthy as well, as some animal diseases are transferrable and dangerous to humans.

We applaud Animal Rez-Q, Inc., the Navajo Nation Animal Control Program, and Altered Tails Barnhart Clinic for their leadership to address the animal overpopulation issue head-on with investment in free spay/neuter and vaccination services. Approval of the funding request in Legislation No. 0052-22 is a strong step forward in this important work.



 - b. Appendix K, Supplemental Funding Request Form is not included.
- 2. In February, 2022 a similar proposal was also submitted through the Executive Branch Review Process by the DNR/Department of Resource Enforcement. Clarification should be provided, which budget does DNR support?
- 3. According to the Controller's Report dated January 20, 2022 the UUFB (Undesignated, Unreserved Fund Balance) is \$23,966,288 as of January 20, 2022.

- We would like for Shiprock Chapter community members to be able to enjoy the outdoors; to run, to play, to hike, to walk without the threat of being bitten or attacked by dogs; our children do not need to carry sticks to ward off dogs to play outside; and
- 4. The Shiprock Chapter does not want any of our residents to be a victim of a mauling case due to aggressive, vicious or packing dogs; we want our community to be safe; and
- 5. The Shiprock community members have difficulty finding veterinary services to get pets to have a spay or a neuter surgery; it takes months to get an appointment; the great expense of a spay or neuter is cost prohibitive to our chapter residents.
