24th NAVAJO NATION COUNCIL - FOURTH YEAR, 2022

AN ACTION

RELATING TO THE NAABIK'ÍYÁTI' COMMITTEE AND NAVAJO NATION COUNCIL;
CONFIRMING THE APPOINTMENT OF MR. MARCUS TULLEY TO THE COMMISSION
ON NAVAJO GOVERNMENT DEVELOPMENT, FOR A TERM OF FOUR (4) YEARS, AS
THE CENTRAL AGENCY COUNCIL REPRESENTATIVE

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Naabik'íyáti' Committee has legislative oversight authority over the Commission on Navajo Government Development and the Office of Navajo Government Development. 2 N.N.C. § 970.
- B. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council which is empowered to recommend all resolutions to the Navajo Nation Council on matters within the Committee's jurisdiction pursuant to 2 N.N.C. §§ 700(A), 701(A)(3).
- C. The Navajo Nation Council confirms appointments to the Commission on Navajo Government Development. 2 N.N.C. § 972(A)(5).

SECTION TWO. FINDINGS

- A. The Commission on Navajo Government Development is a special entity created by the Navajo Nation Council with quasi-independent authority to accomplish the People's project of instituting reforms necessary to ensure an accountable and responsible government. 2 N.N.C. § 970.
- B. The Commission consists of twelve (12) members confirmed by and serving at the pleasure of the Navajo Nation Council. 2 N.N.C. § 972(A).
- C. Five (5) members shall be nominated from the five (5) agencies of the Navajo Nation. Each agency council shall nominate one (1) member from recommendations to be submitted by chapters in each agency, said nominee shall be either Chapter officers, local Government/Governance Commissioners, Grazing Committee/Land Board members, or school board members. These members shall serve a term of four (4) years from the date of

confirmation by the Navajo Nation Council. 2 N.N.C. § 972(A)(5).

- D. Commission members shall be chosen from among individuals who have demonstrated scholarship, a strong sense of civic interest, knowledge of Diné history and cultural heritage, spiritual leadership, leadership in the Navajo government and abilities likely to contribute to the fulfillment of the duties of the commission. 2 N.N.C. § 972(D).
- E. The Navajo Nation Central Agency Council nominated and recommended Mr. Marcus Tulley to serve on the Commission on Navajo Government Development pursuant to Resolution No. CAC 10/21-04, attached as **Exhibit A**, to fill the Central Agency Council Representative position.
- F. Mr. Tulley's letter of interest and resumé are attached as **Exhibit B**.

SECTION THREE. CONFIRMATION

The Navajo Nation hereby confirms the appointment of Mr. Marcus Tulley as the Central Agency Council Representative, to the Commission on Navajo Government Development, for a term of four (4) years from the date of confirmation by the Navajo Nation Council.

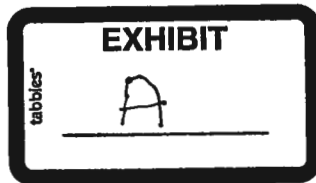

**NOMINATING Marcus Tulley AS THE CENTRAL AGENCY
REPRESENTATIVE TO THE COMMISSION ON NAVAJO GOVERNMENT DEVELOPMENT AND
REQUESTING THE NAVAJO NATION COUNCIL TO CONFIRM THIS NOMINATION**

WHEREAS:


1. The Central Agency Council is composed of 16 chapters.
2. The Navajo Nation Chapters are certified Chapters of the Navajo Nation pursuant to 2 N.N.C. § 4001 and 11 N.N.C. Part 1 § 10 having the authority to address and explore the local needs and concerns of chapter residents through participation in community planning; and
3. The Central Agency Council was established to address the needs, concerns, and general welfare of its constituents and advocate on their behalf for successful implementation of viable agency projects; and
4. The Central Agency Council recognizes that pursuant to Navajo Nation Council Resolution No. CD-68-89 (2020 as amended), the Commission on Navajo Government Development is established within the Legislative Branch as a special entity created by the Navajo Nation Council with quasi-independent authority to accomplish the people's project of instituting reforms necessary to ensure an accountable, responsible, ethical, and equally representative government; and
5. Pursuant to 2 N.N.C. §972(Λ)(5), five members shall be nominated from the five agencies of the Navajo Nation; [*"Each Agency Council shall nominate one member from recommendations to be submitted by Chapters in each agency; said nominees shall be either Chapter Officers, Local Government/Governance Commissioners, Grazing Committee/Land Board Members or School Board member. These members shall serve a term of four (4) years, from the date of confirmation by the Navajo Nation Council so long as they continue as a chapter officer, Local Government/Governance Commissioners, Grazing Committee/Land Board member or School Board member"*].
6. The term of the current Central Agency representative will expire upon the confirmation of a nominee by the Navajo Nation Council.

NOW THEREFORE BE IT RESOLVED:


1. The Central Agency Council hereby nominates Marcus Tulley as the Central Agency Representative to the Commission on Navajo Government Development and requests the Navajo Nation Council to confirm this nomination; and
2. The current Central Agency Representative's term shall expire when new nominee is confirmed by the Navajo Nation Council.

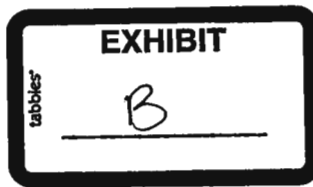
