2. The Navajo Nation further finds that the Whippoorwill Regional Business Development Office has found no party to lease the property contained in Business Site Lease Number FD-92-156. Exhibit C.
3. The Navajo Nation further finds that the Dilkon Chapter, pursuant to resolution number DIL-11-076-11, desires that the land associated with Business Site Lease Number FD-92-156 be relinquished to the Dilkon Chapter to be used for the “Dilkon Health Center.” Exhibit B.
3. The Navajo Nation hereby relinquishes the land associated with Business Site Lease Number FD-92-156 to the Dilkon Chapter for the community purpose of providing for the health needs of the Dilkon Chapter and surrounding area.


