### RESOLUTION OF THE LAW AND ORDER COMMITTEE OF THE 24<sup>th</sup> NAVAJO NATION COUNCIL - Fourth Year, 2022

#### AN ACTION

RELATING TO THE LAW AND ORDER COMMITTEE; APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2023 BUDGET FOR THE NAVAJO NATION DIVISION OF PUBLIC SAFETY AND RELATED MATTERS, TO BE INCLUDED IN THE NAVAJO NATION'S COMPREHENSIVE BUDGET FOR FISCAL YEAR 2023

#### BE IT ENACTED:

#### SECTION ONE. AUTHORITY

- A. The Law and Order Committee ("LOC") is a standing committee of the Navajo Nation Council with oversight authority over the Judicial Branch. 2 N.N.C. \$600(A); 2 N.N.C. \$601(C)(1).
- B. Each Oversight Committee, including the LOC, shall review and make recommendations regarding the programs under its oversight responsibility, regarding the Navajo Nation's Comprehensive Budget for the upcoming Fiscal Year. 12 N.N.C. \$840(A).

#### SECTION TWO. FINDINGS

- A. In accordance with 12 N.N.C. §840(A), the LOC held hearings and took relevant testimony regarding the FY2023 Budget for the Division of Public Safety.
- B. During these budget meetings, the LOC reviewed and considered the proposed FY2023 Budget for the Division of Public Safety., as commented upon by members of the public.

SECTION THREE. APPROVING AND RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2023 BUDGET FOR THE DIVISION OF PUBLIC SAFTEY AND RELATED MATTERS

- A. The Law and Order Committee hereby approves the FY2023 Budget for the Division of Public Safety., as detailed in the "Fund Type Budget Summary" attached hereto as **Exhibit A**.
- B. The LOC hereby approves certain revisions to the Branch Chiefs' proposed FY2023 Budget amount for the Division of Public Safety., as shown in Columns D and E in the "General Fund Comparative Summary" attached hereto as Exhibit B.
- C. The LOC recommends the changes to the General Fund Budget described in **Exhibit C**.

- D. The LOC recommends certain Conditions of Appropriation and Legislative Concerns, as listed in **Exhibit D**.
- E. The LOC recommends that certain Unmet Needs for the Division of Public Safety. be included in the FY2023 Comprehensive Budget, as explained in **Exhibit E**.
- F. The LOC hereby recommends that the Budget and Finance Committee approve the Division of Public Safety. proposed FY2023 Budget and all Committee recommendations, as set forth in Exhibits A E
- G. As necessary and appropriate, the LOC hereby authorizes the LOC Chair and Vice-Chair to negotiate the LOC's recommendations herein with the Budget and Finance Committee.

#### SECTION FOUR. RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE CARRYOVERS FOR THE NAVAJO DIVISION OF PUBLIC SAFETY

The Navajo Police Department Administration account (116001) request to carry forward \$546,590.30 from FY22 to FY23. This amount is in part Drug Investigation efforts and supplies.

\$500,000 was assigned by President Nez for drug investigation. The NPD placed the management team in March 2022 to administer this account. Amounts were placed into overtime, supplies for the team, and vehicle purchase. The team was not able to encumber and purchase the items. As the allocation was being placed for encumbrance, the NPD was able to use existing general funds to pay for team operations. Supplies for the team were not purchased in time as the 6B process is lengthy and encumbrance was not successful as delivery of the supplies would not be received until after the fiscal year. The money allocated for vehicles could not be encumbered the time lines for MVRB approval, ordering and delivery cannot occur before the end of the fiscal year. The remaining \$46,590.30 are amounts related to what the general fund independent of the \$500,000, that has not been encumbered by the program.

The Navajo Police Department is implementing programmatic changes to ensure we encumber and liquidate the fiscal year 2023 funds and the carry forward amounts from fiscal year 2022. This includes creating a financial management section of money professionals to ensure we liquidate.

The Department of Criminal Investigation respectfully requests for unspent funds from FY 2022 to be carried over to FY 2023 in the amount of \$1,840,681. This budget summary includes the following:

Funds were put into personnel expenses, travel expenses, lease and rental, and special transactions in anticipation of the Fourth of July Fair and Rodeo, Navajo Nation Fair and Powwow, and Shiprock Fair however, due to the pandemic these fundings were not spent and NDCI respectfully request these unspent funds be carried over to FY2023 in anticipation of the events coming back in 2023.

Funds were put into supplies, repairs and maintenance, and communication and utilities in anticipation of purchasing operating and medical supplies, and two-way radios however, due to the pandemic the department received assistance from the CARES Act and ARP Act funds which were utilized in purchasing most of these supplies. NDCI respectfully request for the unspent funds to be carried over to FY2023 in a plan to purchase additional supplies and communication needs for the next year ahead.

Funds were put into contractual services to pay on invoices through direct payments for services rendered by the Medical Examiners' Office Flagstaff and Albuquerque however, by direction from the Office of the Controller direct payments were no longer consistent with procedures on paying on the services provided and that the invoices need to be paid through contracts that need to be established. The contracts with both Flagstaff and Albuquerque Medical Examiner's Office are still pending, not allowing the invoices to be paid from the contractual services funds. NDCI respectfully request for the unspent funds to be carried over to FY2023 in anticipation for the contract finalization which will allow for the invoices to be paid out with the funds.

Finally, funds were put into capital outlay for building improvements however, the plans are still in progress and NDCI respectfully request for the unspent funds to be carried over to FY2023 so, plans for building improvements can still be followed through with.

(Expenditure Slow Process)

Based on Fiscal Year 2020, 2021, and 2022 budget expenditure slow process of purchasing and the time it takes to process the 164 requirements.

We have process numerous purchase request and found that most are still awaiting for review at different office before it gets to purchasing. This has really slowed the process of purchasing and we have ended up waiting until it's too late toward the end of the fiscal year.

When the fiscal year purchasing is stop at a certain point prior to the new fiscal year budget process, we end up still waiting for purchase orders or finally received a purchase order and unable to process invoices for payments.

This has been happening every year, so we end up utilizing the next fiscal year new budget. This is not how purchasing office we should be operate when it comes to timely processes of requests. An immediate purchase is necessary because our department equipment, vehicles and protective gear is needed without delay, as these vital equipment in general need replacing due to getting old, can break or become defective while in use, and need replacing on the spot.

#### (Operational Requirements)

Our department has 8 fire stations to oversee and operate. The operations of fire & rescue include requires the following:

- fire apparatus
- fire equipment
- rescue equipment
- hazardous material equipment
- wildland fire equipment
- PPE Structure

- PPE EMS
- PPE Wildland
- PPE Hazardous Materials
- Fire station equipment and furniture
- Fire station office equipment
- Fire station office supplies
- Fire station supplies
- Fire station renovation
- Training fees
- Training books
- Training props
- Uniforms and boots
- Fire prevention equipment
- Fire prevention supplies
- Physical fitness equipment
- Physical fitness supplies

#### (Equipment is expensive)

The equipment and supplies to operate are costly and expensive. Most of all purchases require the 164 process for procurement. This translates into time for and signatures for approvals. Much of the equipment is not sold by Navajo owned businesses. Fire department vendors are few and far from the Navajo Nation as well.

(We have a lot of outdated equipment that needs to be replaced)

With old and outdated apparatus, equipment, and dilapidated buildings, the one fiscal year is not adequate to fully expend all money allocated. The process of signatures and approvals by policy every fiscal year is the problem that leaves unexpended funds.

(NNOOC is not reliable and often closes down)

Having the unspent funds to carry over into the new fiscal year will ultimately help and foster growth of our department. Many projects are planned but having to hurry and spend it all at the mercy of purchasing and controller's office to wait needs to be address. The workforce there is not enough to assist. When the fire department is held responsible for budget expenditures, the organization that is holding up the process sits with office of controller purchasing. With the tribe offices closures, holidays, administrative leave for fairs, voting, and other events such as building closures and COVID-19 spikes, we end up waiting.

#### (End of Fiscal Year 2022 Funds Carry-Over/Forward Request)

For these legitimate reasons, were requesting to have our department to carry-over/forward any funds available in fiscal year 2022 into fiscal year 2023. This will help us tremendously as we have been cut short of completely expending all our funds because of the slow process of paying for invoices and or procuring purchase orders.
