- B. The Law and Order Committee shall select a Chairperson and Vice-Chairperson by a vote. 2 N.N.C. § 184 (A).

Section Three. Confirming Chairperson and Vice-Chairperson

The Law and Order Committee of the Navajo Nation Council, pursuant to its authority under Navajo Nation law, hereby confirms Honorable Eugenia Charles-Newton as Chairperson and Honorable Cherilyn Yazzie as Vice-Chairperson.
